**NOTICE OF WITHDRAWAL OF FIRST
AMENDED STATEMENT OF ISSUES**

TO ALL INTERESTED PARTIES:

1. On or about December 11, 2012, the Bureau for Private Postsecondary Education (Bureau), Department of Consumer Affairs, received an Application for Renewal of Approval to Operate and Offer Educational Programs for Non-Accredited Institutions from Respondent California Human Development Corporation (Respondent).

2. On or about March 7, 2016, the Bureau issued Respondent a Notice of Denial of Application for Renewal of Approval to Operate and Offer Educational Programs for Non-Accredited Institutions. On or about March 24, 2016, the Bureau received from Respondent a request for an administrative hearing.

1 3. On or about November 9, 2016, Joanne Wenzel, the former Chief of the Bureau, filed
2 Statement of Issues No. 1001548 solely in her official capacity. A First Amended Statement of
3 Issues was subsequently filed on April 26, 2017.

4 4. The Bureau hereby withdraws First Amended Statement of Issues No. 1001548. The
5 basis for the withdrawal of this pleading is that the Bureau has determined that Respondent has
6 met the qualifications for exemption from regulation under the Private Postsecondary Education
7 Act of 2009.

8 5. WHEREFORE, IN THE INTERESTS OF JUSTICE, First Amended Statement of
9 Issues No. 1001548 is hereby withdrawn without prejudice.
