The enrollment agreement shall be signed by the student and by an authorized employee of the institution.</p> <p>The institution failed to have the enrollment agreement signed by both the student and an authorized employee of the institution.</p> <p>To remedy this violation the institution shall provide a policy statement indicating how they will ensure the enrollment agreement is signed and dated by both the student and an authorized employee of the institution. 


Please provide copies of the signed and dated School Performance Fact Sheets for students enrolling for the next 30 days.</p>
<p align="center">CEC §94911 (c) Minimum Requirements for Enrollment Agreements</p>	<p>(c) In underlined capital letters on the same page of the enrollment agreement in which the student's signature is required, the total charges for the current period of attendance, the estimated total charges for the entire educational program, and the total charges the student is obligated to pay upon enrollment.</p> <p>The institution failed to enter the total charges for the current period of attendance and the estimated total charges for the entire educational program.</p> <p>To remedy this violation the institution shall provide a policy statement indicating how they will ensure the enrollment agreement is completed with the total charges for the current period of attendance and the estimated total charges for the entire educational program.
