### **Agenda #1 - Welcome, Introductions, and Establishment of a Quorum**

Leigh Ferrin, Vice Chair, called the meeting to order and presided as acting chair at the request of Chair Tess Kraiker. Ms. Ferrin also acknowledged that Committee members Tracy Tambascia and Melanie Delgado had stepped down since the November 2025 meeting and thanked them for their service.

Kansen Chu moved to approve the November 5, 2025, meeting minutes; Tess Kraiker seconded the motion.

## **Agenda #5 – Bureau Operations Update and Discussion**

### **Update on the Bureau’s IT System Project**

Jason Piccione, DCA Chief Information Officer, provided an update on the Bureau's IT system. He reported that Bureau staff are currently working with selected institutions to test expanded online services for the institution portal, including the ability to submit and pay annual fees online and to submit quarterly Student Tuition Recovery Fund (STRF) assessments, in advance of opening portal access to all institutions in the coming months.

### **Licensing Report**

Ms. Vongmany reported on the Licensing Unit. She outlined Attachment 5(b).

Joseph Holt commended the Bureau on the progress made in reducing full approval application timelines, noting that the improvements reflect effective internal resource allocation. He encouraged the Bureau to continue controlling internal processes while acknowledging that institution responsiveness remains a variable outside the Bureau's direct control. Ms. Vongmany thanked Mr. Holt and noted that additional outreach and engagement opportunities identified through workshop feedback are being explored.

Ebony Santee, Bureau Education Administrator, reported on the Quality of Education Unit (QEU). She outlined Attachment 5(c).

### **Compliance and Annual Report Update**

Erik Casida, Bureau Compliance Chief, reported on the Annual Report Unit. He outlined Attachment 5(d).

### Public Comment

### Complaint and Investigation Report

Daniel Rangel, Bureau Enforcement Chief over complaints and investigations, reported on the Complaint and Investigation Unit. He outlined Attachment 5(e).

Robyn Smith thanked the Bureau for the additional context on the insufficient evidence category.

Joseph Holt asked whether the examples provided were representative or random samples. Mr. Rangel explained that they were both random and representative. He added that, of all complaints closed in calendar year 2025, only 57 were closed for insufficient evidence, and that most closures in the combined non-substantiated/insufficient-evidence category fall into the former group, distinctions not currently reflected in the materials. Mr. Holt recommended separating insufficient evidence closures from unsubstantiated closures in future reports.

Ms. Smith requested a breakdown of non-substantiated cases and clarification of what non-substantiation means, including whether there are specific types of evidence considered sufficient for substantiation. She also asked what percentage of insufficient-evidence closures involve anonymous or non-responsive complainants. Mr. Rangel stated that anonymous and non-responsive complainants make up a large share of insufficient-evidence closures but did not have an exact percentage available. He noted that lack of complainant participation is often a significant barrier to investigation. Ms. Smith requested that this information be included in a future report.

Brian Vest, OSAR Manager, reported on the OSAR Unit. He outlined Attachment 5(g).

Robyn Smith requested a future breakdown of transcript assistance contacts, including whether students are having difficulty obtaining transcripts from closed schools and whether any schools are refusing to provide transcripts due to unpaid debts, and how such violations are handled.

Ms. Ferrin noted appreciation for the partner highlights slide and expressed that the outreach efforts are valuable and not always well known.

### **Agenda Item #6 - Status Updates and Discussion on Regulatory Proposals**

Parker Strohmeyer, Bureau Legislative/Regulation Specialist, provided a status update on Bureau regulatory matters. He outlined the Bureau Regulations Tracker in the meeting materials.

#### **6a. Use of the Term “University” (California Education Code (CEC) section 94897; Title 5, California Code of Regulations (5 CCR) section 74150)**

Mr. Strohmeyer outlined the proposed regulatory language regarding the use of the term “university.” He explained that existing regulations define “university” and restrict use of the term unless an institution meets the definition or uses qualifying language to prevent deception. He continued that proposed changes would specify that institutions must meet two criteria to use the term, including accreditation by a U.S. Department of Education-recognized accrediting agency, and conferral of graduate degrees. He stated this establishes a clear objective standard and prevents unaccredited institutions from using the term prior to achieving accreditation.

Mr. Holt asked about grandfathered institutions. Mr. Strohmeyer confirmed that grandfathered institutions are not required to change their name under this package, but if they voluntarily change their name in the future, they must meet the new requirements.

#### 6b. Minimum Operating Standards – Financials (CEC sections 94885 and 94934; 5 CCR sections 71475, 74002, 74110, and 74115)

Mr. Strohmeyer outlined the proposed regulatory changes to minimum operating standards for financial statements. He explained that the package proposes to: eliminate an inconsistency in the level of review required for financial statements submitted with renewal applications (5 CCR section 71475); add a definition for generally accepted accounting principles (5 CCR section 74002); clarify the term “current” (5 CCR section 74115); allow institutions to submit financial statements electronically with annual reports; and clarify that financial statements submitted with annual reports may be either audited or reviewed (5 CCR section 74110).

Mr. Strohmeyer noted that the Bureau is considering whether to modify financial standards applicable to Title IV-participating institutions, given changes occurring at the federal level. He reported that the school participation division of the Department of Education saw the majority of its staff positions eliminated in March 2025, raising questions about the continued meaningful federal oversight. He noted that developing state-level standards would take time and carry administrative burdens, while delaying action could create oversight gaps.

Mr. Holt noted that composite scores are calculated by institutions and their independent auditors and reported to the Department of Education, not calculated by the Department itself. He stated that the reduction in federal staff does not eliminate the calculation of composite scores and that independent auditors remain involved. He clarified that this does not resolve all concerns raised by the Bureau, but on the specific question of composite score calculation, the elimination of federal staff does not mean scores will cease to be produced.

Ms. Ferrin noted that if state-level standards were promulgated, consistency with existing federal frameworks would be important to avoid placing dual compliance burdens on institutions.

Mr. Zimmerman noted that the Department of Education would likely not cease calculating composite scores given the significant effects on institutions participating in NC-SARA, where maintaining an up-to-date composite score is a requirement.

## **Agenda #7 – Sunset Review: Process Overview and Member Discussion**

Ms. Cochrane provided context for the sunset review. She explained that the Bureau is scheduled for a comprehensive sunset review in 2026, through which the Legislature will determine whether and how to reauthorize the Bureau beyond January 1, 2027. She stated that the Bureau submitted its sunset report to the Legislature on January 9, 2026, and the report is publicly available on the Bureau's website and was provided to all Committee members. She noted that the next step is for the Legislature's authorizing committees to draft a background paper and schedule a hearing, for which a date had not yet been confirmed at the time of the meeting.

Ms. Smith expressed appreciation for the thoroughness and quality of the sunset report, commending Bureau Chief Cochrane and the staff for the progress made in addressing long-standing issues and for the substance and recommendations of the report.

Mr. Holt stated that he has been engaged with four previous sunset reports and described this as the most practical and mission-aligned of those documents. He highlighted the specificity of the recommendations, including proposed redline changes to legislative text, as a strong foundation for legislative conversations.

Kevin Powers echoed prior comments on the quality of the report. He noted that he is working with colleagues from the Senate Business and Professions and Senate Education Committees on a joint draft background paper and anticipated the sunset hearing to occur in early to mid-March 2026. He noted that the sunset process typically results in a policy bill extending the Bureau's authorization and potentially addressing policy considerations raised in the background paper.

Ms. Cochrane thanked the Committee for acknowledging the staff's efforts, noting that the report represented a seven-month all-hands effort, with contributions from most Bureau staff.

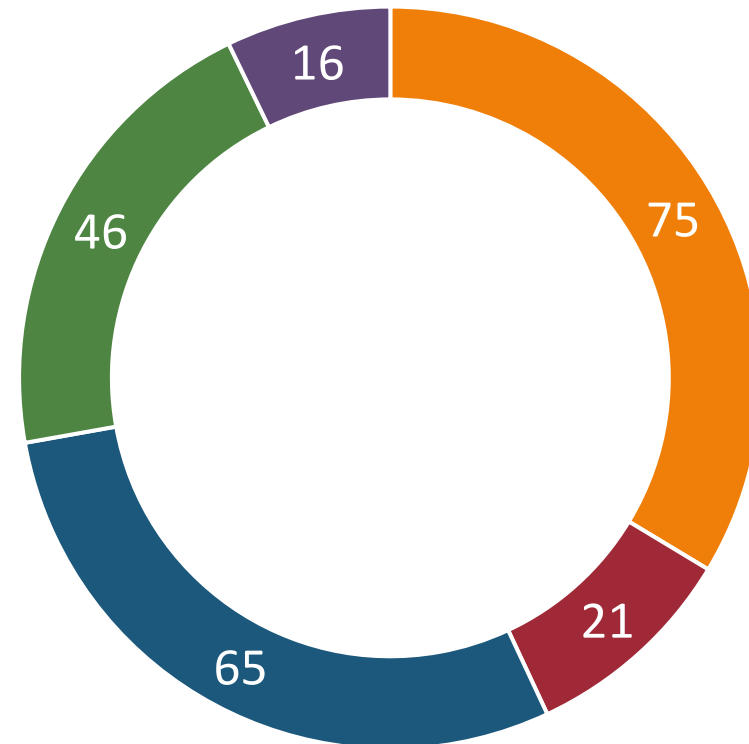

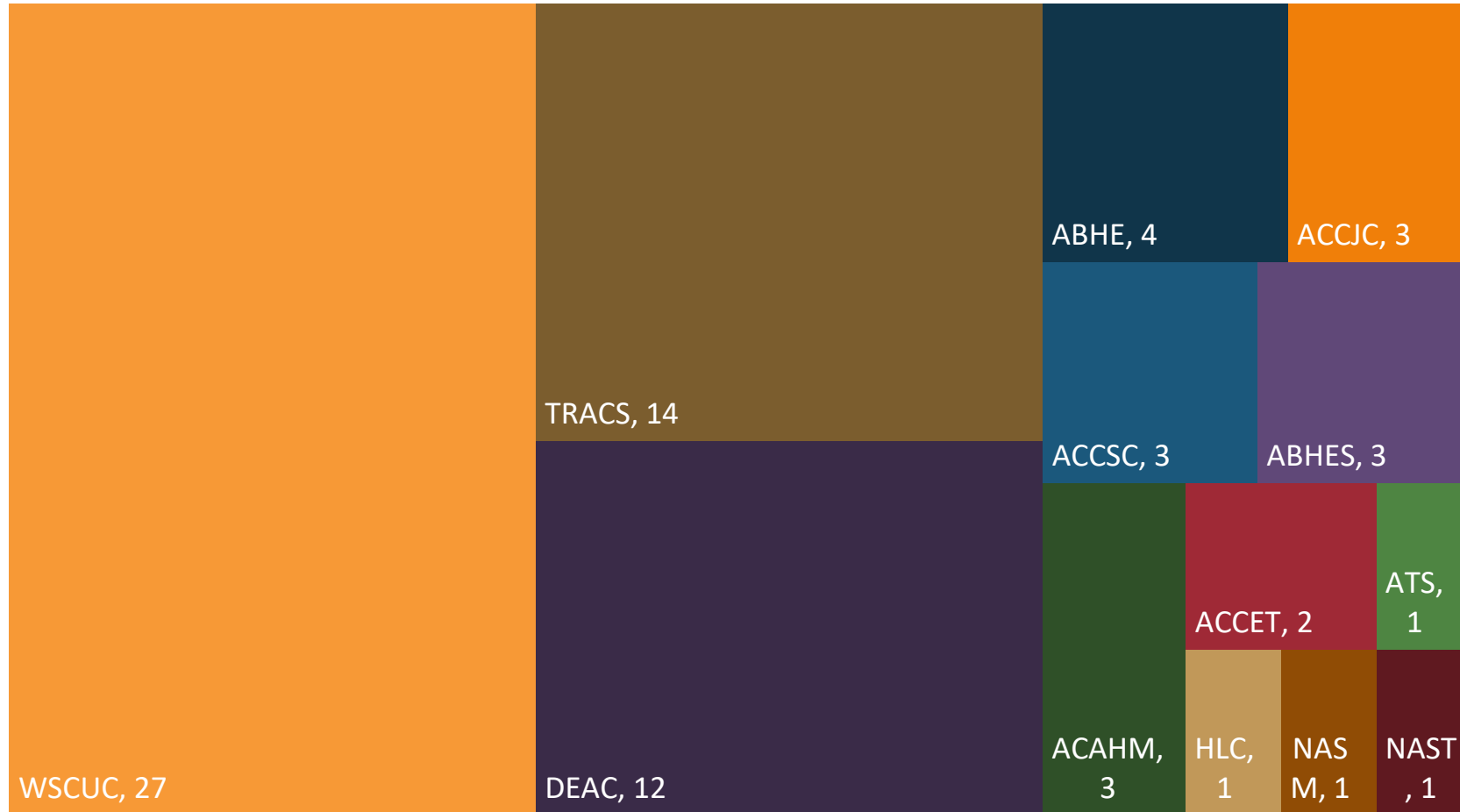

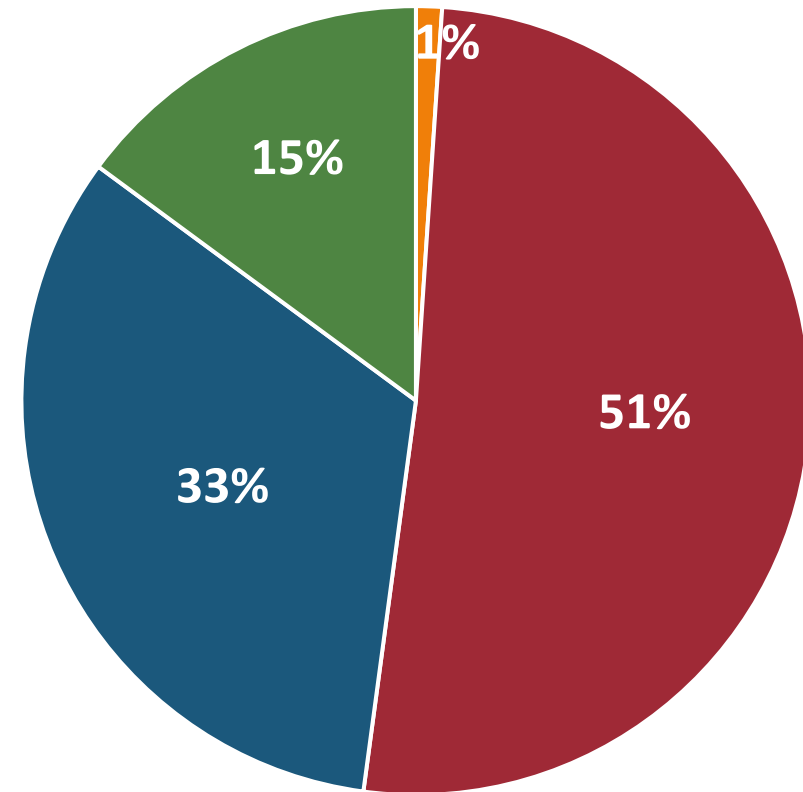

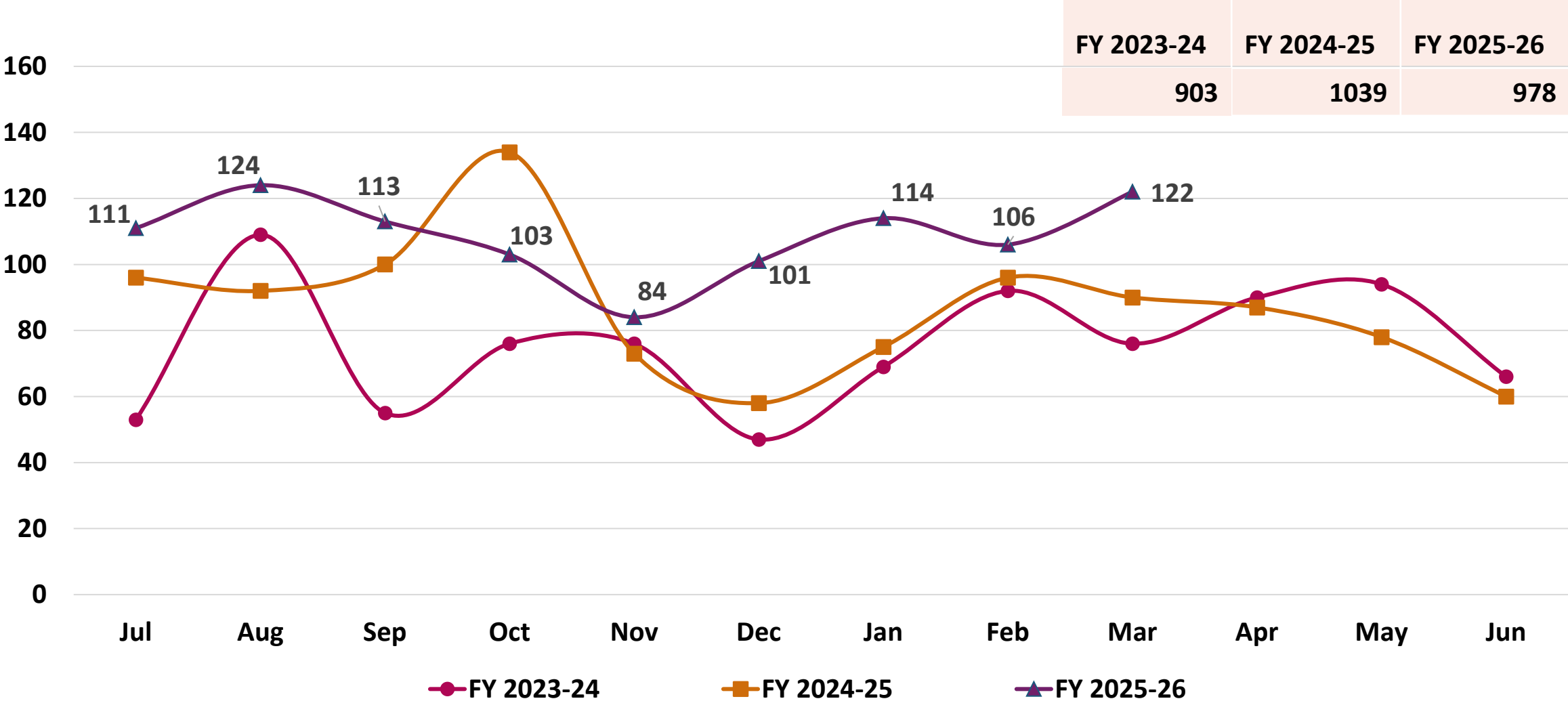

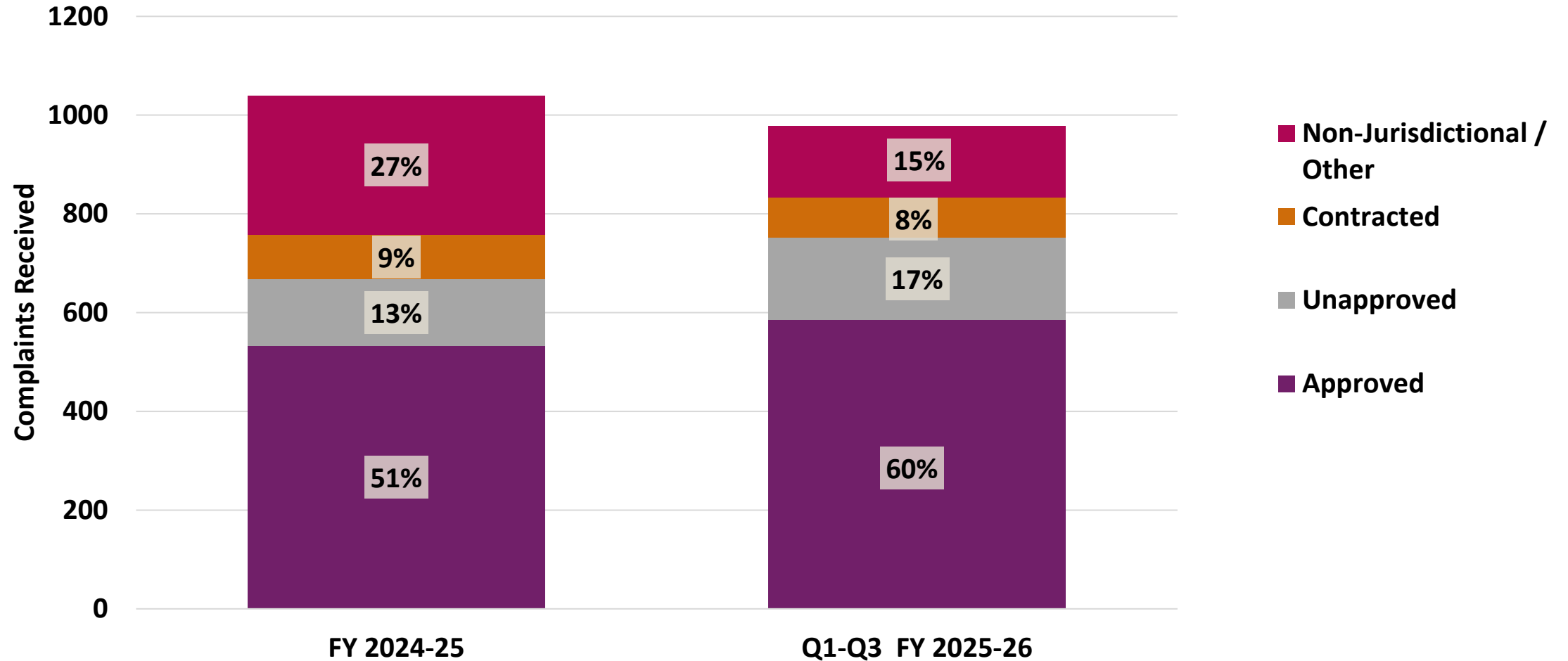


# Complaints Received: FY 2023-24 to Q3 FY 2025-26

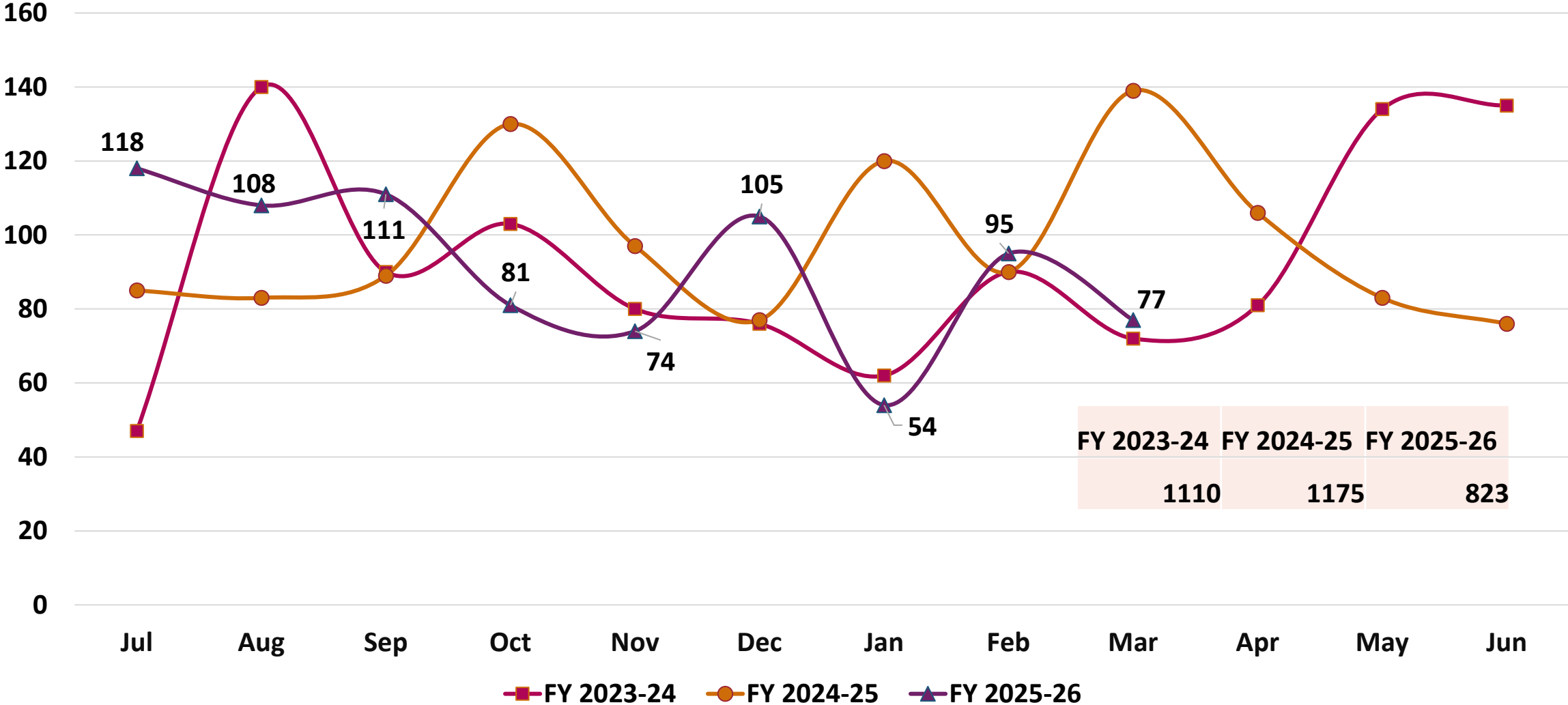


# Complaints Received by School Status

FY 2024-25 to Q3 FY 2025-26

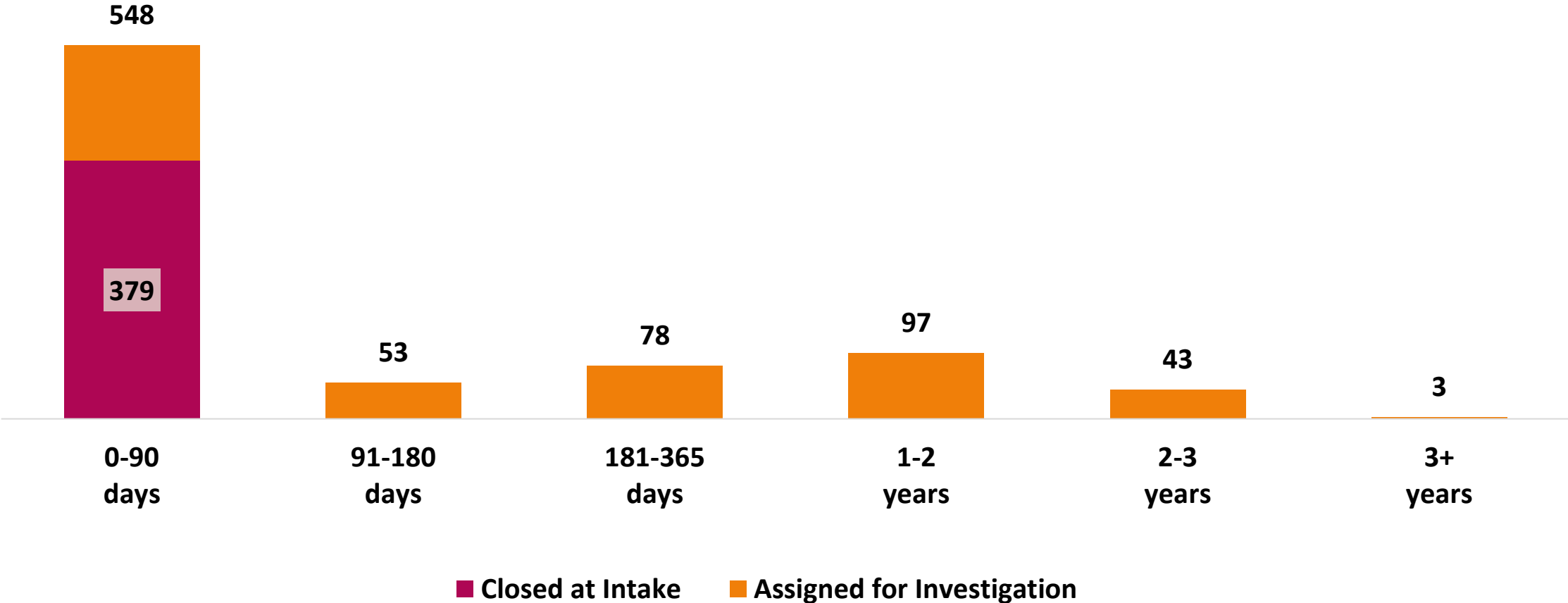

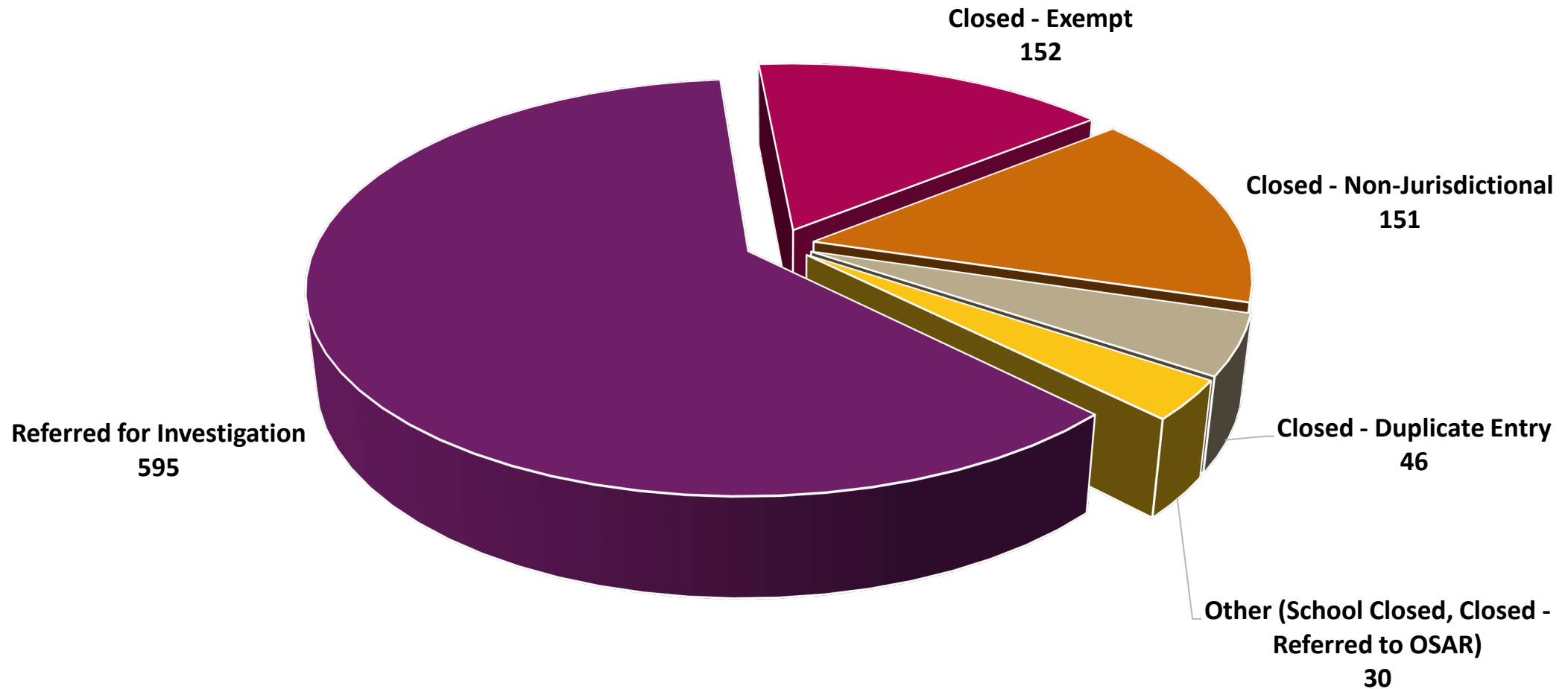

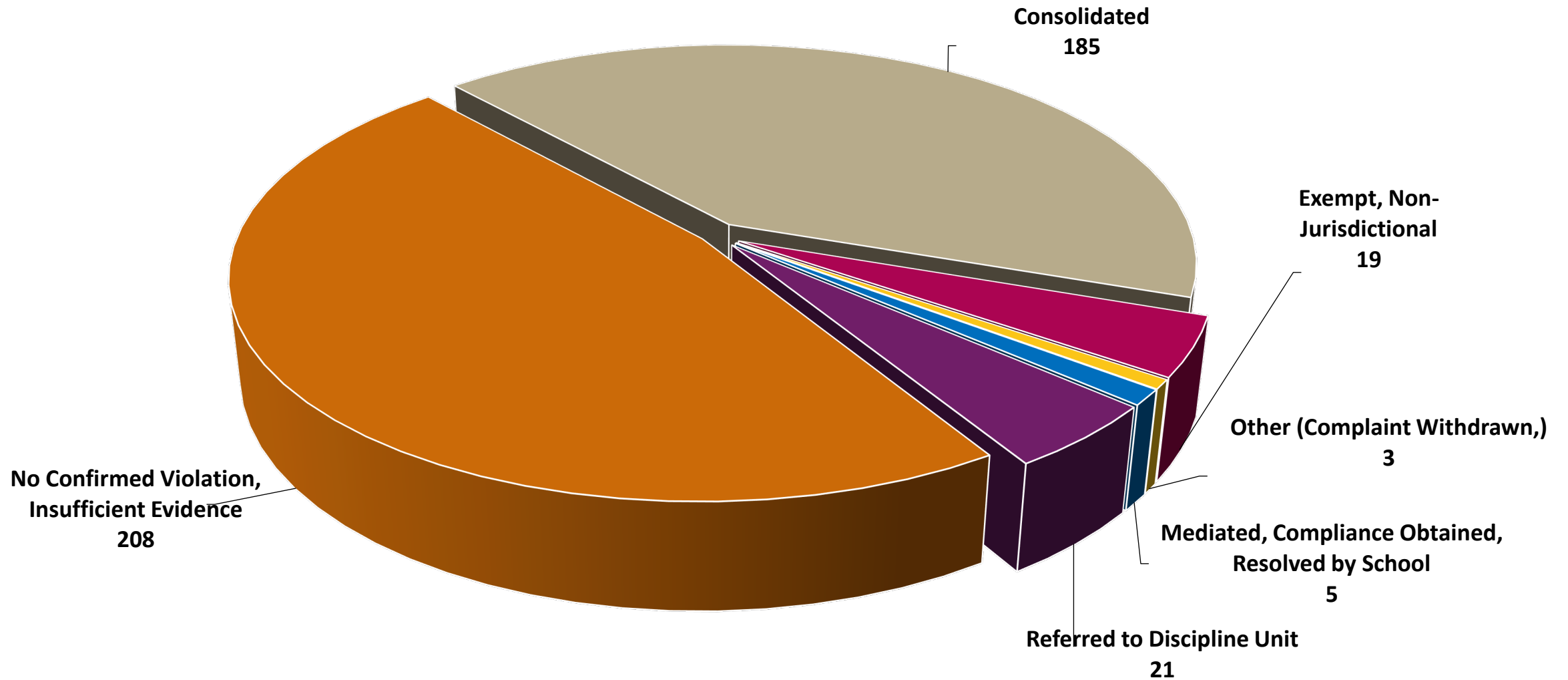
Days to Close (Cases Closed Q1-Q3 FY 2025-26)



# Complaint Intake Outcomes: Q1-Q3 FY 2025-26



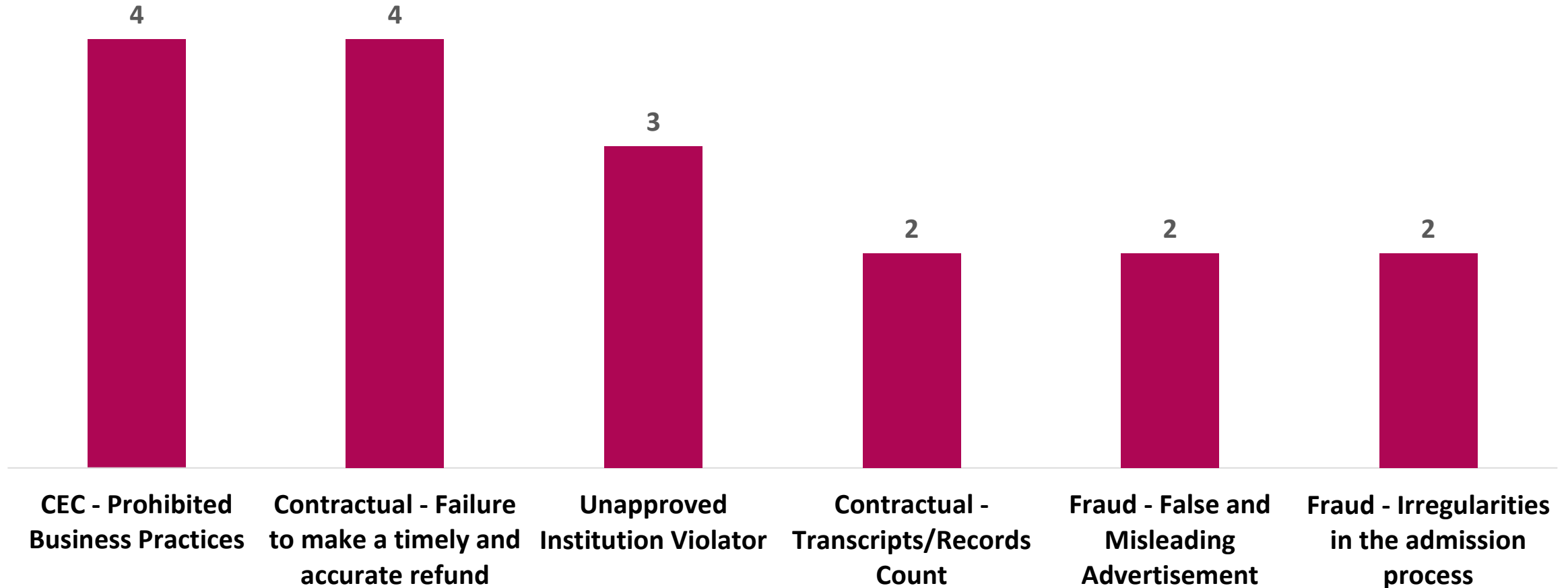

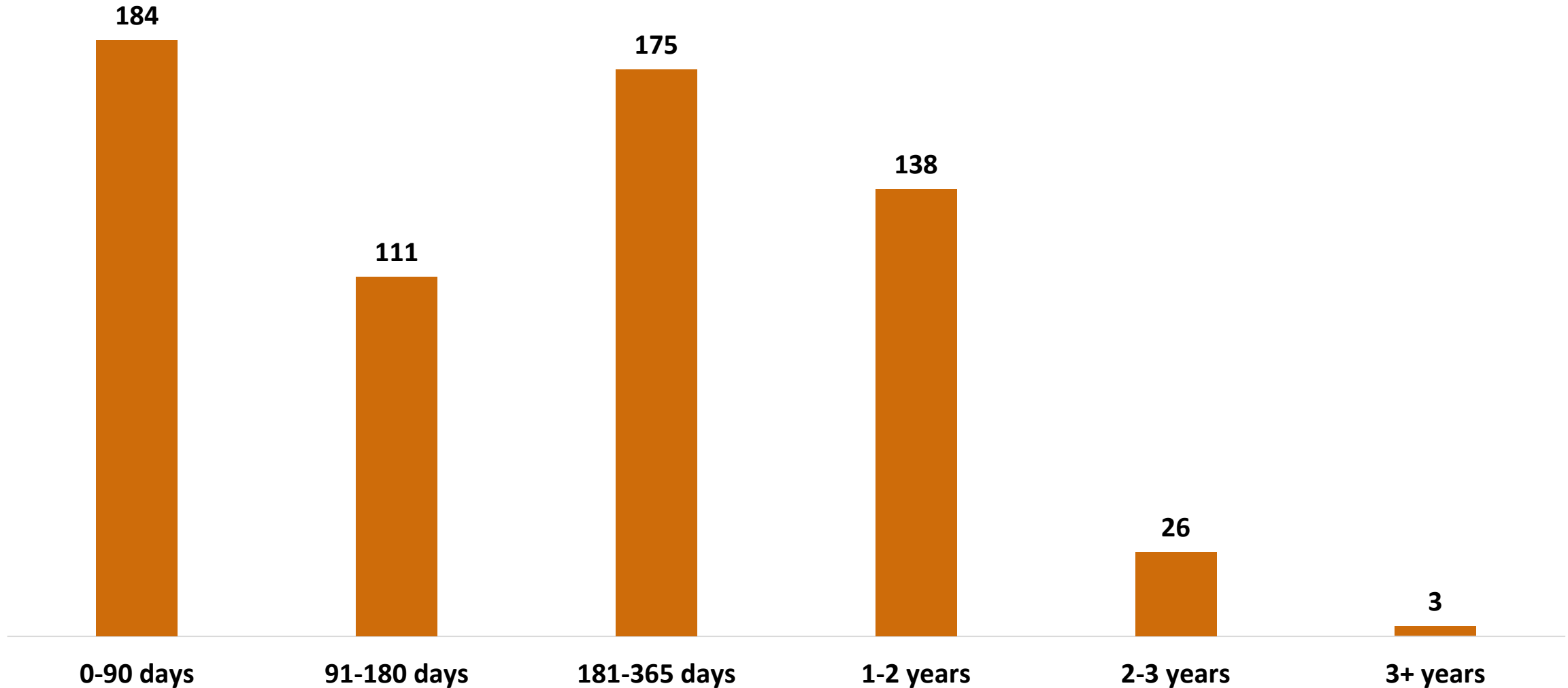

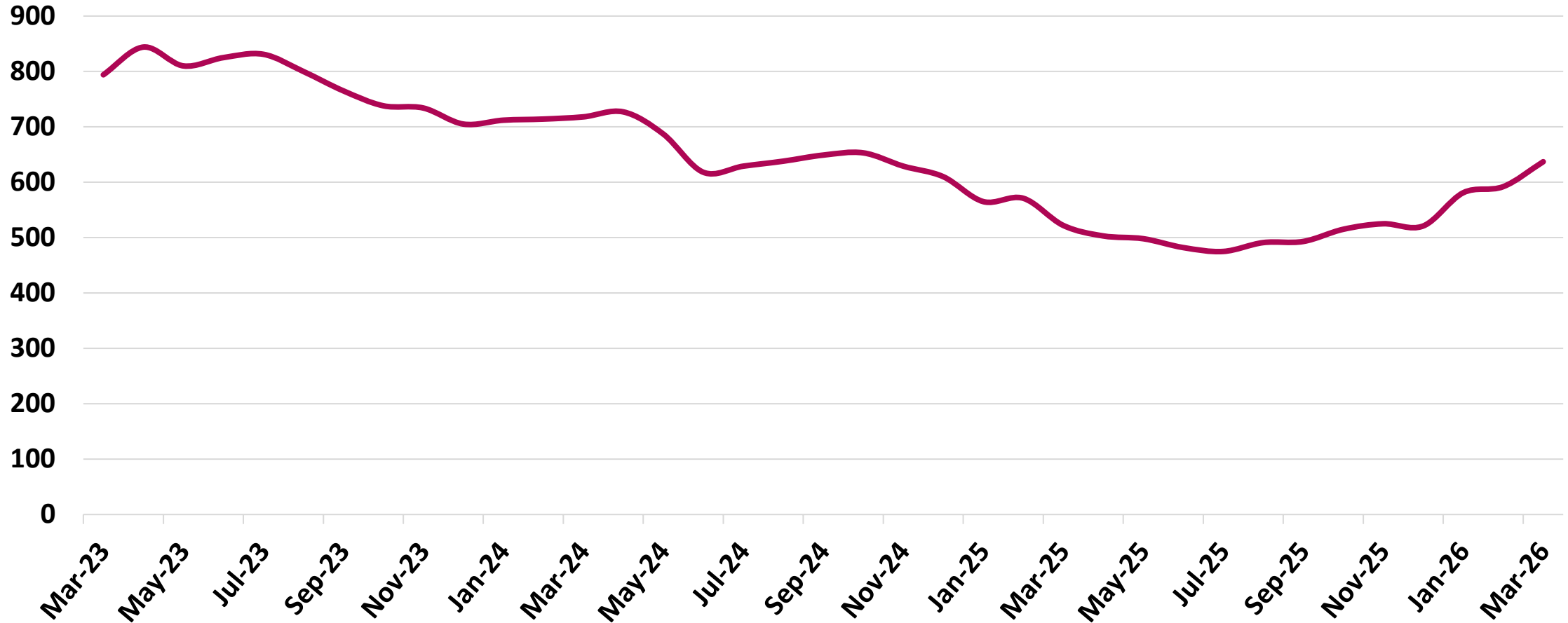

**Chapter 2. Applications**

**Article 1. Application for Approval to Operate and Offer Educational Programs for Non-Accredited Institutions**

**Amend section 71130 of Division 7.5 of Title 5 of the California Code of Regulations to read as follows:**

**71130. Institution Ownership and Control: Violations of Law.**

(\* \* \* \*)

(c) The institution shall provide a statement from any person identified in subdivision (a) of this section who –

(1) Was found in any judicial or administrative proceeding to have violated the Act or the law of any other state related to untrue or misleading advertising, the solicitation of prospective students for enrollment in an educational service, or the operation of a postsecondary school;

(2) Was denied any type of license on grounds set forth in Section ~~480~~480.2 of the Business and Professions Code;

(3) Was adjudicated as responsible for the closure of an institution in which there were unpaid liabilities to the state or federal government or any uncompensated pecuniary losses suffered by students;

(4) Has stipulated to a judgment or administrative order or entered a consent decree involving any of the matters described in this section.

(5) Was convicted of any misdemeanor or felony as provided in Section ~~480~~480.2(a)(1) of the Business and Professions Code;

(\* \* \* \*)

Note: Authority cited: Sections 94803, 94877 and 94888, Education Code. Reference: Sections 94885, 94887 and 94888, Education Code; and Sections 30 and ~~480~~480.2, Business and Professions Code.

#### **Article 4. Processing of Applications**

**Amend section 71400.5 of Division 7.5 of Title 5 of the California Code of Regulations to read as follows:**

##### **71400.5. Denial of an Application.**

(a) The inclusion of false or misleading information, or the intentional or negligent omission of pertinent information on any application may result in the denial of the application or a delay in processing, and may be grounds for action pursuant to Article 18 of the Act.

(b) In addition to denying an application pursuant to section 94887 of the Code, the Bureau may deny any application based on any act that constitutes grounds for the denial of a license under Section ~~480~~480.2 of the Business and Professions Code, incorporated herein by reference.

(c) The proceedings under this section shall be conducted in accordance with Chapter 5 (commencing with Section 11500) of Part 1 of Division 3 of Title 2 of the Government Code.

NOTE: Authority cited: Sections 94803 and 94877, Education Code. Reference: Section ~~480~~480.2, Business & Professions Code; and Sections 94887, 94888 and 94932, Education Code.

#### **Article 6. Renewals**

**Amend section 71475 of Division 7.5 of Title 5 of the California Code of Regulations to read as follows:**

##### **71475. Renewal of an Approval to Operate for a Non-Accredited Institution; Cancellation of an Approval to Operate**

(\* \* \* \*)

(f) The renewal application shall include a statement from any person identified in subdivision (h)(1) of this section who --

(1) Was found in any judicial or administrative proceeding to have violated the Act or the law of any other state related to untrue or misleading advertising, the solicitation of prospective students for enrollment in an educational service, or the operation of a postsecondary school;

(2) Was denied any type of license on grounds set forth in Section ~~480~~480.2 of the Business and Professions Code;

(3) Was adjudicated as responsible for the closure of an institution in which there were unpaid liabilities to the state or federal government or any uncompensated pecuniary losses suffered by students;

(4) Has stipulated to a judgment or administrative order or entered a consent decree involving any of the matters described in this section.

(5) Was convicted of any misdemeanor or felony as provided in Section ~~480~~480.2(a)(1) of the Business and Professions Code;

(\* \* \* \*)

Note: Authority cited: Sections 94803 and 94891, Education Code. Reference: Section 480.2, Business & Professions Code; and Sections 94802 and 94889, Education Code.

### **Chapter 3. Institutional Operating Standards**

#### **Article 1. Minimum Operating Standards**

**Amend section 71720 of Division 7.5 of Title 5 of the California Code of Regulations to read as follows:**

##### **71720. Faculty.**

(a) An Educational Program Leading to a Degree.

(\* \* \* \*)

(7) The institution shall not employ or continue to employ any faculty who were adjudicated in a judicial or administrative proceeding as having violated any provision of the Act or this chapter or as having committed any act that would constitute grounds for the denial of a license under Section ~~480~~480.2 of the Business and Professions Code;

(\* \* \* \*)

(b) Instructors in an Educational Program Not Leading to a Degree.

(\* \* \* \*)

**Chapter 5. Enforcement and Discipline**

**Article 3. Standards Related to Denial, Discipline, and Reinstatement of Approvals to Operate**

**75060. Substantial Relationship Criteria.**

In determining whether any of the grounds for denial, suspension, or revocation set forth in Sections ~~480~~480.2 or 490 of the Business and Professions Code exist, a crime or act shall be considered substantially related to the qualifications, functions, or duties of any

owner, corporate director or member of the governing board, officer, or administrator under any of the following circumstances:

(a) The crime or act involves any violation of the Act or this ~~chapter~~division, Title IV of the federal Higher Education Act of 1965 (20 U.S.C. § 1070, et seq.), the closure of an institution, fraud or misrepresentation, breach of fiduciary duty, any type of forgery or theft, or any type of dishonesty causing any financial loss.

(b) The crime, to a substantial degree, evidences present or potential unfitness to perform the functions and duties authorized or required by the Act or this ~~chapter~~division in a manner consistent with the public health, safety, or welfare, including a crime prohibited by Title 8 (commencing with Section 187) or Title 9 (commencing with Section 261) of the Penal Code.

In determining whether any of the grounds for denial, suspension, or revocation set forth in Sections ~~480~~480.2 or 490 of the Business and Professions Code exist, the Bureau shall consider evidence of rehabilitation and present eligibility for any approval issued by the Bureau, including all of the following factors:

(a) The nature and severity of the acts or crimes under consideration as grounds for denial, suspension, or revocation;

(b) Evidence of any acts committed after the acts or crimes under consideration as grounds for denial, suspension, or revocation that also could be considered grounds for denial, suspension, or revocation;

(c) The time that has elapsed since commission of the acts or crimes described in subdivisions (a) and (b);

(d) The extent to which the person has complied with any terms of parole, probation, restitution, or any other sanctions lawfully imposed against the applicant or licensee;

(e) Evidence of any rehabilitation submitted by the applicant or licensee;

(f) Total criminal record;

(g) Evidence, if any, of expungement proceedings pursuant to Section 1203.4 of the Penal Code.

(b) "Material violation" as used in section 94937 of the Code includes committing any act that would be grounds for denial, suspension, or revocation under section ~~480~~480.2 of the Business and Professions Code.

(c) The proceedings under this section shall be conducted in accordance with Article 10 (commencing with Section 11445.10) of Chapter 4.5 or Chapter 5 (commencing with Section 11500) of Part 1 of Division 3 of Title 2 of the Government Code, as requested by the institution.

<b>SUBJECT</b>	<b>Reduced-Credit Bachelor’s Degree Programs</b>

Reduced-credit bachelor’s degree programs, generally understood as bachelor’s degree programs requiring fewer total units within a shorter timeframe than traditional four-year bachelor’s programs, are growing in prevalence across the country. Many factors are driving this trend. As students seek more affordable pathways to degrees, institutions seek to reduce barriers to degree completion, and employers seek to prioritize skills and workforce competencies, reduced-credit bachelor’s programs present an innovative program model designed to achieve a degree with a lower cost and faster completion time than a traditional bachelor’s program. As of March 2026, nearly 60 institutions are planning, considering, or have already launched these programs in some disciplines.<sup>1</sup>

Several accrediting agencies and other states have published guidance or other documents regarding reduced-credit bachelor’s programs if institutions seek to offer them. This guidance varies—for instance, some accrediting agencies require a certain number of credits in a reduced-credit bachelor program, while others expect an institution to explain the reduction but do not necessarily define a minimum number of credits. Generally, an institution must continue to demonstrate breadth and depth of its curriculum in a reduced-credit bachelor’s degree program. One accreditor specifically requires a reduced credit bachelor program to be named “as something other than a baccalaureate or bachelor’s degree, such as an ‘undergraduate specialist’ degree...”<sup>2</sup>

The Bureau is assessing how to incorporate reduced-credit bachelor’s programs into the Private Postsecondary Education Act’s regulatory framework and seeks feedback from the Committee as it considers changes to allow such programs at accredited institutions.

## Discussion Questions:

1. The Bureau is considering reserving approval of these programs to institutions approved by means of accreditation. In such a scenario, should Bureau regulations specify minimum standards that must be met, such as the number of total credits or program names, or defer to the accrediting agencies?
2. If the Bureau establishes its own minimum requirements, how should those be determined?
3. Are there other consumer protections or disclosures to consider beyond the context of program approval?
4. Does the Committee have thoughts, experience, or other questions related to reduced-credit bachelor programs the Bureau should consider?

**Amend section 71390 of Division 7.5 of Title 5 of the California Code of Regulations to read as follows:**

**§ 71390. Application Form.**

(a) An applicant seeking approval to operate by means of its accreditation pursuant to Section 94890(a)(1) of the Code shall complete an application with the requirements of this section.

(b) An applicant shall submit to the Bureau: ~~the form~~

(1) A completed application as required by subdivision (a) of this section;

(2) A certified copy of its current verification of accreditation granted by its accrediting agency, and which shall include:

(A) The dates of the institution's term of accreditation;

(B) A complete list of the institution's owners, as defined in section 94851 of the Code, which shall include:

(i) The name of each person, as defined in section 94855 of the Code; and

(ii) The percentage of the institution that is owned or controlled by each person.

(C) The form of business organization of the institution;

(D) A complete list of the institution's locations and their physical addresses; and

(E) A complete list of the institution's educational programs that includes:

(i) Whether the program is within the scope of accreditation;

(ii) The level of degree awarded for each program, or if a program is a non-degree program, that the program is a diploma level program;

(iii) The required number of hours or credits for completion for each educational program, and semester, quarter, or trimester unit designations for degree programs; and

(iv) The method of instructional delivery for each educational program offered by the institution.

(3) The appropriate application fee, as provided in Section 94930.5(a)(3) of the Code.

(c) The application for Approval to Operate for an Accredited Institution shall include the following:

(1) The name, mailing address, telephone and fax numbers, website address and institution or school code of the institution.

(2) The name, mailing address, e-mail address, telephone and fax numbers of the institution contact person for the purposes of this application.

(3) The institution's owners, as defined in section 94851 of the Code, which shall include:

(A) The name of each person, as defined in section 94855 of the Code;

(B) The percentage of the institution that is owned or controlled by each person;

(C) The name, title, email address, and physical home address of each person, as defined in section 94855 of the Code, who owns or controls 25% or more of the stock or an interest in the institution, as defined in section 94852 of the Code; and

(D) The name, title, email address, and physical home address of each general partner, officer, corporate director, member of the board of directors, and any other person who exercises substantial control over the institution's management or policies. For the purpose of this paragraph, a person exercises "substantial control over the institution's management or policies" if the person has the authority to cause the institution to expend money or incur debt in the amount of five thousand dollars (\$5,000) or more in any year.

~~(A) For each address required, the institution shall provide a physical home address, and may request that the address, email address, and telephone number, of each person described in paragraph (3) be maintained as personal information.~~

~~(B)(E) The federal employer identification number for partnerships or corporations, or the social security number for individual owners identified in the application pursuant to section 71130(a)(1).~~

(4) The form of business organization of the institution. If the institution is incorporated, the institution shall also identify the state within which the institution is incorporated and the date of incorporation, and provide copies of the articles of incorporation.

(5) The name, physical address, and telephone number of the person or entity designated as the institution's agent for service of process by the applicant. The agent shall be at a physical address other than the address of the institution or any branch. The agent must confirm the information and acknowledge in writing that they are the designated agent for service of process.

(6) The name, physical address, email address, and telephone number of the custodian of records, and the physical addresses and telephone numbers of the offices or buildings where the records will be maintained. If records are stored at a location other than a physical address, the institution shall provide the location where the records are stored.

(7) A statement from any person identified in subdivision (c)(3) of this section who:

(A) Was found in any judicial or administrative proceeding to have violated the Act or the law of any other state related to untrue or misleading advertising, the solicitation of prospective students for enrollment in an educational service, or the operation of a postsecondary school;

(B) Was denied any type of license on grounds set forth in Section 480.2 of the Business and Professions Code;

(C) Was adjudicated as responsible for the closure of an institution in which there were unpaid liabilities to the state or federal government or any uncompensated pecuniary losses suffered by students;

(D) Has stipulated to a judgment or administrative order or entered a consent decree involving any of the matters described in this section;

(E) Was convicted of any misdemeanor or felony as provided in Section 480.2 of the Business and Professions Code.

(8) An acknowledgment by the applicant that they understand that an institution approved by means of its accreditation shall comply with all applicable requirements of the Act and of this Division.

(d) The application shall be signed with original or digital signature and dated, and each fact stated therein and each attachment thereto shall be declared to be true under penalty of perjury, as follows:

(1) Signatories:

(A) Each owner of the institution, or each partner in a partnership, or

(B) If the institution is incorporated, the chief executive officer or president of the corporation and each person who owns or controls 25 percent or more of the stock or interest in the institution, or

(C) If the institution is a nonprofit corporation or a public institution, by the chief executive officer or president.

(2) The declaration shall be in the following form: "I declare under penalty of perjury under the laws of the State of California that the foregoing and all attachments are true and correct.

(b) An institution seeking to renew its Approval to Operate pursuant to section 94890 of the Code shall ~~complete and~~ submit to the Bureau:

(1) A completed application with the requirements of this section;

(2) A certified copy of its verification of accreditation granted by its accrediting agency, which shall include:

(A) The dates of the institution's term of accreditation;

(B) A complete list of the institution's owners, as defined in section 94851 of the Code, which shall include:

(i) The name of each person, as defined in section 94855 of the Code; and

(ii) The percentage of the institution that is owned or controlled by each person.

(C) The form of business organization of the institution;

(D) A complete list of the institution's locations and their physical addresses; and

(E) A complete list of the institution's educational programs that includes:

(ii) The level of degree awarded for the program, or if the program is a non-degree program, that the program is a diploma level program;

(iii) The required number of hours or credits for completion for each educational program, and semester, quarter, or trimester unit designations for degree programs; and

(iv) The method of instructional delivery for each educational program offered by the institution.

(3) The appropriate application fee, as provided in Section 94930.5(b)(3) of the Code.

(c) The application for renewal of an approval to operate for an accredited institution shall include all of the following:

(1) The name, institution or ~~/~~school code, and website address of the institution.

(2) The mailing address, identified either by physical address or by post office box number, telephone number and fax number of the institution.

(3) The name, address, email address, telephone number and fax number of an individual who will function as the institution's contact person for the purposes of the application.

(4) The institution's owners, as defined in section 94851 of the Code, which shall include:

(A) The name of each person, as defined in section 94855 of the Code;

(B) The percentage of the institution that is owned or controlled by each person;

(C) The name, title, email address, and physical home address of each person, as defined in section 94855 of the Code, who owns or controls 25% or more of the stock or an interest in the institution as defined in section 94852 of the Code; and

(D) The name, title, email address, and physical home address of, to the extent applicable, each general partner, officer, corporate director, member of the board of directors, and any other person who exercises substantial control over the institution's management or policies. For the purpose of this paragraph, a person exercises "substantial control over the institution's management or policies: if the person has the authority to cause the institution to expend money or incur debt in the amount of five thousand dollars (\$5,000) or more in any year.

(EB) The federal employer identification number for partnerships or corporations, or the social security number for individual owners identified in the application.

(5) The form of business organization of the institution. If the institution is incorporated, the institution shall also identify the state within which the institution is incorporated and the date of incorporation, and provide copies of the articles of incorporation.

(6) The name, physical address, and telephone number of the person or entity designated as the institution's agent for service of process by the institution. The agent shall be at a physical address other than the address of the institution or any branch. The agent must confirm the information and acknowledge in writing that they are the designated agent for service of process.

(7) The name, physical address, email address, and telephone number of the custodian of records, and the physical addresses and telephone numbers of the offices or buildings

where the records will be maintained. If records are stored at a location other than a physical address, the institution shall provide the location where the records are stored. If there have been no substantive changes made the institution may so state and is not required to provide documentation.

(8) A statement from any person identified in subdivision (c)(4) of this section who:

(A) Was found in any judicial or administrative proceeding to have violated the Act or the law of any other state related to untrue or misleading advertising, the solicitation of prospective students for enrollment in an educational service, or the operation of a postsecondary school;

(B) Was denied any type of license on grounds set forth in Section 480.2 of the Business and Professions Code;

(C) Was adjudicated as responsible for the closure of an institution in which there were unpaid liabilities to the state or federal government or any uncompensated pecuniary losses suffered by students;

(D) Has stipulated to a judgment or administrative order or entered a consent decree involving any of the matters described in this section;

(E) Was convicted of any misdemeanor or felony as provided in Section 480.2 of the Business and Professions Code.

(9) An acknowledgement by the applicant that they understand that an institution approved by means of its accreditation shall comply with all applicable requirements of the Act and of this Division.

(d) An institution may submit an application for renewal of an Approval to Operate pursuant to Section 94890 of the Code while the institution's renewal of accreditation is pending from its accrediting agency. The Bureau shall not approve the renewal application before the institution's accreditation has been renewed by the institution's accrediting agency for the next term of accreditation. In addition to the form required in (b), the institution shall submit the appropriate renewal fee as provided in Section 94930.5(b)(3) of the Code to the Bureau, and verification that its accreditation has been renewed by its accreditation agency.

(e) The institution ~~demonstrates~~ attests to its continued capacity to meet the minimum operating standards by submitting the application signed and dated, and each fact stated therein and each attachment thereto declared to be true under penalty of perjury, as follows:

(1) Signatories shall sign with original or digital signatures:

(A) Each owner of the institution, or each partner in a partnership, or

(B) If the institution is incorporated, by the chief executive officer or president of the corporation and each person who owns or controls 25 percent or more of the stock or interest in the institution, or

(C) If the institution is a nonprofit corporation or a public institution, by the chief executive officer or president.

(2) The declaration shall be in the following form: "I declare under penalty of perjury under the laws of the State of California that the foregoing and all attachments are true and correct.

(3) The application will include the date signed, the name and title of each signor of the application.

(f) Provided that a complete renewal application under CCR section 71480 is received by the Bureau on or before 30 calendar days after the expiration of the approval, a valid approval to operate shall continue until the Bureau has acted upon the renewal application. If a complete renewal application under CCR section 71480 is not received by the Bureau on or before 30 calendar days after expiration of the approval to operate, the institution's approval to operate shall terminate by operation of law on the 31st calendar day after the expiration of the approval to operate. An institution continuing to operate more than 30 calendar days beyond expiration will be subject to citation for operating without approval.

(g) An incomplete application filed under this section will render the institution ineligible for renewal.

(a) Graduation requirements for an undergraduate degree program shall meet minimum credit requirements and shall include provisions for general education appropriate to the level and type of degree. The institution shall specify the distribution of general education credit requirements by subject area for each undergraduate degree program.

(~~b~~) A Bachelor's degree may be awarded to a student whom the institution can document has achieved sequential learning equivalent in general education and equivalent in depth of achievement in a designated major field to that acquired in four years of study beyond high school, as measured by a minimum of 120 semester credits or its equivalent. At least 25 percent of the credit requirements for a Bachelor's degree shall be in general education.

(1) If an institution approved to operate by means of its accreditation seeks to award a student a Bachelor's degree with fewer than 120 but at least 90 semester credits or its equivalent, it may deviate from the standards described in subdivision (b), if the deviations for that program are approved by the institution's accrediting agency recognized by the United States Department of Education.

(A) Any Bachelor's degree programs offered with reduced credit requirements must include reference to the reduced-credit nature of the educational program in its name and all descriptions of the educational program. Any known or potential implications for employment qualification, admission to graduate studies, transfer of credit, or professional licensure must be communicated to prospective students.

(~~c~~b) An Associate degree may be awarded only to a student whom the institution can document has achieved sequential learning equivalent to that acquired in two years of study beyond high school, as measured by a minimum of 60 semester credits or its equivalent. Except as provided in subdivision (~~e~~d) of this section, at least 25 percent of the credit requirements for an Associate degree shall be in general education.

(~~d~~e) The Specialized Associate degree (Occupational) or the Associate of Applied Science degree may be awarded only to a student who completes at least the learning outcomes equivalent to a minimum of 60 semester credits or the equivalent. A minimum of seventy-five percent of the credits shall be in the occupational area for which training is offered. The general education offered as part of a Specialized Associate degree (Occupational) or an Associate of Applied Science degree program shall be such as is necessary for a student to achieve the educational objectives of the program in which the student is enrolled. General education shall be at the same level of quality as that taught in approved Bachelor's or Associate degree programs.
