20 1. On or about March 21, 2016, the Bureau for Private Postsecondary Education  
21 (Bureau) received an Application for Approval to Operate an Institution Non-Accredited from  
22 Rosa E. Macias, doing business as Del Mar Beauty School (Respondent). On or about July 17,  
23 2017, the Bureau issued Respondent a Notice of Denial of Application for Approval to Operate.

24 2. On or about November 30, 2017, Dr. Michael Marion, Jr., Chief of the Bureau for  
25 Private Postsecondary Education, filed Statement of Issues No. 1002923 solely in his  
26 official capacity.

1           3.    On or about May 8, 2018, Respondent withdrew her appeal and request for a hearing  
2 of the denial of her application for approval to operate an institution non-accredited by the  
3 Bureau.

4           4.    Accordingly, Statement of Issues No. 100923, filed against Respondent, is hereby  
5 withdrawn without prejudice and the denial of her application is affirmed.
