19 1. On or about June 8, 2015, the Bureau for Private Postsecondary Education ("Bureau")
20 received an Application for Approval to Operate an Institution Non-Accredited from Respondent
21 CodingDojo, Inc., also known as Coding Dojo ("Respondent"), a California corporation.
22 Between June 22, 2015 and May 25, 2017, the Bureau and Respondent exchanged
23 correspondence regarding Respondent's application.

24 2. On or about September 15, 2017, the Bureau issued Respondent a Notice of Denial of
25 Application for Approval to Operate. On or about September 28, 2017, the Bureau received from
26 Respondent a request for an administrative hearing.

On or about January 9, 2018, Dr. Michael Marion, Jr., Chief of the Bureau for Private Postsecondary Education, Department of Consumer Affairs, filed Statement of Issues No. 1002964 solely in his official capacity. After the filing of Statement of Issues No. 1002964, Respondent provided additional documents intended to resolve issues of non-compliance in Respondent's application.

4. The Bureau hereby withdraws Statement of Issues No. 1002964. The basis for the withdrawal of this pleading is that Respondent has now provided the documents and other information necessary for its application of licensure.

5. WHEREFORE, IN THE INTERESTS OF JUSTICE, Statement of Issues No. 1002964 is hereby withdrawn without prejudice.
