24 1. On or about March 19, 2019, Dr. Michael Marion, Jr, Chief of the Bureau for Private
25 Postsecondary Education, Department of Consumer Affairs filed Statement of Issues No.
26 1003498 solely in his official capacity.

27 2. On or about February 1, 2017, the Bureau for Private Postsecondary Education
28 received an Application for Renewal of Approval to Operate an Institution Non-Accredited from
Florence N. Andongella, as owner of Professional Schools of Beauty, Fashion and Arts, Inc.
(Respondent). After notices of deficiencies and further information from Respondent, on or about

1 May 4, 2018, the Bureau denied the application. The Bureau received a letter from Respondent
2 requesting an administrative hearing.

3 3. The basis for withdrawing the pending Statement of Issues number 1003498 is that
4 Respondent has now provided the documents and other information necessary to cure all
5 deficiencies and receive a Renewal of Approval to Operate for an Institution Non Accredited.

7 WHEREFORE, IN THE INTERESTS OF JUSTICE, Statement of Issues number 1003498
8 is hereby withdrawn without prejudice effective upon signature.
