Violation	Code Section Violated	Description of the violation and required correction.
1	CEC § 94909 (a)(8)(D)	Violation Description: The institution's catalog failed to include an Attendance Policy pursuant to CEC § 94909 (a)(8)(D). Correction: The institution shall update the catalog and include an Attendance policy.
2	CEC § 94913 (a)(1)	Violation Description: The institution's website failed to include the most recently updated catalog pursuant to CEC § 94913 (a)(1). Correction: Once the institution's catalog has been updated to remedy the violation(s), the institution shall update its website to provide the current/updated school catalog pursuant to CEC § 94913(a)(1).
3	CEC § 94909 (a)(3)(D)	Violation Description: The institution's catalog failed to include the required statement with the correct inserts regarding "The Office of Student Assistance and Relief" (OSAR) pursuant to CEC § 94909 (a)(3)(D). The

		institution added their own information instead of the correct inserts. Correction: The institution shall update the catalog to include the required statement with the correct inserts (shown below) regarding, “The Office of Student Assistance and Relief” (OSAR) pursuant to CEC § 94909 (a)(3)(D). “The Office of Student Assistance and Relief is available to support prospective students, current students, or past students of private postsecondary educational institutions in making informed decisions, understanding their rights, and navigating available services and relief options. The office may be reached by calling ((888) 370–7589, Option #5, or by visiting, www.https://osar.bppe.ca.gov/).”
4	CEC §94909(a)(15)	Violation Description: The institutions catalog failed to include the title of the transferability statement in the required format pursuant to CEC §94909(a)(15). Correction: The institution shall update the catalog to include the title of the transferability statement in the required format. All Capital Letters (page 110).
5	5, CCR §71810(b)(3)	Violation Description: The catalog failed to specify whether there are any associated charges for the visa services provided pursuant to 5, CCR §71810(b)(3). Correction: The institution shall update the catalog to include whether there are any associated charges for the visa services provided. (page 107 has reference but is incomplete).

6	CEC §94909(a)(11)	Violation Description: The institutions catalog failed to contain a statement in its entirety specifying that, if a student obtains a loan to pay for an educational program, the student will have to repay the full amount of the loan plus interest, less the amount of any refund, and that, if the student receives federal student financial aid funds, the student is entitled to a refund of the moneys not paid from federal financial aid funds pursuant to CEC §94909(a)(11). Correction: The institution shall update the catalog to include the required statement in its entirety.
7	5, CCR §71810 (b)(11))	Violation Description: The institution failed to include a statement indicating the approximate number of days that will elapse between the institution's receipt of student lessons, projects, or dissertations and the institution's response or evaluation pursuant to 5, CCR §71810 (b)(11)) Correction: The institution shall include a statement indicating the approximate response time.
8	CEC § 94911 (C)	Violation Description: The institution's enrollment agreement failed to include the charges in the specific format on the same page as the students signature pursuant to CEC § 94911 (C). Correction: The institution shall update the enrollment agreement to include the charges in the specific format on the same page as the student's signature.
9	CEC § 94897 (s)	Violation Description: The institution's enrollment agreement contains language that violates Section 1788.93 of the Civil Code pursuant to CEC § 94897 (s). Page 2 states the school will not issue transcripts if a student has a delinquent account or past due balance due. Correction: The institution shall revise the enrollment agreement and remove any reference that violates Civil Code 1788.93. pursuant to CEC § 94897 (s).

Pursuant to 5 CCR section 75010(d), the Institution may do either of the following:

- (1) Within 30 days from the date of the inspection, sign and return the notice to comply, declaring under penalty of perjury that the violation was corrected and describing how compliance was achieved; or
- (2) Within 30 days from the date of the inspection, file with the Bureau a written notice of disagreement, specifying the minor violations described in the notice to comply with which the person approved to operate the institution disagrees, and appealing it by requesting an informal office conference. If a written notice of disagreement is not timely filed with the Bureau, the right to appeal is deemed to have been waived.

Pursuant to CEC section 94935(h), failure to comply with the notice to comply will result in the Bureau taking appropriate administrative enforcement action.

The Notice to Comply was given to the Institution's owner, person in control, chief academic officer, chief executive officer, chief operating officer, institution director, or any person delegated by any of the aforementioned persons to facilitate the inspection or accept such notice as set forth below.
