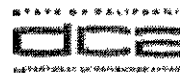

Christina Villanueva issues this Citation: Assessment of Fine and Order of Abatement (Citation) in her official capacity as Discipline Manager for the Bureau for Private Postsecondary Education (Bureau) of the California Department of Consumer Affairs.

CITATION

A Citation is hereby issued to Integrative Wellness Academy, LLC, Owner of Integrative Wellness Academy (Institution) located at 10977 Bluffside Drive, Suite 1307, Los Angeles, CA 91604 pursuant to Business and Professions Code section 125.9 and 149; California Education Code (CEC) section 94944; and Title 5 of the California Code of Regulations (5, CCR) section 75020 for the violation(s) described below.

BACKGROUND

On February 4, 2019, the Bureau received a complaint alleging that the Institution, located at 10977 Bluffside Drive, Suite 1307, Los Angeles, CA 91604, is operating without Bureau approval.

The Bureau determined that the Institution is offering educational programs as a private postsecondary educational institution without Bureau approval based on the Institution's website, www.iwacoaching.com, which establishes tuition costs ranging from \$3200.00 to \$4300.00. These tuition fees prohibit the Institution from operating under Categories of Exempt Institutions- California Code of Regulations Section 94874(f)- An institution that does not award degrees and that solely provides educational programs for total charges of \$2500.00 or less.

VIOLATION(S)

#	Below you will find the California Education Code (CEC) and/or Title 5 of the California Code of Regulations (5, CCR code) section(s) of law you are charged with violating.
1.	<p><u>Violation:</u></p> <p>CEC Section 94886. Approval to Operate Required <i>"Except as exempted in Article 4 (commencing with Section 94874) or in compliance with the transition provisions in Article 2 (commencing with Section 94802), a person shall not open, conduct, or do business as a private postsecondary educational institution in this state without obtaining an approval to operate under this chapter."</i></p> <p>CEC Section 94858. Private Postsecondary Educational Institution <i>"Private postsecondary educational institution" means a private entity with a physical presence in this state that offers postsecondary education to the public for an institutional charge.</i></p> <p>CEC Section 94817.5. Approved to Operate or Approved <i>"Approved to operate" or "approved" means that an institution has received authorization pursuant to this chapter to offer to the public and to provide postsecondary educational programs."</i></p> <p>CEC Section 94868. To Offer to the Public <i>"To offer to the public" means to advertise, publicize, solicit, or recruit."</i></p> <p>CEC Section 94869. To Operate <i>"To operate" means to establish, keep, or maintain any facility or location in this state where, or from which, or through which, postsecondary educational programs are provided."</i></p> <p>On February 13, 2019, Bureau staff reviewed the Institution's website, at https://iwacoaching.com/, and found that the Institution offers many assorted programs of which, the following programs exceed the exemption amount of \$2500.00 pursuant to CCR, Section 94874(f):</p> <ul style="list-style-type: none">• Holistic Life Planner (HLP) (Add-on certification course) - \$3500.00• Holistic Life Planner Certification Course - \$4300.00• Master Integrative Life Coaching (MILC) In-Person - \$3400.00• Integrative Life Coaching (ILC) Certification, MILC Certification, & Business Mastery Course (BMC) - 12-week course - \$3599.00• MILC Online Course - \$3200.00 <p>Based on the Bureau's investigation, the Institution is operating a private postsecondary educational institution at 10977 Bluffside Drive, Suite 1307, Los Angeles, CA 91604, outside of exempt from the provisions of the California Private Postsecondary Act of 2009. The Institution advertises educational programs with tuition fees ranging from \$3200.00 to \$4300.00. Total charges exceed the threshold for operating under operating under CEC section 94858 and requires Bureau approval for operating a private postsecondary institution.</p> <p><u>Order of Abatement:</u> The Bureau orders that the Institution cease to operate as a private postsecondary educational institution, unless the Institution qualifies for an exemption under CEC Section 94874. The Institution</p>

must discontinue recruiting or enrolling students and cease all instructional services and advertising in any form or type of media, including <https://iwacoaching.com/> and any other websites not identified here that are associated with the Institution, until an approval to operate is obtained from the Bureau. The Institution must disconnect all telephone service numbers including but not limited to (818) 358-3131 that are associated with the Institution, until an approval to operate is obtained from the Bureau. To comply with the Order of Abatement the Institution must submit a school closure plan to the Bureau pursuant to California Education Code Section 94926. The Institution must provide a roster of each student currently enrolled at the Institution. The roster must include the names of the students, their contact information (including phone number, email address, and physical address), the programs in which they are enrolled, the amount paid for the programs.

Assessment of Fine

The fine for this violation is \$5,000.00

TOTAL ADMINISTRATIVE FINE DUE: \$5,000.00

ASSESSMENT OF A FINE

In accordance with CEC section 94944; and 5, CCR section 75020(b), the Bureau hereby orders this assessment of a fine in the amount of **\$5,000.00** for the violations described above. **Payment must be made, to the Bureau, within 30 days from the date of service of the Citation.**

COMPLIANCE WITH ORDER OF ABATEMENT

In accordance with the provisions of 5, CCR section 75020 (b) the Bureau hereby issues the order(s) of abatement described above. In accordance with Business and Professions Code Section 149, the Bureau may disconnect any telephone service numbers used by an unapproved Institution. **Evidence of compliance with the order(s) of abatement must be submitted, to the Bureau, within 30 days from the date of service of the Citation.**

APPEAL OF CITATION

You have the right to contest this Citation through an informal conference with the Bureau; and/or through an administrative hearing in accordance with Chapter 5 (Commencing with Section 11500) of Part 1 of Division 3 of Title 2 of the Government Code.

If you wish to contest this Citation, you must submit the 'Notice of Appeal of Citation - Request for Informal Conference and/or Administrative Hearing' form (enclosed) within **30 days** from the date of service of the Citation. *If you do not request an informal conference and/or an administrative hearing within 30 days from the service of the Citation, you will not be able to request one later.*

Unless a written request for an informal conference and/or an administrative hearing is signed by you and delivered to the Bureau by **June 13, 2019**, you will be deemed to have waived or forfeited your right to appeal this matter.

EFFECTIVE DATE OF CITATION

If you do not request an informal conference and/or an administrative hearing, this Citation shall become effective on **May 14, 2019**. Payment of the administrative fine and evidence of compliance

with the order(s) of abatement shall be due by **June 13, 2019**. Your payment of the administrative fine shall not constitute an admission of the violation(s) charged.

If a hearing is requested, you will not be required to comply with this Citation until 30 days after a final order is entered against you.


