Christina Villanueva issues this Citation: Assessment of Fine and Order of Abatement (Citation) in her official capacity as Discipline Manager of the Bureau for Private Postsecondary Education (Bureau) of the California Department of Consumer Affairs.

CITATION

A Citation is hereby issued to The English Language Learning Center, Inc., Owner of English Language Learning Center (Institution) located at 10850 Wilshire Blvd., Suite 210, Los Angeles, CA 90024, pursuant to Business and Professions Code section 125.9; California Education Code (CEC) section 94936; and Title 5 of the California Code of Regulations (5, CCR) section 75020 for the violations described below.

BACKGROUND

All institutions are required to submit a Student Tuition Recovery Fund (STRF) Assessment Reporting Form to the Bureau no later than the last day of the month following the close of the quarter.

Pursuant to CEC section 94923(a) The Student Tuition Recovery Fund relieves or mitigates economic loss suffered by a student while enrolled in an institution not exempt from this article pursuant to Article 4 (commencing with section 94874), who, at the time of his or her enrollment, was a California resident or was enrolled in a California residency program, prepaid tuition, and suffered economic loss.

The Bureau sends notifications/reminders to all approved institutions 30 days prior to close of each quarter.

As of June 24, 2019, English Language Learning Center #1912061 has not submitted the STRF Assessment Reporting Forms for the 2nd, 3rd, and 4th quarter of 2017, the 1st, 2nd, 3rd, and 4th quarter of 2018 and the 1st quarter of 2019.

The assessment shall be collected for the entire period of enrollment, regardless of whether the student pays the institutional charges in increments.</i></p> <p><i>(b) A qualifying institution shall complete the STRF Assessment Reporting Form (Rev. 2/10) and remit it with the STRF assessments collected from students to be received by the Bureau no later than the last day of the month following the close of the quarter as follows:</i></p> <p><i>(1) April 30 for the first quarter,</i></p> <p><i>(2) July 31 for the second quarter,</i></p> <p><i>(3) October 31 for the third quarter, and</i></p> <p><i>(4) January 31 for the fourth quarter. On October 2, 2017, the Institution was notified via mail at 10850 Wilshire Blvd., Suite 210, Los Angeles, CA 90024, stating that the STRF Assessment Reporting Forms for the 3rd quarter of 2017, was due.

On January 2, 2018, the Institution was notified via mail at 10850 Wilshire Blvd., Suite 210, Los Angeles, CA 90024, stating that the STRF Assessment Reporting Forms for the 4th quarter of 2017, was due.

On April 3, 2018, the Institution was notified via mail at 10850 Wilshire Blvd., Suite 210, Los Angeles, CA 90024, stating that the STRF Assessment Reporting Forms for the 1st quarter of 2018, was due.

On June 18, 2018, the Institution was notified via mail at 10850 Wilshire Blvd., Suite 210, Los Angeles, CA 90024, stating that the STRF Assessment Reporting Forms for the 2nd quarter of 2018, was due.

On September 18, 2018, the Institution was notified via mail at 10850 Wilshire Blvd., Suite 210, Los Angeles, CA 90024, stating that the STRF Assessment Reporting Forms for the 3rd quarter of 2018, was due.

On December 20, 2018, the Institution was notified via mail at 10850 Wilshire Blvd., Suite 210, Los Angeles, CA 90024, stating that the STRF Assessment Reporting Forms for the 4th quarter of 2018, was due.

On March 27, 2019, the Institution was notified via mail at 10850 Wilshire Blvd., Suite 210, Los Angeles, CA 90024, stating that the STRF Assessment Reporting Forms for the 1st quarter of 2019, was due.

As of June 24, 2019, the Bureau has not received the delinquent STRF Assessment Reporting Forms from the Institution.

Order of Abatement:

The Bureau orders that the Institution submit the delinquent STRF Assessment Reporting Forms with the STRF Assessments collected from students for the quarters listed above. The Institution shall also submit the student information to substantiate the data reported on the STRF Assessment Reporting Forms. The information provided shall comply with "Record Keeping Requirements" Pursuant to 5, CCR section 76140.

ASSESSMENT OF A FINE

COMPLIANCE WITH ORDER OF ABATEMENT

In accordance with the provisions of CEC section 94936 and 5, CCR section 75020 the Bureau hereby issues the order of abatement described above. **Evidence of compliance with the order of abatement must be submitted, to the Bureau, within 30 days from the date of service of the Citation.**

APPEAL OF CITATION

You have the right to contest this Citation through an informal conference with the Bureau; and/or through an administrative hearing in accordance with Chapter 5 (Commencing with Section 11500) of Part 1 of Division 3 of Title 2 of the Government Code.

If you wish to contest this Citation, you must submit the 'Notice of Appeal of Citation – Request for Informal Conference **and/or** Administrative Hearing' form (enclosed) within 30 days from the date of service of the Citation. *If you do not request an informal conference **and/or** an administrative hearing within 30 days from the service of the Citation, you will not be able to request one at a later time.*

Unless a written request for an informal conference **and/or** an administrative hearing is signed by you and delivered to the Bureau by July 25, 2019, you will be deemed to have waived or forfeited your right to appeal this matter.

EFFECTIVE DATE OF CITATION

If you do not request an informal conference and/or an administrative hearing, this Citation shall become effective on **June 25, 2019**. Payment of the administrative fine and evidence of compliance with the order(s) of abatement shall be due by **July 25, 2019**. Your payment of the administrative fine shall not constitute an admission of the violation(s) charged.

If a hearing is requested, you will not be required to comply with this Citation until 30 days after a final order is entered against you.
