LICENSING HISTORY

1. On or about May 25, 2018, the Bureau renewed an Approval to Operate a Private Postsecondary Institution to University of North Los Angeles (hereinafter referred to as the "Institution"). This Approval to Operate expired on or about May 25, 2023, and has not been renewed. An application for renewal of the Institution's Approval to Operate a Private Postsecondary Institution was received on May 31, 2023, and is under review.

CITATION HISTORY

4. On or about July 19, 2023, the Bureau issued Citation No. 2324010. On or about August 3, 2023, the Bureau received an appeal with a request for an informal conference and administrative hearing. The Bureau held the informal conference on August 23, 2023, and the citation was modified as a result of the informal conference. The Institution requested the Bureau move forward with the appeal for an administrative hearing; however, later requested settlement options in lieu of the administrative hearing. As settlement of the Modified Citation No. 2324010, the Institution agrees to withdraw its request for an Administrative Hearing, submit closure documents pursuant to 5 CCR section 76240 and withdraw its pending renewal application within 30 days of this settlement of Modified Citation No. 2324010 as follows:

CAUSE FOR CITATION & MODIFIED ASSESMENT OF FINE AND/OR ORDER OF ABATEMENT

5. The Institution is in violation of the following Bureau laws and regulations:

Violation #1:

5 CCR section 71930 (c)(3), (c)(4), (e) – Maintenance of Records

Cause for Citation: On or about March 16, 2022, the Bureau conducted an unannounced compliance inspection pursuant to CEC section 94932.5 (a). Prior to the inspection, Bureau staff confirmed that the Institution's hours of operation are listed as Monday-Friday, 10:00am-4:00pm, via its social media Facebook page as the Institution's website page was down for maintenance. On March 16, 2022, Bureau staff arrived at the Institution's address on file and found the Institution was not located at the physical address approved by the Bureau. Bureau staff contacted the Institution's Owner and stated their purpose for the visit. The Owner informed Bureau staff that the Institution is not currently operating, as it was in the process of moving. Bureau staff asked the Owner if anyone was available to assist them with the unannounced inspection. The Owner stated that the Institution no longer has an office at the physical address approved by the Bureau. The Owner stated the Institution is moving to another office within the same building and had not notified the

Bureau of the change of physical address. Bureau staff informed the Owner that all approved institutions are subject to announced and unannounced compliance inspections. and that the Bureau does not reschedule unannounced compliance inspections. The Owner stated he understood.

Where a citation is not contested and fine is not paid, the full amount of the assessed fine shall be added to the fee for renewal of the approval to operate. An approval to operate shall not be renewed without payment of the renewal fee and fine. The Bureau may also enforce the administrative fine as if it were a money judgment pursuant to CEC section 94936.
