1. On or about March 25, 2020, the Bureau renewed an Approval to Operate a Private Postsecondary Institution, Institution Code 2701161, to P. Steve Ramirez Vocational Training Centers (formerly known as Custom Training Solutions) hereinafter referred to as the "Institution". This Approval to Operate will expire on or about March 25, 2025, unless renewed.

CAUSE FOR CITATION & ASSESSMENT OF FINE AND/OR ORDER OF ABATEMENT

4. The Institution is in violation of the following Bureau laws and regulations:

Violation #1:

CEC section 94902(a) - General Enrollment Requirements and 5 CCR section 71920(b)(3) – Student Records

Cause for Citation: On or about December 19, 2023, The Bureau conducted an announced compliance inspection pursuant to CEC section 94932.5(a). Bureau staff inspected a random sampling of student records for current, graduated, and withdrawn students and found that two of the graduated student files reviewed did not contain an enrollment agreement.

Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class A" violation. The Institution is issued a fine of \$5,000.00.

Order of Abatement: Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to ensure all student records follow the law pursuant to CEC section 94902 and 5 CCR section 71920. The Institution must submit a statement of attestation that they have corrected the violation and will ensure that all student records contain executed enrollment agreements. The statement of attestation must be signed and dated by an authorized representative of the Institution.

Violation #2:

CEC section 94902(b)(1) – General Enrollment Requirements and CEC section 94912 – Signature, Initials Required

Cause for Citation: On or about December 19, 2023, The Bureau conducted an announced compliance inspection pursuant to CEC section 94932.5(a). Bureau staff inspected a random sampling of student records for current, graduated, and withdrawn students and found that two of the graduated student files reviewed did not contain a signed School Performance Fact Sheet (SPFS).

Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class B" violation. The Institution is issued a fine of \$1,001.00.

Order of Abatement: Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to ensure all student records follow the law pursuant to CEC sections 94902 and 94912. The Institution must submit a statement of attestation that they have corrected the violation and will ensure that all student records contain signed SPFS. The statement of attestation must be dated and signed by an authorized representative of the Institution.

Violation #3:

CCR section 74112(m) (1) (3-9) Uniform Data – Annual Report, Performance Fact Sheet

Cause for Citation: On or about December 19, 2023, The Bureau conducted an announced compliance inspection pursuant to CEC section 94932.5(a). Bureau staff requested to review documentation supporting all data reported on the Institutions 2020/2021 SPFS. Upon review, Bureau staff found that the Institution's supporting documentation failed to include all the required data points; specifically, the following data points as identified in 5 CCR section 74112 (m)(1) and (m)(3-9).

Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class A" violation. The Institution is issued a fine of \$2,501.00.

Order of Abatement: Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to correct the violation by providing an electronic copy of the template used by the Institution to document supporting data for SPFS, for the Bureau to verify the Institution is collecting the required data points pursuant to 5 CCR section 74112.

In addition, the Institution must submit a statement of attestation they have corrected the violation and will ensure that the supporting data for SPFS is maintained and immediately available during an inspection. The statement of attestation must be dated and signed by an authorized representative of the Institution.

Failure to submit a written request for an informal conference and/or administrative hearing within 30 days from the date of issuance of this citation will forfeit your ability to appeal the citation.

If a hearing is requested, you are not required to comply with this citation until a final order is entered against you.
