Elizabeth Elias issues this modified citation in her official capacity as Deputy Bureau Chief of Enforcement at the Bureau for Private Postsecondary Education, California Department of Consumer Affairs (hereinafter referred to as the "Bureau").

LICENSING HISTORY

1. On or about November 3, 2021, the Bureau renewed an Approval to Operate a Private Postsecondary Institution to Georgiy Kot Academy USA (hereinafter referred to as the "Institution"). This Approval to Operate will expire on or about November 3, 2026, unless renewed.

DISCIPLINE HISTORY

2. The Institution has no prior discipline history.

CITATION JURISDICTION

3. This administrative citation is issued to the Institution pursuant to California Education Code (CEC) section 94936; and Title 5 of the California Code of Regulations (5 CCR) section 75020 et seq. for the violation(s) described below.

CITATION HISTORY

4. On or about November 2, 2023, the Bureau issued Citation No. 2324114. On or about November 13, 2023, the Bureau received an appeal with a request for an informal conference and administrative hearing. The Bureau held the informal conference on December 20, 2023, and the citation was

modified as a result of the informal conference. The Institution requested the Bureau move forward with the appeal for an administrative hearing; however, later requested settlement options in lieu of the administrative hearing. As settlement of the Modified Citation No. 2324114, the Institution agrees to withdraw its request for an Administrative Hearing and agrees to a Settlement of Modified Citation No. 2324114 as follows:

CAUSE FOR CITATION & MODIFIED ASSESMENT OF FINE AND/OR ORDER OF ABATEMENT

5. The Institution is in violation of the following Bureau laws and regulations:

Violation #1:

5 CCR section 74110 – Annual Report in conjunction with CEC section 94934 – Annual Report

Cause for Citation: A review of the Bureau's records confirm the Institution failed to submit all components of the 2021 Annual Report which was due to the Bureau by December 1, 2022. A reminder notice was sent to the Institution on or about the following dates: June 28, 2022, and July 14, 2022, and July 26, 2022.

Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class A" violation. The Institution is issued a fine of \$5,000.00.

Administrative Fine: Pursuant to a Settlement of Modified Citation No. 2324114, the administrative fine is further modified and reduced from \$2,501.00 to \$1,250.50 with a one-year repayment term.

Order of Abatement: Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to submit the 2021 Annual Report pursuant to 5 CCR section 74110 and CEC section 94934.

Order of Abatement: Pursuant to a Settlement of Modified Citation No. 2324114, the Bureau modifies the order of abatement. The Institution shall submit a letter of attestation which states that moving forward it will submit an annual report pursuant to 5 CCR section 74110 and CEC section 94934 as required. The letter or attestation must be signed and dated.

Violation #2:

5 CCR section 71930 (e) – Maintenance Records

Cause for Citation: On or about September 2, 2022, the Bureau conducted an unannounced compliance inspection pursuant to CEC 94932.5 (a). Bureau staff requested access to the school's faculty files, Chief Academic Officer file, and current financial statement. The owner of the Institution was not able to provide Bureau staff with access to the requested files.

Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class B" violation. The Institution is issued a fine of \$1,001.00.

Administrative Fine: Pursuant to a Settlement of Modified Citation No. 2324114, the administrative fine is further modified and reduced from \$1,001.00 to \$500.50 with a one-year repayment term.

Order of Abatement: Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to correct the violation and submit an electronic copy of the faculty files, Chief Academic Officer file, and current financial statement, that includes all the required data pursuant to 5 CCR section 76140 to the Bureau.

In addition, the Institution must submit a statement of attestation they have corrected the violation and will ensure that the faculty files, Chief Academic Officer file and current financial statement are maintained in an electronic format and readily available to a Bureau representative upon request per 5 CCR 76140 (b). The statement of attestation must be dated and signed by an authorized representative of the Institution.

Order of Abatement: Affirmed.

5 CCR section 74112 (m)(1-9) – Uniform Data – Annual Report, Performance Fact Sheet and 5 CCR section 71930 (e) – Maintenance Records

Cause for Citation: On or about September 2, 2022, the Bureau conducted an unannounced compliance inspection pursuant to CEC 94932.5 (a). Bureau staff requested a copy of the substantiating data for the 2019-2020 School Performance Fact Sheet (SPFS) for review. The Institution's Admission Advisor stated that they are unable to produce the required substantiating data for SPFS, as it is located in an electronic database that would require contact with the system developer to construct a report that showed all the required SPFS data.

Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class A" violation. The Institution is issued a fine of \$2,501.00.

Administrative Fine: Pursuant to a Settlement of Modified Citation No. 2324114, the administrative fine is further modified and reduced from \$2,501.00 to \$1,250.50 with a one-year repayment term.

Order of Abatement: Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to correct the violation and submit a copy of the substantiating data for the 2020-2021 SPFS that includes all the required data pursuant to 5 CCR section 74112. In addition, the Institution must submit a statement of attestation they have corrected the violation and will ensure that the substantiating data for SPFS is maintained and immediately available during an inspection. The statement of attestation must be dated and signed by an authorized representative of the Institution.

Order of Abatement: Pursuant to a Settlement of Modified Citation No. 2324114, the Bureau modifies the order of abatement. The Institution shall submit a letter of attestation that moving forward it will maintain all data pursuant to 5 CCR section 74112 (m)(1-9). The letter or attestation must be signed and dated.

5 CCR section 74112 (e)(2) – Uniform Data – Annual Report, Performance Fact Sheet in conjunction with CEC 94912 – Signature, Initials Required

Cause for Citation: On or about September 2, 2022, the Bureau conducted an unannounced compliance inspection pursuant to CEC 94932.5(a). Bureau staff reviewed student files and determined that the files did not contain a current Performance Fact Sheet.

Administrative Fine: Pursuant to 5, CCR 75030, the Bureau has determined this to be a "Class C" violation. The Institution is issued a fine of \$501.00.

Administrative Fine: Pursuant to a Settlement of Modified Citation No. 2324114, the administrative fine is further modified and reduced from \$501.00 to \$250.50 with a one-year repayment term.

Order of Abatement: Pursuant to 5, CCR 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to ensure all student records follow the law pursuant to CCR, Title 5, section 71920. The Institution must submit a statement of attestation they have corrected the violation and ensured that all student records contain an Institution transcript. The statement of attestation must be dated and signed by an authorized representative of the Institution.

Order of Abatement: Affirmed.

Violation #5:

5 CCR section 71920 (b)(5) – Student Records and CCR, 5 CCR section 71930 (a), (e) – Maintenance Records in conjunction with CEC 94900 (b) – Required Student Records

Cause for Citation: On or about September 2, 2023, the Bureau conducted an unannounced compliance inspection pursuant to CEC 94932.5(a). Bureau staff reviewed student files and determined that 5 of the 6 files for graduated students and withdrawn/dropped students, did not contain a transcript. Additionally, the school was not able to provide a transcript for these students.

Administrative Fine: Pursuant to 5, CCR 75030, the Bureau has determined this to be a "Class C" violation. The Institution is issued a fine of \$501.00.

Administrative Fine: Pursuant to a Settlement of Modified Citation No. 2324114, the administrative fine is further modified and reduced from \$501.00 to \$250.50 with a one-year repayment term.

The Bureau orders the Institution to ensure all student records follow the law pursuant to CCR, Title 5, section 71920. The Institution must submit a statement of attestation they have corrected the violation and ensured that all student records contain a transcript. The statement of attestation must be dated and signed by an authorized representative of the Institution.

Order of Abatement: Affirmed.

Violation #6:

CEC section 94935 (b) - Notice to Comply in conjunction with 5 CCR 75010 (h

Cause for Citation: On or about September 2, 2022, Bureau staff issued a Notice to Comply (NTC) for CEC section 94913 (a)(1)(2)(4) Institutional Web Site Requirements violations. The Institution failed to comply with the Notice to Comply by the due date of October 2, 2022.

Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class B" violation. The Institution is issued a fine of \$2,501.00.

Administrative Fine: Pursuant to a Settlement of Modified Citation No. 2324114, the administrative fine is further modified and reduced from \$2,501.00 to \$1,250.50 with a one-year repayment term.

Order of Abatement: Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to correct the violations identified in the Notice to Comply and submit proof of compliance pursuant to CEC section 94935.

Order of Abatement: Affirmed.
