Elizabeth Elias issues this citation in her official capacity as Deputy Bureau Chief of Enforcement at the Bureau for Private Postsecondary Education, California Department of Consumer Affairs (hereinafter referred to as the "Bureau").

LICENSING HISTORY

- On or about October 3, 2014, the Bureau renewed an Approval to Operate an Accredited Private Postsecondary Institution, Institution Code 1920381, to World Mission University, hereinafter referred to as the "Institution." This Approval to Operate expired on or about April 30, 2025, and has not been renewed. An application for renewal of the Institutions Approval to Operate a Private Postsecondary Institution was received on December 26, 2024, and is under review.

CITATION JURISDICTION

- This administrative citation is issued to the Institution pursuant to California Education Code (CEC) section 94936; and Title 5 of the California Code of Regulations (5 CCR) section 75020 et seq. for the violation(s) described below.

CAUSE FOR CITATION & ASSESSMENT OF FINE AND/OR ORDER OF ABATEMENT

- The Institution is in violation of the following Bureau laws and regulations:

Violation #1:

CEC section 94986(b) - Substantive Change for Institutions Approved by Means of Accreditation and CEC section 94894(g) – Substantive Change Defined

Cause for Citation: On or about January 29, 2024, the Bureau conducted an announced compliance inspection pursuant to CEC section 94932.5(a).

Bureau staff discovered that the Institution was advertising and offering its courses in Korean without Bureau approval. The Institution was approved by its accreditor, Association for Biblical Higher Education (ABHE), to teach its courses in Korean, however, the Institution failed to obtain prior authorization from the Bureau.

Following the Announced Inspection, the Institution submitted an Application for Change in Educational Objectives on March 6, 2024, to offer its courses in Korean. This application was approved by the Bureau on April 10, 2024.

The Bureau determined the Institution failed to obtain prior authorization from the Bureau before offering its courses in Korean.

Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a “Class D” violation. The Institution is issued a fine of \$250.00.

Order of Abatement: N/A

COMPLIANCE WITH ORDER OF ABATEMENT

5. The Bureau has not issued an order of abatement.
