1	5 CCR § 71810(b)(10)	<p>Violation Description: Pages 35-36 of the institution's catalog contains a description of its library and learning resources; however, it fails to provide the procedures for student access to those resources.</p> <p>Correction: The institution shall update its catalog to provide the procedures for student access to library resources pursuant to 5 CCR § 71810(b)(10).</p>
2	5 CCR § 71810(b)(5)	<p>Violation Description: The institution's catalog fails to state whether any instruction will occur in a language other than English and, if so, the level of proficiency required and the kind of documentation of proficiency.</p> <p>Correction: The institution shall update its catalog to state whether any instruction will occur in a language other than English, pursuant to 5 CCR § 71810(b)(5).</p>

Violation	Code Section Violated	Description of the violation and required correction.
3	CEC § 94919(d)	<p>Violation Description: The institution's catalog page 88 contains conflicting statements regarding the student's right to cancel the enrollment agreement through attendance of the first class session, or the seventh day after enrollment, whichever is later.</p> <p>Correction: The institution shall correct the conflicting language regarding the cancellation period to comply with CEC § 94919(d).</p>
4	CEC §94909(a)(10)	<p>Violation Description: The institution's catalog fails to provide a statement reporting whether the institution participates in state financial aid.</p> <p>Correction: The institution shall add a statement regarding financial aid pursuant to CEC §94909(a)(10).</p>
5	CEC § 94919(d)	<p>Violation Description: Page 7 of the institution's enrollment agreement contains conflicting statements regarding the student's right to cancel the enrollment agreement through attendance of the first class session, or the seventh day after enrollment, whichever is later.</p> <p>Correction: The institution shall correct the conflicting language regarding the cancellation period to comply with CEC § 94919(d).</p>
6	CEC § 94911(k)	<p>Violation Description: The enrollment agreement fails to contain the following verbatim language:</p> <p>"I understand that this is a legally binding contract. My signature below certifies that I have read, understood, and agreed to my rights and responsibilities, and that the institution's cancellation and refund policies have been clearly explained to me."</p> <p>Correction: The institution shall update the enrollment agreements to include the disclosure referenced above, verbatim pursuant to CEC § 94911(k).</p>


Violation	Code Section Violated	Description of the violation and required correction.
7	CEC § 94916	<p>Violation Description: The enrollment agreement fails to contain the following verbatim notice:</p> <p>“NOTICE” “YOU MAY ASSERT AGAINST THE HOLDER OF THE PROMISSORY NOTE YOU SIGNED IN ORDER TO FINANCE THE COST OF THE EDUCATIONAL PROGRAM ALL THE CLAIMS AND DEFENSES THAT YOU COULD ASSERT AGAINST THIS INSTITUTION, UP TO THE AMOUNT YOU HAVE ALREADY PAID UNDER THE PROMISSORY NOTE.”</p> <p>Correction: The institution shall update its enrollment agreement to include the required notice pursuant to CEC § 94916.</p>

Pursuant to 5 CCR section 75010(d), the Institution may do either of the following:

- (1) Within 30 days from the date of the inspection, sign and return the notice to comply, declaring under penalty of perjury that the violation was corrected and describing how compliance was achieved; or
- (2) Within 30 days from the date of the inspection, file with the Bureau a written notice of disagreement, specifying the minor violations described in the notice to comply with which the person approved to operate the institution disagrees, and appealing it by requesting an informal office conference. If a written notice of disagreement is not timely filed with the Bureau, the right to appeal is deemed to have been waived.

Pursuant to CEC section 94935(h), failure to comply with the notice to comply will result in the Bureau taking appropriate administrative enforcement action.

The Notice to Comply was given to the Institution’s owner, person in control, chief academic officer, chief executive officer, chief operating officer, institution director, or any person delegated by any of the aforementioned persons to facilitate the inspection or accept such notice as set forth below.
