1	CEC § 94909(a)(3)(C)	Violation Description: The institution's 2025 catalog provided the required OSAR language; however, it failed to provide the Bureau's phone number and website address.
		Correction: The institution shall update the required OSAR statement in its 2025 catalog to include the Bureau's phone number and website address, pursuant to CEC § 94909(a)(3)(C).
2	CEC § 94913(a)(1)	<b>Violation Description:</b> The institution's website contains a catalog with violations identified in this NTC.
		Correction: Once the institution's catalog has been updated to remedy the violations, the institution shall update its website to provide the current/updated catalog, pursuant to CEC § 94913(a)(1).
3	5 CCR § 76120(a)	Violation: Page 1 of the institution's enrollment agreement (EA) lists the following STRF fee:
		\$ 2.50 per \$1,000.00 of institutional charges.

Violation	Code Section Violated	Description of the violation and required correction.
		Effective April 1, 2024, the Student Tuition Recovery Fund (STRF) assessment rate changed from two dollars and fifty cents (\$2.50) per one thousand dollars (\$1,000) of institutional charges to zero dollar (\$0.00) per one thousand dollars (\$1,000) of institutional charges. (5, CCR section 76120). Institutions will still be required to complete and submit all STRF Assessment Reporting Forms on a quarterly basis and maintain specified student information for STRF-eligible students.

4	CEC § 94897(I)	Violation: The institution's promotional material contains the following statement: "School Approved by Bureau of Private Post Secondary Education (BPPE)" without clearly stating that approval means compliance with state standards.
		<b>Correction:</b> The institution shall update its promotional material to include the required approval statement, pursuant to CEC § 94897(I).
5	5 CCR § 71920	Violation: The institution failed to provide its website address on its transcript.
		<b>Correction:</b> The institution shall update its transcript to include its website address.

Pursuant to 5 CCR section 75010(d), the Institution may do either of the following:

- (1) Within 30 days from the date of the inspection, sign and return the notice to comply, declaring under penalty of perjury that the violation was corrected and describing how compliance was achieved; or
- (2) Within 30 days from the date of the inspection, file with the Bureau a written notice of disagreement, specifying the minor violations described in the notice to comply with which the person approved to operate the institution disagrees, and appealing it by requesting an informal office conference. If a written notice of disagreement is not timely filed with the Bureau, the right to appeal is deemed to have been waived.

Pursuant to CEC section 94935(h), failure to comply with the notice to comply will result in the Bureau taking appropriate administrative enforcement action.

The Notice to Comply was given to the Institution's owner, person in control, chief academic officer, chief executive officer, chief operating officer, institution director, or any person delegated by any of the aforementioned persons to facilitate the inspection or accept such notice as set forth below.
