5	5 CCR § 71810 (b)(15) in conjunction with CEC § 94897 (s)	<p>Violation Description: On page 59, the institution's 2025 catalog, contains an unenforceable policy regarding withholding transcripts if the student has not fulfilled their financial obligations to the school.</p> <p>Correction: The institution shall remove the non-compliant statement from the 2025 catalog, pursuant to CEC § 94897 (s).</p>
6	CEC § 94911 (f)	<p>Violation Description: The institution's enrollment agreement failed to include a statement specifying that, if the student obtains a loan to pay for an educational program, the student will have the responsibility to repay the full amount of the loan plus interest, less the amount of any refund.</p> <p>Correction: The institution shall update their enrollment agreement to include the above statement, pursuant to CEC § 94911 (f).</p>
7	CEC § 94911 (g)(1)	<p>Violation Description: The institution's enrollment agreement failed to include a statement specifying that, if the student defaults on a federal or state loan, both the following may occur: (1) The federal or state government or a loan guarantee agency may take action against the student, including applying any income tax refund to which the person is entitled to reduce the balance owed on the loan.</p> <p>Correction: The institution shall update their enrollment agreement to include the above statement, pursuant to CEC § 94911 (g)(1).</p>
8	CEC § 94911 (g)(2)	<p>Violation Description: The institution's enrollment agreement failed to include a statement specifying that, if the student defaults on a federal or state loan, both the following may occur: (2) The student may not be eligible for any other federal student financial aid at another institution or other government financial assistance until the loan is repaid.</p> <p>Correction: The institution shall update their enrollment agreement to include the above statement, pursuant to CEC § 94911 (g)(2).</p>

9	CEC § 94909 (a)(8)(B) in conjunction with CEC § 94919 (d)	<p>Violation Description: On page 10, the institution's 2025 catalog contains unenforceable statements regarding non-refundable charges during the cancellation period. The institution is required to refund all 100 percent of the amount paid for institutional charges, less a reasonable deposit or application fee not to exceed two hundred fifty dollars (\$250), if notice of cancellation is made through attendance at the first class session, or the seventh day after enrollment, whichever is later.</p> <p>Correction: The institution shall update their 2025 catalog to include statements describing the requirement above, pursuant to CEC § 94909 (a)(8)(B) in conjunction with CEC § 94919 (d).</p>
10	CEC § 94913 (a)(1)	<p>Violation Description: The institution's website no longer includes a link to the most recent catalog.</p> <p>Correction: The institution shall update their website to include a link to their most recent catalog, pursuant to CEC § 94913 (a)(1).</p>

Pursuant to 5 CCR section 75010(d), the Institution may do either of the following:

- (1) Within 30 days from the date of the inspection, sign and return the notice to comply, declaring under penalty of perjury that the violation was corrected and describing how compliance was achieved; or
- (2) Within 30 days from the date of the inspection, file with the Bureau a written notice of disagreement, specifying the minor violations described in the notice to comply with which the person approved to operate the institution disagrees, and appealing it by requesting an informal office conference. If a written notice of disagreement is not timely filed with the Bureau, the right to appeal is deemed to have been waived.

Pursuant to CEC section 94935(h), failure to comply with the notice to comply will result in the Bureau taking appropriate administrative enforcement action.

The Notice to Comply was given to the Institution's owner, person in control, chief academic officer, chief executive officer, chief operating officer, institution director, or any person delegated by any of the aforementioned persons to facilitate the inspection or accept such notice as set forth below.
