1	5, CCR § 71810 (b)(1)	<p><b>Violation Description:</b> The institution's catalog failed to specifically outline the beginning and ending dates defining the time-period covered. The current dates on the catalog indicate: "February 1, 2025." The dates should be specific and include "Month, Day, Year – Month, Day, Year."</p> <p><b>Correction:</b> The institution's catalog shall contain the above information, pursuant to 5, CCR § 71810 (b)(1).</p>
2	CEC § 94897 (I)	<p><b>Violation Description:</b> On page 1 of the institution's catalog, the institution identifies itself as being approved to operate by the Bureau, however the school failed to state clearly and conspicuously that approval to operate means compliance with state standards as set forth in the California Private Postsecondary Act of 2009.</p> <p><b>Correction:</b> The institution shall update the statement on page 1 of the catalog pursuant to CEC § 94897 (I).</p>
3	CEC § 94909 (a)(3)(D)	<p><b>Violation Description:</b> The institution catalog failed to include the following statement:</p>

6	CEC § 94909 (a)(8)(B) in conjunction with CEC § 94920 (b).	<p><b>Violation Description:</b> Page 113 of the institution’s catalog under “Program Tuition and fees”, contains a list of the charges as Non-Refundable Charges.” These fees with the exception of the Registration fee (not to exceed \$250) are refundable during the cancellation period.</p> <p><b>Correction:</b> The institution shall update the “Tuition and Fees” section on page 113 of the institution’s catalog, pursuant to CEC § 94909 (a)(8)(B) in conjunction with CEC § 94920 (b).</p>

8	5, CCR § 71810 (b)(4)(A)	<p><b>Violation Description:</b> The institution's catalog failed to contain the language proficiency information including level of proficiency required of the students and the kind of documentation of proficiency that will be accepted.</p> <p><b>Correction:</b> The institution shall update the catalog to include the above information, pursuant to 5, CCR § 71810 (b)(4)(A).</p>
9	CEC § 94909 (a)(9)	<p><b>Violation Description:</b> The institution catalog failed to contain the schedule of total charges for a period of attendance and an estimated schedule of total charges for the entire education program.</p> <p><b>Correction:</b> The institution shall update the catalog with the above information, pursuant to CEC § 94909 (a)(9).</p>
10	5, CCR § 71810 (b)(13)(B)	<p><b>Violation Description:</b> The institution's catalog failed to include the availability of housing located reasonably near the institution's facilities and an estimation of the approximate cost or range of cost of the housing.</p> <p><b>Correction:</b> The institution shall update the institution's catalog with the above information, pursuant to 5, CCR § 71810 (b)(13)(B).</p>

13	CEC §94911(e)(1) in conjunction with CEC §94920(b)	<p><b>Violation Description:</b> Page 1 of the institution's enrollment agreement, under fees section mentioned list of the charges as "Non-Refundable Charges" Please be advised these fees with the exception of the Registration fee (not to exceed \$250) are refundable during the cancellation period.</p> <p><b>Correction:</b> The institution shall update the fee section on page 1 of the enrollment agreement pursuant to CEC §94911(e)(1) in conjunction with CEC §94920(b).</p>
14	5, CCR § 71800 (e)(11) in conjunction with 5, CCR § 76120 (a)	<p><b>Violation Description:</b> On page 4 of the institution's enrollment agreement, the institution failed to update the STRF assessment fee which is zero dollars (\$0.00) per one thousand dollars (\$1,000) of institutional charges.</p> <p><b>Correction:</b> The institution shall update the enrollment agreement to reflect the current STRF assessment fee which is zero dollars (\$0.00) per one thousand dollars (\$1,000) of institutional charges, pursuant to 5, CCR § 71800 (e)(11) and 5, CCR § 76120 (a).</p>
15	CEC § 94909 (a)(15).	<p><b>Violation Description:</b> On page 4 of the Institution's enrollment agreement, the institution inserted the institution's name within the section of the disclosure that requires the "name of the educational program" or if institution offers more than one educational program, "the educational program" may be inserted.</p> <p><b>Correction:</b> The institution shall update the disclosure on page 69 of the catalog, pursuant to CEC § 94909 (a)(15).</p>

16	CEC § 94897 (l)(1)(2)	<p><b>Violation Description:</b> The institution's website under "accreditation" states it is approved by Bureau for Private Postsecondary Education (BPPE), however the institution failed to clearly define the term approved.</p> <p><b>Correction:</b> The institution shall update the statement on institution's website to state that approved to operate means compliance with state standards as set forth in the California Private Postsecondary Act of 2009 and Division 7.5 of Title 5 of the California Code of Regulations pursuant to CEC § 94897 (l)(1)(2).</p>
17	CEC § 94913 (a)(1)	<p><b>Violation Description:</b> The institution failed to maintain a website that provide a institution's updated catalog.</p> <p><b>Correction:</b> The institution shall update website, pursuant to CEC § 94913 (a)(1).</p>

Pursuant to 5 CCR section 75010(d), the Institution may do either of the following:

- (1) Within 30 days from the date of the inspection, sign and return the notice to comply, declaring under penalty of perjury that the violation was corrected and describing how compliance was achieved; or
- (2) Within 30 days from the date of the inspection, file with the Bureau a written notice of disagreement, specifying the minor violations described in the notice to comply with which the person approved to operate the institution disagrees, and appealing it by requesting an informal office conference. If a written notice of disagreement is not timely filed with the Bureau, the right to appeal is deemed to have been waived.

**Pursuant to CEC section 94935(h), failure to comply with the notice to comply will result in the Bureau taking appropriate administrative enforcement action.**
