2	CEC § 94909 (a)(8)(B) in conjunction with CEC § 94920 (b)	<p>Violation Description: In the Schedule of Charges section of the institution's 2026 catalog, Equipment is identified as nonrefundable. This is unenforceable during the cancellation period.</p> <p>Correction: The institution shall update their catalog to accurately describe these charges as refundable during the cancellation period, or remove the statement, pursuant to CEC § 94909 (a)(8)(B) in conjunction with CEC § 94920 (b).</p>

3	CCR § 71800 (d)	<p>Violation Description: The institution's 2024 enrollment agreement failed to contain the date by which the student must exercise his or her right to cancel or withdraw, and the refund policy.</p> <p>Correction: The institution shall update their enrollment agreement to include the above statement, pursuant to CCR § 71800 (d).</p>
4	CEC § 94911 (e)(1) in conjunction with CEC § 94920 (b)	<p>Violation Description: In the Itemized Charges By Payment Period section of the institution's enrollment agreement, Equipment is identified as nonrefundable. This is unenforceable during the cancellation period.</p> <p>Correction: The institution shall update their enrollment agreement to accurately describe these charges as refundable during the cancellation period, or remove the statement, pursuant to CEC § 94911 (e)(1) in conjunction with CEC § 94920 (b).</p>
5	CEC § 94913 (a)(5)	<p>Violation Description: The institution's website failed to contain a link to or copy of its current annual report.</p> <p>Correction: The institution shall update its website to include a copy of or link to its current annual report, pursuant to CEC94913 (a)(5).</p>

Pursuant to 5 CCR section 75010(d), the Institution may do either of the following:

- (1) Within 30 days from the date of the inspection, sign and return the notice to comply, declaring under penalty of perjury that the violation was corrected and describing how compliance was achieved; or
- (2) Within 30 days from the date of the inspection, file with the Bureau a written notice of disagreement, specifying the minor violations described in the notice to comply with which the person approved to operate the institution disagrees, and appealing it by requesting an informal office conference. If a written notice of disagreement is not timely filed with the Bureau, the right to appeal is deemed to have been waived.

Pursuant to CEC section 94935(h), failure to comply with the notice to comply will result in the Bureau taking appropriate administrative enforcement action.

The Notice to Comply was given to the Institution's owner, person in control, chief academic officer, chief executive officer, chief operating officer, institution director, or any person delegated by any of the aforementioned persons to facilitate the inspection or accept such notice as set forth below.
