1	5, CCR § 71810 (b)(1)	<b>Violation Description:</b> The institution's catalog failed to contain the specific beginning and ending dates defining the time period covered by the catalog. The dates should be specific and include "Month, Day, Year – Month, Day, Year.  <b>Correction:</b> The institution's catalog shall contain the above information, pursuant to 5, CCR § 71810 (b)(1).
2	CEC § 94897 (l)	<b>Violation Description:</b> On page 3 of the institution's catalog, the institution identifies itself as being approved to operate by the Bureau, however the institution failed to state clearly and conspicuously that approval to operate means compliance with state standards as set forth in the California Private Postsecondary Act of 2009.  <b>Correction:</b> The institution's catalog shall contain the above information, pursuant to CEC § 94897 (l).

However, the statement references the Bureau's old address and old telephone number.</p> <p><b>Correction:</b> The institution shall update the STRF statement in the institution's catalog with the Bureau's current address (1747 North Market Boulevard, Suite 225, Sacramento, California, 95834), and current telephone number (916-574-8900 or (888) 370-7589), pursuant to 5, CCR § 76215 (b).</p>
4	CEC § 94909 (a)(8)(B)	<p><b>Violation Description:</b> Pages 22-23 of the institution's catalog contain cancellation, withdrawal, and refund policies, however failed to include a description of the procedures that a student is required to follow to cancel the enrollment agreement or withdraw from the institution and obtain refund consistent with the requirements.</p> <p><b>Correction:</b> The institution shall include the above information in the institution's catalog, pursuant to CEC § 94909 (a)(8)(B).</p>
5	5, CCR § 71810 (b)(13)(A)	<p><b>Violation Description:</b> The institution's catalog failed to include the housing information for the institute's location in the state of California.</p> <p>(A) Whether the institution has dormitory facilities under its control.</p> <p><b>Correction:</b> The institution shall update the catalog to include the above information, pursuant to 5, CCR § 71810 (b)(13)(A).</p>
6	5, CCR § 71810 (b)(15)	<p><b>Violation Description:</b> The institution's catalog failed to include policies on the retention of student records.</p> <p><b>Correction:</b> The institution shall include the above information in the institution's catalog, pursuant to 5, CCR § 71810 (b)(15).</p>

8	5, CCR § 71800 (b)	<p><b>Violation Description:</b> The institution's enrollment agreement failed to include the period covered by the enrollment agreement.</p> <p><b>Correction:</b> The institution shall update the enrollment agreement to include the above information, pursuant to 5, CCR § 71800 (b).</p>
9	5, CCR § 71800 (c)	<p><b>Violation Description:</b> The institution's enrollment agreement failed to include the program start date and schedule completion date.</p> <p><b>Correction:</b> The institution shall update the enrollment agreement to include the above information, pursuant to 5, CCR § 71800 (c).</p>

12	CEC § 94911 (e)(3)	<p><b>Violation Description:</b> The enrollment agreement failed to include a description of the procedures that a student is required to follow to cancel the enrollment agreement or withdraw from the institution and obtain a refund.</p> <p><b>Correction:</b> The institution shall update the enrollment agreement to include the above information, pursuant to CEC § 94911 (e)(3).</p>
13	CEC § 94911 (i)(2)	<p><b>Violation Description:</b> The page 7 of the institution's enrollment agreement contains the specific required statement, however failed to include a line for the student to initial certify documents were received.</p> <p><b>Correction:</b> The institution shall update the enrollment agreement to include the above information CEC § 94911 (i)(2).</p>
14	CEC § 94902 (a)	<p><b>Violation Description:</b> The institution's enrollment agreement failed to include signature lines for the student and an authorized employee of the institution.</p> <p><b>Correction:</b> The institution shall update the enrollment agreement to include the above information, pursuant to CEC § 94902 (a)</p>

15	CEC § 94913 (a)(1)	<p><b>Violation Description:</b> The institution's website failed to update a link to the institution's current catalog.</p> <p><b>Correction:</b> The institution shall update the institution's website, pursuant to CEC § 94913 (a)(1).</p>
16	CEC § 94913 (a)(2)	<p><b>Violation Description:</b> The institution's website failed to provide a School Performance Fact Sheet for year 2023/2024 for each educational program offered by the institution.</p> <p><b>Correction:</b> The institution shall update the institution's website, pursuant to CEC § 94913 (a)(2).</p>
17	CEC §94897 (l)	<p><b>Violation Description:</b> On the institution's website (<a href="https://www.hult.edu/campuses/san-francisco/">https://www.hult.edu/campuses/san-francisco/</a>) the institution website states institution is approved to operate in San Francisco by the California Bureau for Private Postsecondary Education, however the institution failed to state clearly and conspicuously that approval to operate means compliance with state standards as set forth in the California Private Postsecondary Act of 2009.</p> <p><b>Correction:</b> The institution shall update the institution's website, pursuant to CEC §94897 (l).</p>

Pursuant to 5 CCR section 75010(d), the Institution may do either of the following:

- (1) Within 30 days from the date of the inspection, sign and return the notice to comply, declaring under penalty of perjury that the violation was corrected and describing how compliance was achieved; or
- (2) Within 30 days from the date of the inspection, file with the Bureau a written notice of disagreement, specifying the minor violations described in the notice to comply with which the person approved to operate the institution disagrees, and appealing it by requesting an informal office conference. If a written notice of disagreement is not timely filed with the Bureau, the right to appeal is deemed to have been waived.

**Pursuant to CEC section 94935(h), failure to comply with the notice to comply will result in the Bureau taking appropriate administrative enforcement action.**
