**WITHDRAWAL OF
STATEMENT OF ISSUES**

Respondent

On January 9, 2026, The Learning Source (Respondent) withdrew its appeal and request for hearing of the denial of its application for Renewal of Approval to Operate and Offer Educational Programs for Non-Accredited Institutions by the Bureau for Private Postsecondary Education (Bureau) and of the denial of its Application for Change in Educational Objectives. Accordingly, Statement of Issues No. BPPE23-0713 and BPPE24-0259, filed against Respondent, are withdrawn without prejudice and the denial of these applications are affirmed effective March 31, 2026.

Respondent shall comply with California Education Code section 94927 to teach-out currently enrolled students through March 31, 2026.

1 If Respondent is unable to complete the teach-out by that date, they must provide refunds in
2 accordance with California Education Code section 94927.

3 Respondent shall lose all rights and privileges as an Approved Institution in California as of
4 March 31, 2026.

5 Respondent may not apply for a new Approval to Operate for one (1) year from March 31,
6 2026. Should Respondent file an application for Approval to Operate during the 1-year waiting
7 period, the Bureau shall deny the application or petition.
