Violation	Code Section Violated	Description of the violation and required correction.
1	CEC § 94909 (a)(9) in conjunction with 5 CCR § 76120 (a)	Violation Description: The institution's 2026 catalog incorrectly identifies the STRF fee on page 24, as " \$2.50 per \$1,000 of institutional charges". The current fee is listed as " \$0.00 per \$1,000 of institutional charge." Correction: The institution shall update its 2026 catalog, to include the current STRF value pursuant to CEC § 94909 (a)(9) in conjunction with 5 CCR § 76120 (a).
2	CEC § 94909 (a)(9) in conjunction with CEC § 94920 (b)	Violation Description: The cancellation statement on page 24 of the institution's 2026 catalog, "Cancelation period is the first day of class session.", is not compliant with CEC § 94920 (b). CEC § 94920 (b) specifies the cancellation window as through attendance at the first class session, or the seventh day after enrollment, whichever is later . Correction: The institution shall update its 2026 catalog to include the full cancellation period pursuant to CEC § 94909 (a)(9) and CEC § 94920 (b).

3	CEC § 94913 (a)(1)	<p>Violation Description: The homepage of the institution's website failed to post the most current catalog.</p> <p>Correction: Once the institution's catalog has been updated to remedy the violations, the institution shall update its website to provide the current/updated school catalog pursuant to CEC § 94913 (a)(1).</p>
4	CEC § 94913 (a)(2)	<p>Violation Description: The institution failed to post on its website clear and conspicuous links to the school's 2023/2024 School Performance Fact Sheets for all programs offered by the school.</p> <p>Correction: The institution shall update its website to include a clear and conspicuous link to the school's 2023/2024 School Performance Fact Sheets for all programs offered by the school pursuant to CEC § 94913 (a)(2).</p>
5	5 CCR § 76140	<p>Violation Description: The institution's 2025 2nd and 3rd Quarter STRF supporting documentation failed to contain record (1) Student identification number, (3) Email address, (4) Local or mailing address, (5) Address at the time of enrollment, (7) Date enrollment agreement signed, (9) Amount of STRF assessment collected, (10) Quarter in which the STRF assessment was remitted to the Bureau, (12) Total institutional charges charged, and (13) Total institutional charges paid.</p> <p>Correction: The institution shall update the institution's 2025 2nd and 3rd Quarter STRF supporting documentation, pursuant 5 CCR § 76140 (a).</p>

Pursuant to 5 CCR section 75010(d), the Institution may do either of the following:

- (1) Within 30 days from the date of the inspection, sign and return the notice to comply, declaring under penalty of perjury that the violation was corrected and describing how compliance was achieved; or
- (2) Within 30 days from the date of the inspection, file with the Bureau a written notice of disagreement, specifying the minor violations described in the notice to comply with which the person approved to operate the institution disagrees, and appealing it by requesting an informal office conference. If a written notice of disagreement is not timely filed with the Bureau, the right to appeal is deemed to have been waived.

Pursuant to CEC section 94935(h), failure to comply with the notice to comply will result in the Bureau taking appropriate administrative enforcement action.

The Notice to Comply was given to the Institution's owner, person in control, chief academic officer, chief executive officer, chief operating officer, institution director, or any person delegated by any of the aforementioned persons to facilitate the inspection or accept such notice as set forth below.
