On or about July 30, 2024, the Bureau renewed an Approval to Operate an Accredited Private Postsecondary Institution, Institution Code 3804461, to Acupuncture & Integrative Medicine College-Berkeley (formerly known as Acupuncture and Integrative Medicine College-Berkeley and Meiji College of Oriental Medicine) hereinafter referred to as the “Institution.” This Approval to Operate will expire on or about August 31, 2028, and has not been renewed.
