1	CEC § 94909 (a)(2)	<b>Violation Description:</b> The institution’s catalog failed to include an accurate statement regarding its approval to operate pursuant to CEC § 94909 (a)(2). (the statement indicates the institution is “pending approval”).  <b>Correction:</b> The institution shall update the catalog to correct the statement by removing “pending approval” and inserting “approved”.

5	5 CCR § 76215 (b)	<p><b>Violation Description:</b> The institution’s catalog failed to include the most recent version of the STRF disclosure pursuant to 5 CCR § 76215 (b).</p> <p><b>Correction:</b> The institution shall update the catalog with the most recent version of the STRF disclosure which includes the bureau’s current address and phone number.</p>
6	CEC § 94909 (a)(7)	<p><b>Violation Description:</b> The institution’s catalog failed to include the names and specific qualifications of the faculty pursuant to CEC § 94909 (a)(7).</p> <p><b>Correction:</b> The institution shall update the catalog with the names and qualifications of the faculty members currently teaching.</p>
7	CEC § 94913 (a)(1) In conjunction with 5 CCR § 74117	<p><b>Violation Description:</b> The institution’s website failed to contain a current catalog pursuant to CEC § 94913 (a)(1) In conjunction with 5 CCR § 74117 (the posted catalog expired December 31, 2025).</p> <p><b>Correction:</b> The institution shall post an updated catalog to the website after the catalog violations noted in this NTC have been corrected.</p>

8	CEC § 94913 (a)(2) In conjunction with 5 CCR § 74117	<p><b>Violation Description:</b> The institution’s website failed to contain a current (2023/2024) School Performance Fact Sheet for each educational program offered by the institution pursuant to CEC § 94913 (a)(2) In conjunction with 5 CCR § 74117.</p> <p><b>Correction:</b> The institution shall post the current (2023/2024) SPFS for each program offered to their website.</p>
9	CEC § 94913 (a)(4) In conjunction with 5 CCR § 74117	<p><b>Violation Description:</b> The institution’s website failed to contain link to the bureau’s website pursuant to CEC § 94913 (a)(4) In conjunction with 5 CCR § 74117.</p> <p><b>Correction:</b> The institution shall update their website to include a link to the bureau’s website.</p>
10	CEC § 94911 (e)(12)	<p><b>Violation Description:</b> The institution’s enrollment agreement failed to include the itemization of charges paid to an entity other than the institution that is specifically required for participation in the educational program pursuant to CEC § 94911 (e)(12.)</p> <p><b>Correction:</b> The institution shall include a breakdown of the additional fees as noted in the enrollment agreement.</p>
11	5 CCR § 76215 (b)	<p><b>Violation Description:</b> The institution’s enrollment agreement failed to include the most recent version of the STRF disclosure pursuant to 5 CCR § 76215 (b).</p> <p><b>Correction:</b> The institution shall update the enrollment agreement with the most recent version of the STRF disclosure which includes the bureau’s current address and phone number.</p>

Pursuant to 5 CCR section 75010(d), the Institution may do either of the following:

- (1) Within 30 days from the date of the inspection, sign and return the notice to comply, declaring under penalty of perjury that the violation was corrected and describing how compliance was achieved; or
- (2) Within 30 days from the date of the inspection, file with the Bureau a written notice of disagreement, specifying the minor violations described in the notice to comply with which the person approved to operate the institution disagrees, and appealing it by requesting an

informal office conference. If a written notice of disagreement is not timely filed with the Bureau, the right to appeal is deemed to have been waived.

**Pursuant to CEC section 94935(h), failure to comply with the notice to comply will result in the Bureau taking appropriate administrative enforcement action.**

The Notice to Comply was given to the Institution's owner, person in control, chief academic officer, chief executive officer, chief operating officer, institution director, or any person delegated by any of the aforementioned persons to facilitate the inspection or accept such notice as set forth below.
