1	CEC § 94909(a)(8)(A)	<p>Violation Description: The institution’s catalog fails to contain the information regarding Admissions policies, including the institution’s policies regarding the acceptance of credits earned at other institutions or through challenge examinations and achievement tests, and a list describing any transfer or articulation agreements between the institution and any other college or university that provides for the transfer of credits earned in the program of instruction. <u>If the institution has not entered into an articulation or transfer agreement with any other college or university, the institution shall disclose that fact.</u></p> <p>Correction: The institution shall update the catalog to include all required information pursuant to 94909(a)(8)(A)</p>

2	CEC § 94909(a)(9)	<p>Violation Description: The institution’s catalog fails to contain the schedule of total charges for a period of attendance and an estimated schedule of total charges for the entire educational program.</p> <p>Correction: The institution shall include in the catalog a schedule of total charges for a period of attendance and an estimated schedule of total charges for the entire educational program pursuant to CEC § 94909(a)(9).</p>
3	CEC § 94909(a)(8)(A)	<p>Violation Description: The institution’s catalog page 4 fails to contain admission policies that are consistent with what is listed on the enrollment agreement.</p> <p>Correction: The institution shall update the admission policies to be consistent in the catalog and enrollment agreement.</p>
4	CEC §94911(e)(1)	<p>Violation Description: The institution’s enrollment page 8 contains a noncompliant statement regarding the students’ right to cancel.</p> <p>A disclosure with a clear and conspicuous caption, “STUDENT’S RIGHT TO CANCEL,” under which it is explained that the student has the right to cancel the enrollment agreement and obtain a refund of charges paid through attendance at the first class session, or the seventh day after enrollment, whichever is later.</p> <p>Correction: The institution shall update the catalog to include only the required disclosure pursuant CEC §94911(e)(1).</p>
5	5,CCR §71800(b)	<p>Violation Description: The institution’s enrollment agreement fails to identify the Period covered by the enrollment agreement.</p> <p>Correction: The institution shall update the enrollment agreement to include the required information pursuant to 5,CCR §71800(b).</p>

6	CEC § 94911(b)	<p>Violation Description: The institution’s enrollment agreement fails to contain schedule of total charges, including a list of any charges that are nonrefundable and the student’s obligations to the Student Tuition Recovery Fund, clearly identified as nonrefundable charges.</p> <p>Correction: The institution shall update the enrollment agreement to include listing the Student Tuition Recovery Fund as nonrefundable.</p>
7	CEC § 94911(d)	<p>Violation Description: The institution’s enrollment agreement fails to contain A clear and conspicuous statement that the enrollment agreement is legally binding when signed by the student and accepted by the institution.</p> <p>Correction: The institution shall update the enrollment agreement to include the required statement pursuant to CEC § 94911(d).</p>
8	CEC § 94913(a)(1)&(2)	<p>Violation Description: The institution’s website fails to contain the current catalog and a School Performance Fact Sheet for each educational program offered by the institution.</p> <p>Correction: The institution shall update the website to include all required items pursuant to CEC § 94913(a)(1)&(2)</p>

Pursuant to 5 CCR section 75010(d), the Institution may do either of the following:

- (1) Within 30 days from the date of the inspection, sign and return the notice to comply, declaring under penalty of perjury that the violation was corrected and describing how compliance was achieved; or
- (2) Within 30 days from the date of the inspection, file with the Bureau a written notice of disagreement, specifying the minor violations described in the notice to comply with which the person approved to operate the institution disagrees, and appealing it by requesting an informal office conference. If a written notice of disagreement is not timely filed with the Bureau, the right to appeal is deemed to have been waived.

Pursuant to CEC section 94935(h), failure to comply with the notice to comply will result in the Bureau taking appropriate administrative enforcement action.

The Notice to Comply was given to the Institution’s owner, person in control, chief academic officer, chief executive officer, chief operating officer, institution director, or any person delegated by any of the aforementioned persons to facilitate the inspection or accept such notice as set forth below.
