Elizabeth Elias issues this modified citation in her official capacity as Deputy Bureau Chief of Enforcement at the Bureau for Private Postsecondary Education, California Department of Consumer Affairs (hereinafter referred to as the "Bureau").

LICENSING HISTORY

- On or about November 7, 2024, the Bureau renewed an Approval to Operate a Private Postsecondary Institution, Institution Code 88083975 to Healthcare Academy of California, hereinafter referred to as the "Institution". This Approval to Operate will expire on or about November 7, 2029, unless renewed.

DISCIPLINE HISTORY

CITATION JURISDICTION

- This administrative citation is issued to the Institution pursuant to California Education Code (CEC) section 94936; and Title 5 of the California Code of Regulations (5 CCR) section 75020 et seq. for the violation(s) described below.

CITATION HISTORY

- On or about February 23, 2026, the Bureau issued Citation No. 25260015. On or about March 19, 2026, the Bureau received an appeal with a

request for an informal conference. The informal conference was held on April 27, 2026. New substantive information was presented during the informal conference; therefore, the Bureau modifies the citation as follows:

**CAUSE FOR CITATION &
MODIFIED ASSESSMENT OF FINE AND/OR ORDER OF ABATEMENT**

5. The Institution is in violation of the following Bureau laws and regulations:

Violation #1:

5 CCR section 71920(b)(1)(A) – Student Records, 5 CCR section 71930(e) – Maintenance of Records and CEC section 94897(u) - Prohibited Business Practices

Cause for Citation: On or about September 16, 2024, the Bureau conducted an unannounced compliance inspection pursuant to CEC section 94932.5(a). Bureau staff reviewed seven student files and found that all seven files reviewed failed to contain a verification of high school diploma or its equivalent establishing the student's ability to do college level work. Further, Bureau staff determined that the Institution failed to adhere to its own admissions policy requiring proof of either a high school diploma or its equivalent to demonstrate the student's qualifications for admission.

Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class A" violation. The Institution is issued a fine of \$2,501.00.

Administrative Fine: Modified. The Bureau modifies the administrative fine from \$2,501.00 to \$1,500.00. The Bureau modifies the violation from a "Class A" violation to "Class B" violation.

Order of Abatement: Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to submit a statement of attestation that they have corrected the violations and will ensure that the institution adheres to its stated policies pursuant to CEC section 94897(u) and that they will maintain required student records pursuant to 5 CCR sections 71920 and 71930. The statement of attestation must be signed and dated by an authorized representative of the Institution.

Order of Abatement: Affirmed. The Order of Abatement has been satisfied.

Violation #2:

CEC section 94900(b) – Required Student Records, 5 CCR section 71920(b)(5) – Student Records and 5 CCR section 71930(a) and (e) – Maintenance of Records

Cause for Citation: On or about September 16, 2024, the Bureau conducted an unannounced compliance inspection pursuant to CEC section 94932.5(a). Bureau staff reviewed seven student files and found that three graduate student files reviewed failed to contain a transcript of courses, the units on which the certificate was based, or the grades earned by the students. Additionally, the Institution’s owner confirmed the Institution only provides a completion certificate, and a transcript is not provided.

Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a “Class A” violation. The Institution is issued a fine of \$5,000.00.

Administrative Fine: Modified. (description of modification) The Bureau modifies the administrative fine from \$5,000.00 to \$2,501.00. The violation remains a “Class A” violation.

Order of Abatement: Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to submit a statement of attestation that they will maintain required student records pursuant to CEC section 94900 and 5 CCR sections 71920 and 71930. The statement of attestation must be signed and dated by an authorized representative of the Institution.

Order of Abatement: Affirmed. The Order of Abatement has been satisfied.

Violation #3:

CEC section 94902(a) – General Enrollment Requirements, 5 CCR section 71800(c) – Enrollment Agreement, and 5 CCR section 71920(b)(3) – Student Records

Cause for Citation: On or about September 16, 2024, the Bureau conducted an unannounced compliance inspection pursuant to CEC section 94932.5(a). Bureau staff reviewed seven student files and found that four of the student files reviewed contained an enrollment agreement that was not fully executed. The enrollment agreement did not contain a signature of an authorized employee of the institution, a general enrollment requirement. Additionally, the Bureau found one graduate student file contained an enrollment agreement that was signed by a student after the program start date.

Furthermore, the Bureau found that three of the student files reviewed contained enrollment agreements that were missing the required program start date and scheduled completion date pursuant to 5 CCR section 71800; specifically, subsection (c).

Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class A" violation. The Institution is issued a fine of \$5,000.00.

Administrative Fine: Modified. The Bureau modifies the administrative fine from \$5,000.00 to \$1,501.00. The Bureau modifies the violation from a "Class A" violation to "Class B" violation.

Order of Abatement: Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to ensure all student records follow the law pursuant to CEC section 94902 and 5 CCR sections 71800 and 71920. The Institution must submit a statement of attestation that they have corrected the violation and will ensure that all student records contain signed enrollment agreements and will include all required data pursuant to 5 CCR section 71800. The statement of attestation must be signed and dated by an authorized representative of the Institution.

Order of Abatement: Affirmed. The Order of Abatement has been satisfied.

Violation #4:

5 CCR section 71920(b)(3) – Student Records, 5 CCR section 71930(a) and (e) – Maintenance of Records and CEC section 94900.5(c) – Required Institutional Records

Cause for Citation: On or about September 16, 2024, the Bureau conducted an unannounced compliance inspection pursuant to CEC section 94932.5(a). Bureau staff reviewed seven student files and determined that all student files reviewed failed to contain a School Performance Fact Sheet (SPFS) which is a required institutional record.

Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class A" violation. The Institution is issued a fine of \$2,501.00.

Administrative Fine: Modified. The Bureau modifies the administrative fine from \$2,501.00 to \$1,001.00. The Bureau modifies the violation from a "Class A" violation to "Class B" violation.

Order of Abatement: Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to ensure all student records are maintained pursuant to 5 CCR sections 71920 and 71930 and CEC section 94900.5. The Institution must submit a statement of attestation that they have corrected the violation and will ensure that all student records contain signed and dated SPFS prior to the execution of the enrollment agreement. The statement of attestation must be dated and signed by an authorized representative of the Institution.

Order of Abatement: Affirmed. The Order of Abatement has been satisfied.

Violation #5:

CEC section 94900 - Required Student Records and 5 CCR section 71920 Student Records and 5 CCR section 71930(e) – Maintenance of Records

Cause for Citation: On or about September 16, 2024, the Bureau conducted an unannounced compliance inspection pursuant to CEC section 94932.5(a). Bureau staff requested to review nine student files; however, the Institution was only able to provide 7 student files for review. Therefore, the Institution failed to make all records immediately available for inspection.

Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class B" violation. The Institution is issued a fine of \$1,001.00.

Administrative Fine: Modified. The Bureau modifies the administrative fine from \$1,001.00 to \$501.00. The Bureau modifies the violation from a "Class B" violation to "Class C" violation.

Order of Abatement: Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to submit a statement of attestation that they will maintain required student records pursuant to CEC section 94900 and 5 CCR sections 71920 and 71930. The statement of attestation must be signed and dated by an authorized representative of the Institution.

Order of Abatement: Affirmed. The Order of Abatement has been satisfied.

Violation #6:

5 CCR section 71920(b)(10) – Student Records and 5 CCR section 71930(e) – Maintenance of Records

Cause for Citation: On or about September 16, 2024, the Bureau conducted an unannounced compliance inspection pursuant to CEC section 94932.5(a). Bureau staff reviewed seven student files and found that two withdrawn student files reviewed failed to include a refund document consistent with 5 CCR section 71920(b)(10).

Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class B" violation. The Institution is issued a fine of \$1,001.00.

Administrative Fine: Affirmed.

Order of Abatement: Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to submit a statement of attestation that they will maintain required student records pursuant to 5 CCR sections 71920 and 71930. The statement of attestation must be signed and dated by an authorized representative of the Institution.

Order of Abatement: Affirmed. The Order of Abatement has been satisfied.

Violation #7:

5 CCR section 71930(d) – Maintenance of Records

Cause for Citation: On or about September 16, 2024, the Bureau conducted an unannounced compliance inspection pursuant to CEC section 94932.5(a). Bureau staff requested student files and found that the Institution failed to maintain a second set of all students' academic and financial records at a secondary site or in a secure manner away from damage or loss.

Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class B" violation. The Institution is issued a fine of \$2,500.00.

Administrative Fine: Modified. The Bureau modifies the administrative fine from \$2,500.00 to \$1,001.00. The violation remains a "Class B" violation.

Order of Abatement: Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to submit a statement of attestation that they will maintain a second set of student academic records and financials records at a secondary location or in a secure manner away from damage or loss pursuant to 5 CCR section 71930. The statement of attestation must be signed and dated by an authorized representative of the Institution.

Order of Abatement: Affirmed. The Order of Abatement has been satisfied.

Violation #8:

5 CCR section 71600(a) – Application for Significant Change in Method of Instructional Delivery or Change in Distance Education Learning Management System, CEC section 94893 - Authorization Required for Substantive Change CEC section and 94897(q) – Prohibited Business Practices

Cause for Citation: On or about September 16, 2024, the Bureau conducted an unannounced compliance inspection pursuant to CEC section 94932.5(a). Upon review of the Institution's website, Bureau staff found that the Institution is offering unapproved online programs for Pharmacy Technician, Veterinary Assistant, Healthcare IT Professional program, Physical Therapy Aid, Dental Assistant, Medical Assistant and Medical Billing and Coding, without prior Bureau authorization.

Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a “Class A” violation. The Institution is issued a fine of \$5,000.00.

Administrative Fine: Modified. The Bureau modifies the administrative fine from \$5,000.00 to \$2,501.00. The violation remains a “Class A” violation.

Order of Abatement: Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to cease advertising and offering unapproved programs. The Institution must submit a statement of attestation that they have ceased offering the unapproved courses and will obtain prior Bureau approval before making a substantive change to its approval to operate. The statement of attestation must be signed and dated by an authorized representative of the Institution.

Order of Abatement: Affirmed. The Order of Abatement has been satisfied.

Violation #9:

5 CCR section 76140(a)(5-6)(12-13) - Record-Keeping Requirements and 5 CCR section 71930(e) – Maintenance of Records

Cause for Citation: On or about September 16, 2024, the Bureau conducted an unannounced compliance inspection pursuant to CEC section 94932.5(a). Bureau staff request to review the Institution’s Student Tuition Recovery Fund (STRF) substantiating data for the 1st and 2nd quarter reporting periods of 2024. Bureau staff found that the Institution failed to collect all the required data points pursuant to 5 CCR section 76140. Specifically, 76140 subsections (a)(5-6) and (a)(12-13). The Institution was unable to provide the data by the conclusion of the inspection.

Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a “Class B” violation. The Institution is issued a fine of \$1,001.00.

Administrative Fine: Modified. The Bureau modifies the administrative fine from \$1,001.00 to \$501.00. The Bureau modifies the violation from a “Class B” violation to “Class C” violation.

Order of Abatement: Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to correct the violation by providing an electronic copy of the template used by the Institution to document its STRF substantiating documentation, for the Bureau to verify the Institution is collecting the required data points pursuant to 5 CCR section 76140.

In addition, the Institution must submit a statement of attestation they have corrected the violation and will ensure that the substantiating data for STRF is maintained in an electronic format and readily available to a Bureau representative upon request per 5 CCR sections 76140 and 71930. The statement of attestation must be dated and signed by an authorized representative of the Institution.

Order of Abatement: Affirmed.

Violation #10:

5 CCR section 74112(m)(1-9) – Uniform Data – Annual Report, Performance Fact Sheet, 5 CCR section 71930(e) – Maintenance of Records, and CEC section 94929.7(a) – Documentation of Performance Data

Cause for Citation: On or about September 16, 2024, the Bureau conducted an unannounced compliance inspection pursuant to CEC section 94932.5(a). Bureau staff requested to review documentation supporting all data reported on the Institution's 2021/2022 School Performance Fact Sheet (SPFS). The Institution provided Bureau staff with various spreadsheets. Upon review, Bureau staff found that the Institution failed to collect and/or maintain all of the required data points to substantiate the Institutions 2021/2022 SPFS pursuant to 5 CCR section 74112.

Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class A" violation. The Institution is issued a fine of \$2,501.00.

Administrative Fine: Modified. The Bureau modifies the administrative fine from \$2,501.00 to \$1,500.00. The Bureau modifies the violation from a "Class A" violation to "Class B" violation.

Order of Abatement: Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to correct the violation by providing an electronic copy of the template used by the Institution to document

supporting data for SPFS, for the Bureau to verify the Institution is collecting the required data points pursuant to 5 CCR section 74112.

In addition, the Institution must submit a statement of attestation they have corrected the violation and will ensure that the supporting data for SPFS is maintained. The statement of attestation must be dated and signed by an authorized representative of the Institution.

Order of Abatement: Affirmed.

COMPLIANCE WITH ORDER OF ABATEMENT

6. In accordance with the provisions of CEC section 94936 and 5 CCR sections 75020 and 75040, the Bureau issues the order(s) of abatement described above. Evidence of compliance with the order of abatement must be submitted to the Bureau within 30 days from the date of issuance of this modified citation. NOTICE OF APPEAL RIGHTS

8. Pursuant to 5 CCR section 75040(d), the modified decision is considered final, unless a request for a hearing was filed timely.

If the Institution requested a hearing and no longer chooses to proceed with the hearing, the Institution may request to withdraw the request for a hearing.

COMPLIANCE WITH FINE AND/OR ORDER OR ABATEMENT DISCLOSURE

9. Pursuant to 5 CCR section 75050, payment of the fine and/or compliance with any order of abatement does not constitute an admission of the violation charged and shall be represented as satisfactory resolution of the matter for the purposes of public disclosure.

Pursuant to 5 CCR section 75050, failure to comply with this citation order, its order of abatement, and/or administrative fine by the required due date is grounds for denial or discipline of an approval to operate. Where a citation is not contested and fine is not paid, the full amount of the assessed fine shall be added to the fee for renewal of the approval to operate. An approval to operate shall not be renewed without payment of the renewal fee and fine. The Bureau may also enforce the administrative fine as if it were a money judgment pursuant to CEC section 94936.
