5	CEC § 94920 (b)	<p><b>Violation Description:</b> In the Tuition and Refund Policy section of the institution's 2026 catalog, the table misidentifies both columns for Kit and Book as NR (nonrefundable). This is misleading and unenforceable during the cancellation period.</p> <p><b>Correction:</b> The institution shall update Tuition and Refund Policy table to identify these items as refundable during the cancellation period or remove the NR designation, pursuant to CEC § 94920 (b).</p>

Pursuant to 5 CCR section 75010(d), the Institution may do either of the following:

- (1) Within 30 days from the date of the inspection, sign and return the notice to comply, declaring under penalty of perjury that the violation was corrected and describing how compliance was achieved; or
- (2) Within 30 days from the date of the inspection, file with the Bureau a written notice of disagreement, specifying the minor violations described in the notice to comply with which the person approved to operate the institution disagrees, and appealing it by requesting an informal office conference. If a written notice of disagreement is not timely filed with the Bureau, the right to appeal is deemed to have been waived.

**Pursuant to CEC section 94935(h), failure to comply with the notice to comply will result in the Bureau taking appropriate administrative enforcement action.**
