Elizabeth Elias issues this citation in her official capacity as Deputy Bureau Chief of Enforcement at the Bureau for Private Postsecondary Education, California Department of Consumer Affairs (hereinafter referred to as the "Bureau").

### LICENSING HISTORY

1. On or about October 15, 2024, the Bureau renewed an Approval to Operate an Accredited Private Postsecondary Institution, Institution Code 1903571, to Dongguk University Los Angeles (formerly known as Dongguk-Royal University), hereinafter referred to as the "Institution." This Approval to Operate will expire on or about August 31, 2031, unless renewed.

### DISCIPLINE HISTORY

2. The Institution has the following discipline history:

### CITATION JURISDICTION

3. This administrative citation is issued to the Institution pursuant to California Education Code (CEC) section 94936; and Title 5 of the California Code of Regulations (5 CCR) section 75020 et seq. for the violation(s) described below.

### CAUSE FOR CITATION & ASSESSMENT OF FINE AND/OR ORDER OF ABATEMENT

4. The Institution is in violation of the following Bureau laws and regulations:

**Violation #1:****5 CCR section 74112 (m)(1-9) – Uniform Data – Annual Report, Performance Fact Sheet and 5 CCR section 71930 (e) – Maintenance of Records**

**Cause for Citation:** On or about September 17, 2025, the Bureau conducted an unannounced compliance inspection pursuant to CEC section 94932.5(a). Bureau staff requested documentation supporting all data reported on the Institutions 2022/2023 School Performance Fact Sheet (SPFS). Upon review, Bureau staff found that the Institution failed to collect and/or maintain all of the required data points for 2022 and 2023, pursuant to 5 CCR section 74112, specifically subsections (m)(1-6), and (m)(8-9).

**Administrative Fine:** Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class A" violation. The Institution is issued a fine of \$3,500.00.

**Order of Abatement:** Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to correct the violation by providing an electronic copy of the template used by the Institution to document supporting data for SPFS, for the Bureau to verify the Institution is collecting the required data points pursuant to 5 CCR section 74112.

In addition, the Institution must submit a statement of attestation they have corrected the violation and will ensure that the supporting data for SPFS is maintained and immediately available during an inspection. The statement of attestation must be dated and signed by an authorized representative of the Institution.

**Violation #2:****5 CCR section 71920(b)(9) – Student Records, and 5 CCR section 71930(e) – Maintenance of Records**

**Cause for Citation:** On or about September 17, 2025, the Bureau conducted an unannounced compliance inspection pursuant to CEC section 94932.5(a). Bureau staff reviewed six student files and found that all of the student files reviewed failed to include a document showing the total amount of money received from or on behalf of the student and the date or dates on which the money was received.

**Administrative Fine:** Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class B" violation. The Institution is issued a fine of \$1,001.00.

**Order of Abatement:** Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to submit a statement of attestation that they will maintain required student records pursuant to 5 CCR section 71920 and 5 CCR section 71930. The statement of attestation must be signed and dated by an authorized representative of the Institution.

**Violation #3:**

**CEC section 94900(b) – Required Student Records, 5 CCR section 71920 Student Records and 5 CCR section 71930(e) – Maintenance of Records**

**Cause for Citation:** On or about September 17, 2025, the Bureau conducted an unannounced compliance inspection pursuant to CEC section 94932.5(a). Bureau staff reviewed six student files and found that three graduated student files reviewed failed to contain a transcript of courses and units on which the certificate or degree was based, the grades earned by the student or the degree or certificate that was granted and the date on which that degree or certificate was granted.

**Administrative Fine:** Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class A" violation. The Institution is issued a fine of \$2,501.00.

**Order of Abatement:** Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to ensure all student records follow the law pursuant to CEC section 94900 and 5 CCR sections 71920 and 71930. The Institution must submit a statement of attestation they have corrected the violation and will ensure that all student records contain a transcript of courses and units on which the certificate or degree was based, the grades earned by the student or the degree or certificate that was granted and the date on which that degree or certificate was granted. The statement of attestation must be dated and signed by an authorized representative of the Institution.

**Violation #4:**

**CEC section 94935(b) and (h) – Notice to Comply in conjunction with 5 CCR 76140(a)(6) - Record-Keeping Requirements**

**Cause for Citation:** On or about September 17, 2025, Bureau staff issued a Notice to Comply (NTC) to the Institution. The Institution failed to remedy the noncompliance as noted in the Notice to Comply within 30 days for the following violation:

- **Violation 11** - 5 CCR section 76140(a)(6) - Record-Keeping Requirements

While the Institution attempted to remedy the noncompliance, the Institutions Student Tuition Recovery Fund (STRF) supporting documentation failed to contain some required data pursuant to 5 CCR section 76140; specifically, subsection (a)(6).

**Administrative Fine:** Pursuant to 5 CCR section 75030, the Bureau has determined this to be a “Class D” violation. The Institution is issued a fine of \$500.00

**Order of Abatement:** Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to correct the violations identified in the Notice to Comply and submit proof of compliance pursuant to CEC section 94935 and 5 CCR section 76140.

### **COMPLIANCE WITH ORDER OF ABATEMENT**

5. In accordance with the provisions of CEC section 94936 and 5 CCR section 75020, the Bureau issues the order(s) of abatement described above. Evidence of compliance with the order of abatement must be submitted to the Bureau within 30 days from the date of issuance of this citation. ### **NOTICE OF APPEAL RIGHTS**

7. You have the right to contest this citation through an informal conference with the Bureau pursuant to 5 CCR section 75020 and/or through an administrative hearing in accordance with Chapter 5 (Commencing with section 11500) of Part 1 of Division 3 of Title 2 of the Government Code.

If you wish to contest this citation, the Bureau must receive a written request within 30 days from the date of issuance of this citation asking for an informal conference and/or administrative hearing or you may also submit the enclosed *Notice of Appeal of Citation – Request for Informal Conference and/or Administrative Hearing* form.
