2	5 CCR § 71800 (e)(4)	<p>Violation Description: The institution’s enrollment agreement template failed to itemize the cost of lab supplies or kits, however, their catalog states the institution charges \$230 for supplies in the Charges: Tuition & Fees section.</p> <p>Correction: The institution shall update their enrollment agreement to itemize for the cost of supplies or remove the statement from their catalog, pursuant to 5 CCR § 71800 (e)(4).</p>
3	5 CCR § 71800 (e)(11) in conjunction with 5 CCR § 76120 (a)	<p>Violation Description: The institution’s enrollment agreement template failed to update the cost for the Student Tuition Recovery Fund fee to its current rate of \$0.00 per \$1,000.00 of institution charges.</p> <p>Correction: The institution shall update their enrollment agreement to itemize for the cost of at the current rate, pursuant to 5 CCR § 71800 (e)(11) in conjunction with 5 CCR § 76120 (a).</p>

Pursuant to 5 CCR section 75010(d), the Institution may do either of the following:

- (1) Within 30 days from the date of the inspection, sign and return the notice to comply, declaring under penalty of perjury that the violation was corrected and describing how compliance was achieved; or
- (2) Within 30 days from the date of the inspection, file with the Bureau a written notice of disagreement, specifying the minor violations described in the notice to comply with which the person approved to operate the institution disagrees, and appealing it by requesting an informal office conference. If a written notice of disagreement is not timely filed with the Bureau, the right to appeal is deemed to have been waived.

Pursuant to CEC section 94935(h), failure to comply with the notice to comply will result in the Bureau taking appropriate administrative enforcement action.
