Violation	Code Section Violated	Description of the violation and required correction.
1	CEC § 94913(a)(5)	Violation Description: The institution's website fails to contain the most recent annual report submitted to the bureau. Correction: The institution shall update the website to include all required items pursuant to CEC § 94913(a)(5).
2	CEC §94909(a)(2) in conjunction with CEC §94897(l)	Violation Description: The institutions 2025-2026 catalog on page 12 uses the term "approval to operate" without stating clearly and conspicuously that approval to operate means compliance with state standards as set forth in this chapter. Correction: The institution shall update the 2025-2026 catalog with the required information pursuant to CEC §94909(a)(2) in conjunction with CEC §94897(l).

Violation	Code Section Violated	Description of the violation and required correction.
3	CEC §94909(a)(3)(B)	Violation Description: The institutions 2025-2026 catalog on page 16 contains the following disclosure without the required specific language: “As a prospective student, you are encouraged to review this catalog before signing an enrollment agreement. You are also encouraged to review the School Performance Fact Sheet, which must be provided to you before signing an enrollment agreement.” Correction: The institution shall update the catalog with the required information pursuant to CEC §94909(a)(3)(B).
4	CEC §94909(a)(3)(A)	Violation Description: The institutions 2025-2026 catalog on page 17 contains the following disclosure with the bureau’s old telephone number: “Any questions a student may have regarding this catalog that have not been satisfactorily answered by the institution may be directed to the Bureau for Private Postsecondary Education at (address), Sacramento, CA (ZIP Code), (internet website address), (telephone and fax numbers).” Correction: The institution shall update the catalog with the required information pursuant to CEC §94909(a)(3)(A).
5	5 CCR §71810(b)(3)	Violation Description: The institutions 2025-2026 catalog fails to specify whether visa services are provided or whether the institution will vouch for student status, and any associated charges. Correction: The institution shall update the catalog with the required information pursuant to 5 CCR §71810(b)(3).
6	CEC § 94909(a)(9)	Violation Description: The institution’s 2025-2026 catalog on page 125 fails to contain the schedule of total charges for a period of attendance. Correction: The institution shall include in the 2025-2026 catalog a schedule of total charges for a period of attendance pursuant to CEC § 94909(a)(9).

7	5 CCR §76215(b)	Violation Description: The institution's 2025-2026 catalog on pages 122-123 contains the bureau's old address and telephone number in the STRF disclosure. Correction: The institution shall include in the 2025-2026 catalog with the correct information pursuant to 5 CCR §76215(b).
8	CEC § 94919 (c) and 5 CCR § 71751 (a)(3)(A)	Violation Description: The institution's 2025-2026 catalog on page 122 and page 2 on the enrollment agreement template contains the incorrect pro-rata refund calculation. Correction: The institution shall update the 2025-2026 catalog with the correct pro-rata refund calculation pursuant to CEC § 94919 (c) and 5 CCR § 71751 (a)(3)(A).
9	CEC §94911(d)	Violation Description: The institution's enrollment agreement template on page 3 fails to contain a clear and conspicuous statement that the enrollment agreement is legally binding when signed by the student and accepted by the institution. Correction: The institution shall update the enrollment agreement with the required information pursuant to CEC §94911(d).
10	CEC § 94913 (a)(1)	Violation Description: The institution's website contains a catalog with violations identified in this NTC. Correction: Once the institution's current catalog has been updated to remedy the violation(s), the institution shall update its website to provide the current/updated institution catalog pursuant to CEC § 94913(a)(1).

Pursuant to 5 CCR section 75010(d), the Institution may do either of the following:

- (1) Within 30 days from the date of the inspection, sign and return the notice to comply, declaring under penalty of perjury that the violation was corrected and describing how compliance was achieved; or
- (2) Within 30 days from the date of the inspection, file with the Bureau a written notice of disagreement, specifying the minor violations described in the notice to comply with which the person approved to operate the institution disagrees, and appealing it by requesting an informal office conference. If a written notice of disagreement is not timely filed with the Bureau, the right to appeal is deemed to have been waived.

Pursuant to CEC section 94935(h), failure to comply with the notice to comply will result in the Bureau taking appropriate administrative enforcement action.

The Notice to Comply was given to the Institution's owner, person in control, chief academic officer, chief executive officer, chief operating officer, institution director, or any person delegated by any of the aforementioned persons to facilitate the inspection or accept such notice as set forth below.
