On September 29, 2022, an informal telephone conference was held in the matter of Citation: Assessment of Fine and Order of Abatement No. 2223018 (Citation) against Alexander Cusianovic Owner of Las Americas Truck Driving School (Institution). In attendance were Elizabeth Elias, Enforcement Chief, and Alexander Cusianovic, Owner.

Pursuant to Business and Professions Code, section 148; California Education Code (CEC), section 94944; and Title 5 of California Code of Regulations (5, CCR), section 75020 and section 75040, the Bureau for Private Postsecondary Education (Bureau) renders the following decision relative to your appeal of the Citation No. 2223018

It is the decision of the Enforcement Chief that on September 29, 2022, Citation No. 2223018 is affirmed for the following reason(s):

- No new substantive facts were presented at the conference.

**VIOLATION CODE SECTIONS**

#	Below you will find the California Education Code (CEC) and/or Title 5 of the California Code of Regulations (5, CCR code) section(s) of law you are charged with violating.
1.	<p><b>AFFIRMED</b></p> <p><b>Violation:</b></p> <p><b>CEC Section 94886. Approval to Operate Required</b></p> <p><i>“Except as exempted in Article 4 (commencing with Section 94874) or in compliance with the transition provisions in Article 2 (commencing with Section 94802), a person shall not open, conduct, or do business as a private postsecondary educational institution in this state without obtaining an approval to operate under this chapter.”</i></p>

**CEC Section 94817.5. Approved to Operate or Approved**

“Approved to operate” or “approved” means that an institution has received authorization pursuant to this chapter to offer to the public and to provide postsecondary educational programs.”

**CEC Section 94868. To Offer to the Public**

“To offer to the public” means to advertise, publicize, solicit, or recruit.”

**CEC Section 94869. To Operate**

“To operate” means to establish, keep, or maintain any facility or location in this state where, or from which, or through which, postsecondary educational programs are provided.”

On May 10, 2022, Bureau Staff conducted a search of the Institution’s website at [www.lasamestrucking.com](http://www.lasamestrucking.com). Bureau staff located the “Training” section of the website and found a listing for Class A Manual and Automatic Basic Training of 30 hours at a price list of \$3,500.00.

Additionally, the advertisement also has a listing of a DMV Mandatory Training, plus 15 hours of training, as per the DMV Mandatory requirement, for a price of \$2,800.00.

Furthermore, upon a further check of the Institution’s website, an additional advertisement of a special offer for individuals utilizing cash payment was found, for a price of \$2,500.00.

Through the course of the investigation, it was determined that the Institution is operating without Bureau approval or a valid exemption.

**Order of Abatement:**

The Bureau orders that the Institution cease to operate as a private postsecondary educational institution, unless the Institution qualifies for an exemption under CEC section 94874. The Institution must discontinue recruiting or enrolling students and cease all instructional services and advertising in any form or type of media, including [www.lasamestrucking.com](http://www.lasamestrucking.com), and any other websites not identified here that are associated with the Institution, until such time as an approval to operate is obtained from the Bureau. The Institution must disconnect all telephone service numbers including, but not limited to, (909) 245-1530 and (909) 248-2366, that are associated with the Institution until such time as an approval to operate is obtained from the Bureau. To comply with the Order of Abatement the Institution must submit a school closure plan to the Bureau pursuant to California Education Code section 94926. The Institution must provide a roster of each student currently enrolled at the Institution. The roster must include the names of the students, their contact information (including phone number, email address, and physical address), the programs in which they are enrolled, the amount paid for the programs.

APPEAL OF CITATION

You *do not* have the right to request another Informal Conference to appeal this affirmed Citation. You *do*, however, have the right to appeal this affirmed Citation through an Administrative Hearing. A hearing before an Administrative Law Judge will be scheduled and you will be notified of the hearing date. The hearing will be held pursuant to Chapter 5 (commencing with section 11500) of Part 1 of Division 3 of Title 2 of the Government Code.

If you do not wish to appeal this modified Citation you must withdraw your initial request for an Administrative Hearing, if one was made. Please complete and mail the enclosed Withdrawal – Request for Administrative Hearing within 30 Days of the date of this decision.

EFFECTIVE DATE OF CITATION AND FINE ASSESSMENT

This affirmed Citation is effective on **October 12, 2022**. The order of abatement and payment are due by **November 11, 2022**.

Failure to abate the violation or to pay the administrative fine within the time allowed is grounds for denial of an application for an approval to operate or discipline. The Bureau will promptly take all

appropriate action to enforce the Affirmed Citation and recover the civil penalties prescribed therein or found to be due after a hearing.
