### LICENSING HISTORY

1. On or about January 6, 2021, the Bureau renewed an Approval to Operate a Private Postsecondary Institution to Institution of Contemporary Psychoanalysis (hereinafter referred to as the "Institution"). This Approval to Operate expired on or about January 5, 2021 and has not been renewed. An application for renewal of the Institution's Approval to Operate a Private Postsecondary Institution was received on July 15, 2021 and is under review.

On or about December 29, 2015 the Bureau issued an Approval to Operate a Branch location. This Approval to Operate expired on or about January 5, 2021 and has not been renewed. An application for renewal of the Institution's Approval to Operate a Private Postsecondary Institution Branch was received on July 15, 2021 and is under review.

### CAUSE FOR CITATION & ASSESMENT OF FINE AND/OR ORDER OF ABATEMENT

4. The Institution is in violation of the following Bureau laws and regulations:

<b>Cause for Citation:</b> A review of the Bureau's records confirm the Institution failed to submit all components of the 2021 Annual Report which was due to the Bureau by December 1, 2022. A reminder notice was sent to the Institution on or about the following dates: June 28, 2022 and July 14, 2022 and July 26, 2022.
<b>Administrative Fine:</b> Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class A" violation. The Institution is issued a fine of \$5,000.00.
<b>Order of Abatement:</b> Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:  The Bureau orders the Institution to submit the 2021 Annual Report pursuant to 5 CCR section 74110 and CEC section 94934.

**5 CCR section 76130 – Collection and Submission of Assessments**
