Elizabeth Elias issues this modified citation in her official capacity as Deputy Bureau Chief of Enforcement at the Bureau for Private Postsecondary Education, California Department of Consumer Affairs (hereinafter referred to as the "Bureau").

LICENSING HISTORY

- On or about January 16, 2020, the Bureau renewed an Approval to Operate an Accredited Private Postsecondary Institution, Institution Code 3711341, to International Academy of English / San Diego (formerly known as San Diego International Academy of English) hereinafter referred to as the "Institution". This Approval to Operate will expire on or about August 31, 2028, unless renewed.

CITATION JURISDICTION

- This administrative citation is issued to the Institution pursuant to California Education Code (CEC) section 94936; and Title 5 of the California Code of Regulations (5 CCR) section 75020 et seq. for the violation(s) described below.

4. On or about December 4, 2024, the Bureau issued Citation No. 24250156. On or about December 20, 2024, the Bureau received a Notice of Appeal requesting both an informal conference and administrative hearing. The Bureau held the informal conference on January 31, 2025, and the citation was modified as a result of the informal conference. The Modified Citation was issued on February 28, 2025. On May 15, 2025, the Bureau transmitted the case to the Attorney General's Office for an administrative hearing as requested by the Institution. However, prior to the administrative hearing, the Institution signed a Settlement of Modified Citation No. 24250156. As settlement of the Modified Citation No. 24250156, the Institution agrees to withdraw its request for an Administrative Hearing and agrees to a Settlement of Modified Citation Order as follows:

**CAUSE FOR CITATION &
MODIFIED ASSESSMENT OF FINE AND/OR ORDER OF ABATEMENT**

5. The Institution is in violation of the following Bureau laws and regulations:

Violation #1:

5 CCR section 74112(m)(2-9) Uniform Data – Annual Report, Performance Fact Sheet and 5 CCR section 71930(e) – Maintenance of Records

Cause for Citation: On or about December 18, 2023, the Bureau conducted an unannounced compliance inspection pursuant to CEC section 94932.5(a). Bureau staff requested documentation supporting data reported on the Institutions 2020/2021 School Performance Fact Sheet (SPFS). Upon review of the SPFS, Bureau staff found that the Institution's documentation for 2020/2021 failed to include all the required data points; specifically, the following data points as identified in 5 CCR section 74112 (m) (2-9).

Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class A" violation. The Institution is issued a fine of \$2,501.00.

Administrative Fine: Pursuant to the Settlement of Modified Citation No. 24250156, the administrative fine is further modified and reduced to \$1,250.00.

Order of Abatement: Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to correct the violation by providing an electronic copy of the template used by the Institution to document supporting data for SPFS, for the Bureau to verify the Institution is collecting the required data points pursuant to 5 CCR section 74112 and 71930.

In addition, the Institution must submit a statement of attestation they have corrected the violation and will ensure that the supporting data for SPFS is maintained and immediately available during an inspection. The statement of attestation must be dated and signed by an authorized representative of the Institution.

Order of Abatement: Affirmed.

Violation #2:

5 CCR section 71720(b)(2) – Faculty, 5 CCR section 71930(e) – Maintenance of Records and CEC 94900.5(b) – Required Institutional Records

Cause for Citation: On or about December 18, 2023, the Bureau conducted an unannounced compliance inspection pursuant to CEC section 94932.5(a). Bureau staff reviewed three faculty records and determined that the Institution did not maintain faculty records regarding continuing education (CE) courses in the subject area, classroom management or other courses related to teaching.

Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a “Class C” violation. The Institution is issued a fine of \$1,000.00.

Administrative Fine: Pursuant to the Settlement of Modified Citation No. 24250156, the administrative fine is further modified and reduced to \$500.00.

Order of Abatement: Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to ensure all faculty records follow the law pursuant to 5 CCR sections 71720, 71930 and CEC section 94900.5. The Institution must submit a statement of attestation they have corrected the violation and ensured that all faculty records are in compliance with the law. The statement of attestation must be dated and signed by an authorized representative of the Institution.

Order of Abatement: Affirmed. The abatement has been satisfied.

Violation #3:

CEC section 94900 – Required Student Records, 5 CCR section 71920 Student Records and 5 CCR section 71930(e) – Maintenance of Records

Cause for Citation: On or about December 18, 2023, the Bureau conducted an unannounced compliance inspection pursuant to CEC section 94932.5(a). Bureau staff requested student records for current, graduated, and withdrawn students. It was found the Institution did not maintain files in a way which identified students as graduated or withdrawn, therefore; the inspector was unable to review graduated and withdrawn student files.

Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a “Class A” violation. The Institution is issued a fine of \$2,501.00.

Administrative Fine: Pursuant to the Settlement of Modified Citation No. 24250156, the administrative fine is further modified and reduced to \$1,250.00

Order of Abatement: Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to submit a statement of attestation they will maintain required student records pursuant to CEC section 94900 and 5 CCR sections 71920 and 71930. The statement of attestation must be signed and dated by an authorized representative of the Institution.

Order of Abatement: Affirmed.

Violation #4:

5 CCR section 71750(f) – Withdrawals and Refunds

Cause for Citation: On or about December 18, 2023, the Bureau conducted an unannounced compliance inspection pursuant to CEC section 94932.5(a). During the inspection, it was determined that the Institution did not maintain a cancellation and withdrawal log.

Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a “Class A” violation. The Institution is issued a fine of \$2,501.00.

Administrative Fine: Pursuant to the Settlement of Modified Citation No. 24250156, the administrative fine is further modified and reduced to \$1,250.00

Order of Abatement: Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to submit a statement of attestation confirming the Institution will maintain a cancellation and withdrawal log in compliance with 5 CCR section 71750(f). The statement of attestation must be dated and signed by an authorized representative of the Institution.

Order of Abatement: Affirmed.

Violation #5:

CEC section 94935(b) and (h) – Notice to Comply and 5 CCR 75010(h) - Notice to Comply; Informal Appeal Process.

Cause for Citation: On or about December 18, 2023, the Bureau conducted an unannounced compliance inspection pursuant to CEC section 94932.5(a). At the conclusion of the inspection, Bureau staff issued a Notice to Comply (NTC) pursuant to CEC section 94935 and 5 CCR section 75010.

The Institution failed remedy the following noncompliance as noted in the Notice to Comply within 30 days:

- CEC section 94920(b) - Mandatory Cancellation, Withdrawal, and Refund Policies
- 5 CCR section 71810(b)(4)(A) – Catalog
- 5 CCR section 76120(a) - Amount of STRF Assessment
- 5 CCR section 71750(c)(1) - Withdrawals and Refunds

Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a “Class B” violation. The Institution is issued a fine of \$2,500.00.

The Bureau orders the Institution to correct the violations identified in the Notice to Comply and submit proof of compliance pursuant to CEC section 94935 and 5 CCR section 75010.

Order of Abatement: Affirmed.

6. In accordance with the provisions of CEC section 94936 and 5 CCR sections 75020 and 75040, the Bureau issues the order(s) of abatement described above. 8. The Institution forfeits their right to appeal by withdrawing their appeal for an administrative hearing.

9. Pursuant to 5 CCR section 75050, payment of the fine and/or compliance with any order of abatement does not constitute an admission of the violation charged and shall be represented as satisfactory resolution of the matter for the purposes of public disclosure.

Pursuant to 5 CCR section 75050, failure to comply with this citation order, its order of abatement, and/or administrative fine by the required due date is grounds for denial or discipline of an approval to operate. Where a citation is not contested and fine is not paid, the full amount of the assessed fine shall be added to the fee for renewal of the approval to operate. An approval to operate shall not be renewed without payment of the renewal fee and fine. The Bureau may also enforce the administrative fine as if it were a money judgment pursuant to CEC section 94936.
