### LICENSING HISTORY

1. On or about December 22, 2023, the Bureau renewed an Approval to Operate an Accredited Private Postsecondary Institution, Institution Code 1926311, to American Harbor College (formerly known as Harbor Career College), hereinafter referred to as the "Institution." This Approval to Operate will expire on or about February 28, 2028, unless renewed.

The informal conference was held on June 18, 2025. No new substantive facts were presented during the informal conference; therefore, the Bureau affirms Citation No. 24250345.

5. The Institution is in violation of the following Bureau laws and regulations:

#### Violation #1:

5 CCR section 74006(a), (b) – Annual Fee and CEC 94931(b) – Late Payment

**Cause for Citation:** The Institution failed to pay its annual fee and 90-day late payment penalty fee for the 2025 calendar year.
