24 1. On June 4, 2025, Deborah Cochrane, Chief of the Bureau for Private Postsecondary
25 Education, Department of Consumer Affairs ("Bureau"), solely in her official capacity, filed
26 Statement of Issues Number BPPE24-0254.

27 2. On or about February 24, 2023, the Bureau received an Application for Renewal of
28 Approval to Operate and Offer Educational Programs for an Institution Non-Accredited from
American Heritage University of Southern California ("Respondent"). After sending several

1 notices of deficiencies and reviewing additional documents submitted by Respondent, on or about
2 March 19, 2024, the Bureau issued a Notice of Denial of Approval to Operate an Institution Non-
3 Accredited. On or about March 25, 2024, the Bureau received a Request for an Administrative
4 Hearing from Respondent.

5 3. On July 21, 2025, the Bureau received Respondent's Notice of Withdrawal of
6 Request for Hearing. The basis for withdrawing the pending Statement of Issues Number
7 BPPE24-0254 is that Respondent has withdrawn its request for a hearing.

8 4. WHEREFORE, IN THE INTEREST OF JUSTICE, Statement of Issues Number
9 BPPE24-0254 is hereby withdrawn without prejudice.
