Correction: The institution shall update their website to include their most recent SPFS, pursuant to CEC § 94913 (a)(2).
2	CEC § 94913 (a)(5)	Violation Description: The institution's 2024 annual report was approved and published to the BPPE website, however, they failed to post it to their institution website. Correction: The institution shall update their website to include their most recent annual report, pursuant to CEC § 94913 (a)(5).
3	CEC § 94897 (q)	Violation Description: The institution's website (https://calregional.com/enroll-now/) contains false/misleading statements that imply the institution is

4	CEC § 94897 (q)	<p>Violation Description: The institution’s website contains misleading and untrue statements indicating they have approved locations all over the state when they are only approved to operate at the sites located in Fairfield, Fremont, Stockton, Redding, El Centro, Fresno and Roseville.</p> <p>Correction: The institution shall update their website to clearly and specifically identify the true operators of the institutions at all unapproved locations, or remove these locations, pursuant to CEC § 94897 (q).</p>
5	CEC § 94897 (q)	<p>Violation Description: The institution’s website contains misleading and untrue statements indicating they have approval to offer Medical Billing and Coding and ECG Technician programs.</p> <p>Correction: The institution shall update their website to clearly and specifically identify the true operators of the institutions providing these programs, or remove these statements, pursuant to CEC § 94897 (q).</p>


Pursuant to 5 CCR section 75010(d), the Institution may do either of the following:

- (1) Within 30 days from the date of the inspection, sign and return the notice to comply, declaring under penalty of perjury that the violation was corrected and describing how compliance was achieved; or
- (2) Within 30 days from the date of the inspection, file with the Bureau a written notice of

disagreement, specifying the minor violations described in the notice to comply with which the person approved to operate the institution disagrees, and appealing it by requesting an informal office conference. If a written notice of disagreement is not timely filed with the Bureau, the right to appeal is deemed to have been waived.

Pursuant to CEC section 94935(h), failure to comply with the notice to comply will result in the Bureau taking appropriate administrative enforcement action.

The Notice to Comply was given to the Institution's owner, person in control, chief academic officer, chief executive officer, chief operating officer, institution director, or any person delegated by any of the aforementioned persons to facilitate the inspection or accept such notice as set forth below.
