On October 4, 2019, an informal telephone conference was held in the matter of Citation: Assessment of Fine and Order of Abatement No. 1920056 (Citation) against Union University of California, Inc., Owner of Union University of California (Institution). In attendance were Leeza Rifredi, Deputy Bureau Chief and Son Xuan Nguyen, Chief Operating Officer.

Pursuant to Business and Professions Code, section 125.9; California Education Code, section 94936; and Title 5 of the California Code of Regulations, section 75020 and section 75040, the Bureau for Private Postsecondary Education (Bureau) renders the following decision relative to your appeal of the Citation No. 1920056.

It is the decision of the Deputy Bureau Chief that on October 4, 2019, Citation No. 1920056 is modified and makes the following change(s):
