23 1. On or about August 5, 2013, the Bureau for Private Postsecondary Education received
24 an application for Renewal for Approval to Operate and Offer Educational Programs for Non-
25 Accredited Institution from John Ridgel's Academy of Beauty, Inc., ("Respondent") with Alice
26 Hsu designated as its President, Chief Executive Officer and 75% owner. On or about July 7,
27 2017, after providing Respondent with multiple opportunities to cure various deficiencies in its


1 application, the Bureau denied Respondents' application for Renewal of Approval to Operate an
2 Institution Non-Accredited.

3 2. On or about April 6, 2018, Dr. Michael Marion, Jr., Bureau Chief of the Bureau for
4 Private Postsecondary Education, Department of Consumer Affairs, filed Statement of Issues No.
5 1002848 solely in his official capacity.

6 3. On or about January 17, 2019, Respondent withdrew its appeal and request for a
7 hearing of the denial of its Application for Renewal of Approval to Operate an Institution Non-
8 Accredited.

9 4. Accordingly, Statement of Issues No. 1002848, filed against Respondent, is hereby
10 withdrawn without prejudice and the denial of their application is affirmed.
