Christina Villanueva issues this Citation: Assessment of Fine and Order of Abatement (Citation) in her official capacity as Discipline Manager of the Bureau for Private Postsecondary Education (Bureau) of the California Department of Consumer Affairs.

CITATION

A Citation is hereby issued to Free Agent, Inc., Owner of JVTA, Inc., (Institution) located at 3510 Torrance Blvd., Suite 219, Torrance, CA 90503, pursuant to Business and Professions Code section 125.9; California Education Code (CEC) sections 94936 and 94932; and Title 5 of the California Code of Regulations (5, CCR) section 75020 for the violations described below.

BACKGROUND

On September 8, 2021, the Bureau attempted to conduct an unannounced Compliance inspection at the Institution. According to the Institution's School Catalog and website, the Institution's office hours are Monday through Friday 8:00am to 6:00pm. Bureau staff arrived at the Institution site at 12:30pm and attempted to open the office door, however the door was locked and there was not a response Bureau staff then called an Institution contact listed on the Institution's General Information form and received a voice mail. Bureau staff left a voice message identifying themselves as Bureau staff and stated that they were at the Institution to conduct an unannounced Compliance inspection. Bureau staff also stated in the voicemail that they would wait an hour to receive a response and provided their contact phone number.

Furthermore, Bureau staff also attempted to reach the Institution's Agent for Process by phone, was unable to reach a live person, therefore Bureau staff left a voice identifying themselves as Bureau staff and that they were attempting to contact the school. At 1:45pm Bureau staff had not received a call back from Institution staff, and left the Institution site as they were unable to conduct an unannounced Compliance inspection.

VIOLATION

1.	<p><u>Violation:</u> CEC Section 94932.5 – Announced and Unannounced Compliance Inspections <i>“(a) As part of its compliance program, the bureau shall perform announced and unannounced inspections of institutions at least every five years.”</i></p> <p>5, CCR Section 71930(e) – Maintenance of Records <i>“(e) All records that the institution is required to maintain by the Act or this chapter shall be made immediately available by the institution for inspection and copying during normal business hours by the Bureau and any entity authorized to conduct investigations.”</i></p> <p>Bureau staff was unable to conduct an unannounced Compliance inspection at the Institution’s site and was unable to inspect records during normal business hours in accordance with CEC Section 94932.5 and 5, CCR Section 71930.</p> <p><u>Order of Abatement:</u> The Bureau orders the Institution to submit a written policy, or procedure, of how future compliance will be maintained in accordance with CEC Section 94932.5 and 5, CCR Section 71930.</p> <p><u>Assessment of Fine</u> The fine for this violation is <u>\$5,000.00</u></p>

ASSESSMENT OF A FINE

In accordance with CEC section 94936; and 5, CCR sections 75020 and 75030, the Bureau hereby orders this assessment of fine in the amount of **\$5,000.00** for the violations described above. **Payment must be made, to the Bureau, within 30 days from the date of service of the Citation.**

COMPLIANCE WITH ORDER OF ABATEMENT

In accordance with the provisions of CEC section 94936 and 5, CCR section 75020 the Bureau hereby issues the order(s) of abatement described above. **Evidence of compliance with the order(s) of abatement must be submitted, to the Bureau, within 30 days from the date of service of the Citation.**

APPEAL OF CITATION

You have the right to contest this Citation through an informal conference with the Bureau; and/or through an administrative hearing in accordance with Chapter 5 (Commencing with Section 11500) of Part 1 of Division 3 of Title 2 of the Government Code.

If you wish to contest this Citation, you must submit the ‘Notice of Appeal of Citation – Request for Informal Conference and/or Administrative Hearing’ form (enclosed) within 30 days from the date of service of the Citation. *If you do not request an informal conference and/or an administrative hearing within 30 days from the service of the Citation, you will not be able to request one at a later time.*

Unless a written request for an informal conference and/or an administrative hearing is signed by you and delivered to the Bureau by **August 20, 2022**, you will be deemed to have waived or forfeited your right to appeal this matter.

EFFECTIVE DATE OF CITATION

If you do not request an informal conference and/or an administrative hearing, this Citation shall become effective on **July 21, 2022**. Payment of the administrative fine and evidence of compliance with the order(s) of abatement shall be due by **August 20, 2022**. Your payment of the administrative fine shall not constitute an admission of the violation(s) charged.

If a hearing is requested, you will not be required to comply with this Citation until 30 days after a final order is entered against you.
