CITATION HISTORY

4. On or about February 22, 2024, the Bureau issued Citation No. 23240196. On or about March 25, 2024, the Bureau received an appeal with a request for an informal conference. The informal conference was held on April 22, 2024. New substantive facts were presented during the informal conference; therefore, the Bureau modifies the citation as follows:

CAUSE FOR CITATION & MODIFIED ASSESMENT OF FINE AND/OR ORDER OF ABATEMENT

5. The Institution is in violation of the following Bureau laws and regulations:

Violation #1: 5 CCR section 74110 – Annual Report in conjunction with CEC section 94934 – Annual Report
Cause for Citation: A review of the Bureau's records confirm the Institution failed to submit a 2022 Annual Report. The report was due to the Bureau by December 1, 2023.
Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class A" violation. The Institution is issued a fine of \$5,000.00. Administrative Fine: Modified. The Bureau modifies the administrative fine to \$2,501.00. Citation remains a Class "A" violation.
Order of Abatement: The Bureau orders the Institution to submit the 2022 Annual Report pursuant to 5 CCR section 74110 and CEC section 94934. Order of Abatement: Affirmed

An approval to operate shall not be renewed without payment of the renewal fee and fine. The Bureau may also enforce the administrative fine as if it were a money judgment pursuant to CEC section 94936.
