


§71720 - Faculty.	<p>(b) Instructors in an Educational Program Not Leading to a Degree.</p> <p>(2) Each instructor shall maintain their knowledge by completing continuing education courses in his or her subject area, classroom management or other courses related to teaching.</p> <p>The institution failed to provide copies of continuing education for their instructors or a policy and procedure for ensuring instructors maintain their knowledge by completing continuing education.</p> <p>To remedy the violation, the institution shall provide their policy and procedure for ensuring each instructor maintains their knowledge by completing continuing education courses. A copy of the policy and procedure and the last page of this document shall be submitted with the response to the Notice to Comply and the last page of this document within the specified time frame.</p>
§71920 - Student Records.	<p>(b) In addition to the requirements of section 94900, the file shall contain all of the following pertinent student records:</p> <p>(1) Written records and transcripts of any formal education or training, testing, or experience that are relevant to the student's qualifications for admission to the institution or the institution's award of credit or acceptance of transfer credits including the following:</p> <p>(A) Verification of high school completion or equivalency or other documentation establishing the student's ability to do college</p>
