1	CEC § 94909(a)(5)	Violation Description: The institution's catalog fails to include any final tests or examinations required for completion of each program Correction: The institution shall update the catalog to include any required final tests or examinations required for completion of each program pursuant to CEC § 94909(a)(5).
2	CEC § 94909(a)(9) in conjunction with CEC § 94870	Violation Description: The institution's catalog fails to include the schedule of total charges for a period of attendance and an estimated schedule of total charges for the entire educational program. Correction: The institution shall update its catalog to include the schedule of total charges for a period of attendance and an estimated schedule of total charges for the entire educational program as defined by CEC § 94870 pursuant to CEC § 94909(a)(9).

3	CEC § 94909(a)(8)(B) in conjunction with CEC § 94920(b)	<p>Violation Description: Pages 36 and 37 of the institution's catalog contains a refund policy that is not compliant with CEC § 94920(b) which states:</p> <p>"Institutions shall refund 100 percent of the amount paid for institutional charges, less a reasonable deposit or application fee not to exceed two hundred fifty dollars (\$250), if notice of cancellation is made through attendance at the first class session, or the seventh day after enrollment, whichever is later."</p> <p>Correction: The institution shall remove the noncompliant refund verbiage in the catalog pursuant to CEC § 94909(a)(8) referencing CEC § 94920(b).</p>
4	5 CCR § 71810(b)(12)	<p>Violation Description: The institution's catalog fails to contain a description of all student services.</p> <p>Correction: The institution shall update its catalog to include a description of all student services, pursuant to 5, CCR 71810(b)(12).</p>
5	CEC § 94913(a)(1)	<p>Violation Description: The institution's website contains a catalog with violations identified in this NTC.</p> <p>Correction: Once the institution has updated its catalog to correct the violations identified in this NTC, the institution shall update its website to include a clearly labeled link to the institution's catalog pursuant to CEC § 94913(a)(1).</p>
6	CEC § 94913(a)(4)	<p>Violation Description: The institution's website fails to provide a clear and conspicuous link to the Bureau's internet website.</p> <p>Correction: The institution shall update its website to include a clear and conspicuous link to the Bureau's internet website pursuant to CEC § 94913(a)(4).</p>
7	CEC § 94913(a)(5)	<p>Violation Description: The institution's website fails to provide a link to the institution's most recent annual report submitted to the Bureau.</p> <p>Correction: The institution shall update its website to include a clear and conspicuous link to the institution's most recent annual report pursuant to CEC § 94913(a)(5).</p>

8	5 CCR § 71800(e)(2)	<p>Violation Description: The institution's enrollment agreement includes the registration fee in the itemized list of institutional charges; however, it fails to identify the registration fee as non-refundable.</p> <p>Correction: The institution shall update its enrollment agreement to clearly identify the registration fee as nonrefundable pursuant to 5 CCR § 71800(e)(2).</p>
9	CEC § 94911(j)(1)	<p>Violation Description: The institution's enrollment agreement contains the required disclosure language directing students to the Bureau for unanswered questions; however, the disclosure includes outdated contact information.</p> <p>Correction: The institution shall update its enrollment agreement to include the Bureau's correct contact information in the disclosure referenced above pursuant to CEC § 94911(j)(1).</p>
10	5 CCR § 71800(e)(11)	<p>Violation Description: The institution's enrollment agreement includes the STRF fee in the itemized list of institutional charges; however, it fails to identify the fee as non-refundable.</p> <p>Correction: The institution shall update its enrollment agreement to clearly identify the STRF fee as non-refundable pursuant to § 71800(e)(11).</p>

Pursuant to 5 CCR section 75010(d), the Institution may do either of the following:

- (1) Within 30 days from the date of the inspection, sign and return the notice to comply, declaring under penalty of perjury that the violation was corrected and describing how compliance was achieved; or
- (2) Within 30 days from the date of the inspection, file with the Bureau a written notice of disagreement, specifying the minor violations described in the notice to comply with which the person approved to operate the institution disagrees, and appealing it by requesting an informal office conference. If a written notice of disagreement is not timely filed with the Bureau, the right to appeal is deemed to have been waived.

Pursuant to CEC section 94935(h), failure to comply with the notice to comply will result in the Bureau taking appropriate administrative enforcement action.

The Notice to Comply was given to the Institution's owner, person in control, chief academic officer, chief executive officer, chief operating officer, institution director, or any person delegated by any of the aforementioned persons to facilitate the inspection or accept such notice as set forth below.
