The website currently includes a School Performance Fact Sheet for 2021-2022.</p> <p>Correction: To remedy this violation, the school shall update its school's website to include current links pursuant to CEC § 94913 (a)(2) and 5CCR § 71810 (a).</p>
2	CEC § 94909 (a)(3)(D)	<p>Violation Description: The institution's catalog dated 1/1/2025-12/31/2025 failed to include the required verbatim statement.</p> <p>"The Office of Student Assistance and Relief is available to support prospective students, current students, or past students of private postsecondary educational institutions in making informed decisions, understanding their rights, and navigating available services and relief options. The office may be reached by calling (888) 370- 7589, option #5, or by visiting osar.bppe.ca.gov."</p>

3	CEC § 94897 (s)	<p>Violation Description: The institution's catalog dated 1/1/2025 – 12/31/2025 violated Section 1788.93 of the Civil Code by requiring students to pay all fees to the school prior to being awarded a transcript. (pg 14)</p> <p>Correction: Provide an updated catalog that is corrected to comply with CEC § 94897 (s).</p>
4	CEC § 94911 (d)	<p>Violation Description: The institution's enrollment agreement failed to include a statement indicating the enrollment agreement is legally binding when signed by the student and accepted by the institution.</p> <p>Correction: Provide an updated enrollment agreement that is corrected to comply with CEC § 94911 (d).</p>
5	5 CCR § 71720 (b)(2)	<p>Violation Description: The institution's faculty files failed to include copies of continuing education.</p> <p>Correction: Provide a policy and procedure that is in compliance with 5 CCR § 71720 (b)(2).</p>

Pursuant to 5 CCR section 75010(d), the Institution may do either of the following:

- (1) Within 30 days from the date of the inspection, sign and return the notice to comply, declaring under penalty of perjury that the violation was corrected and describing how compliance was achieved; or
- (2) Within 30 days from the date of the inspection, file with the Bureau a written notice of disagreement, specifying the minor violations described in the notice to comply with which the person approved to operate the institution disagrees, and appealing it by requesting an informal office conference. If a written notice of disagreement is not timely filed with the Bureau, the right to appeal is deemed to have been waived.

Pursuant to CEC section 94935(h), failure to comply with the notice to comply will result in the Bureau taking appropriate administrative enforcement action.
