Violation	Code Section Violated	Description of the violation and required correction.
1	CEC § 94909 (a)(8)(B) in conjunction with CEC § 94919 (d)	Violation Description: The institutions 2026-2027 catalog failed to contain cancellation, withdrawal, and refund policies, including an explanation that the student has the right to cancel the enrollment agreement and obtain a refund of charges paid through attendance at the first class session, or the seventh day after enrollment, whichever is later. The following statement, found in the CANCELLATIONS, WITHDRAWALS, AND REFUNDS section fails to clearly state that the student can cancel by whichever date is later: General Cancellation: Within 14 days after enrollment or before the start of the program, students can cancel for a full refund, minus non-refundable fees up to \$200. This statement is misleading and unenforceable. Correction: The institution shall update their catalog to include the above statements, pursuant to CEC § 94909 (a)(8)(B) in conjunction with CEC § 94919 (d).

Violation	Code Section Violated	Description of the violation and required correction.
2	5 CCR § 71800 (e)(10) in conjunction with CEC § 94919 (d)	Violation Description: The institution's enrollment agreement template contains a statement misidentifying the Transfer Fee as nonrefundable. This statement is misleading and unenforceable during the cancellation period. Correction: The institution shall update their enrollment agreement template to accurately identify this fee as refundable during the cancellation period or remove the statement, pursuant to 5 CCR § 71800 (e)(10) in conjunction with CEC § 94919 (d).
3	CEC § 94913 (a)(1)	Violation Description: Following correction of the minor violations found in the institutions 2026-2027 catalog, the most recent version will no longer be posted to their website. Correction: The institution shall post a copy of, or link to, their most recent catalog, pursuant to CEC § 94913 (a)(1).

Pursuant to 5 CCR section 75010(d), the Institution may do either of the following:

- (1) Within 30 days from the date of the inspection, sign and return the notice to comply, declaring under penalty of perjury that the violation was corrected and describing how compliance was achieved; or
- (2) Within 30 days from the date of the inspection, file with the Bureau a written notice of disagreement, specifying the minor violations described in the notice to comply with which the person approved to operate the institution disagrees, and appealing it by requesting an informal office conference. If a written notice of disagreement is not timely filed with the Bureau, the right to appeal is deemed to have been waived.

Pursuant to CEC section 94935(h), failure to comply with the notice to comply will result in the Bureau taking appropriate administrative enforcement action.

The Notice to Comply was given to the Institution's owner, person in control, chief academic officer, chief executive officer, chief operating officer, institution director, or any person delegated by any of the aforementioned persons to facilitate the inspection or accept such notice as set forth below.
