2	CEC § 94913 (a)(2) in conjunction with 5CCR § 71810 (a)	<p>Violation Description: The institution’s website failed to contain a link to the institution’s current School Performance Fact Sheets (SPFS). The SPFS’ posted on the website are for 2022-2023</p> <p>Correction: The institution shall update its school’s website to include current links pursuant to CEC § 94913 (a)(2) and 5CCR § 71810 (a).</p>

(pg 121)</p> <p>Correction: The institution shall update their enrollment agreement and catalog to meet compliance with CEC § 94897 (s).</p>
9	5CCR § 71750 (a)(1)(A)	<p>Violation Description: The institution’s catalog dated 12/1/2025-12/31/2025 includes a cancellation policy not in compliance with the bureau’s regulations. The institution’s policy includes a non-refundable application fee (\$150) and registration fee (\$100). In addition, the catalog lists several fees as non-refundable that are not allowable during the cancellation period.</p> <p>Correction: The institution shall submit a catalog and enrollment agreement in compliance with 5CCR § 71750 (a)(1)(A).</p>
10	CEC § 94909 (a)(9)	<p>Violation Description: The institution’s catalog dated 1/1/2025 – 12/31/2025 failed to include the schedule of total charges for a period of attendance and an estimated schedule of total charges for the entire educational program.</p> <p>Correction: The institution shall update their catalog to meet compliance with CEC § 94909 (a)(9).</p>
11	5CCR § 71920 (b)(5)(E)	<p>Violation Description: The institution’s transcripts failed to include their address, website, and telephone number.</p> <p>Correction: The institution shall update their transcripts and submit a draft copy to meet compliance with 5CCR § 71920 (b)(5)(E).</p>


Pursuant to 5 CCR section 75010(d), the Institution may do either of the following:

- (1) Within 30 days from the date of the inspection, sign and return the notice to comply, declaring under penalty of perjury that the violation was corrected and describing how compliance was achieved; or
- (2) Within 30 days from the date of the inspection, file with the Bureau a written notice of

disagreement, specifying the minor violations described in the notice to comply with which the person approved to operate the institution disagrees, and appealing it by requesting an informal office conference. If a written notice of disagreement is not timely filed with the Bureau, the right to appeal is deemed to have been waived.

Pursuant to CEC section 94935(h), failure to comply with the notice to comply will result in the Bureau taking appropriate administrative enforcement action.

The Notice to Comply was given to the Institution's owner, person in control, chief academic officer, chief executive officer, chief operating officer, institution director, or any person delegated by any of the aforementioned persons to facilitate the inspection or accept such notice as set forth below.
