3	CEC § 94909 (a)(9)	<p><b>Violation Description:</b> On page 36 of the institution's 2024-2025 catalog, tuition is identified as the institution's education prices for academic year 2020-2021 and fails to clearly describe the schedule of total charges for a period of attendance.</p> <p><b>Correction:</b> The institution shall update their 2024-2025 catalog to clearly describe the schedule of total charges for a period of attendance, pursuant to CEC § 94909 (a)(9).</p>
4	5 CCR § 71810 (b)(15) in conjunction with CEC § 94897 (s)	<p><b>Violation Description:</b> On page 31 and again on page 34 the institution's 2024 catalog, contains an unenforceable policy regarding withholding transcripts if the student has not fulfilled their financial obligations to the school.</p> <p><b>Correction:</b> The institution shall remove the non-compliant statement from the catalog, pursuant to 5 CCR § 71810 (b)(15) in conjunction with CEC § 94897 (s).</p>
5	5 CCR § 71800 (e)(4)	<p><b>Violation Description:</b> The institution's 2024-2025 enrollment agreement failed to itemize for lab supplies or kits.</p> <p><b>Correction:</b> The institution shall update their 2024-2025 enrollment agreement to itemize for lab supplies or kits, pursuant to 5 CCR § 71800 (e)(4).</p>
6	5 CCR § 71800 (e)(5)	<p><b>Violation Description:</b> The institution's 2024-2025 enrollment agreement failed to itemize for textbooks, or other learning media.</p> <p><b>Correction:</b> The institution shall update their 2024-2025 enrollment agreement to itemize for textbooks, or other learning media, pursuant to 5 CCR § 71800 (e)(5).</p>

Pursuant to 5 CCR section 75010(d), the Institution may do either of the following:

- (1) Within 30 days from the date of the inspection, sign and return the notice to comply, declaring under penalty of perjury that the violation was corrected and describing how compliance was achieved; or
- (2) Within 30 days from the date of the inspection, file with the Bureau a written notice of disagreement, specifying the minor violations described in the notice to comply with which the person approved to operate the institution disagrees, and appealing it by requesting an informal office conference. If a written notice of disagreement is not timely filed with the Bureau, the right to appeal is deemed to have been waived.

**Pursuant to CEC section 94935(h), failure to comply with the notice to comply will result in the Bureau taking appropriate administrative enforcement action.**

The Notice to Comply was given to the Institution's owner, person in control, chief academic officer, chief executive officer, chief operating officer, institution director, or any person delegated by any of the aforementioned persons to facilitate the inspection or accept such notice as set forth below.
