2       12. This stipulation shall be subject to approval by the Director or the Director's designee.  
3 Respondent understands and agrees that counsel for Complainant and the staff of the Bureau for  
4 Private Postsecondary Education may communicate directly with the Director and staff regarding  
5 this stipulation and surrender, without notice to or participation by Respondent or his counsel. By  
6 signing the stipulation, Respondent understands and agrees that he may not withdraw his  
7 agreement or seek to rescind the stipulation prior to the time the Director considers and acts upon  
8 it. If the Director fails to adopt this stipulation as the Decision and Order, the Stipulated  
9 Surrender and Disciplinary Order shall be of no force or effect, except for this paragraph, it shall  
10 be inadmissible in any legal action between the parties, and the Director shall not be disqualified  
11 from further action by having considered this matter.

12       13. The parties understand and agree that Portable Document Format (PDF) and facsimile  
13 copies of this Stipulated Surrender of Approval to Operate and Order, including Portable




