21 1. On or about May 14, 2013, the Bureau for Private Postsecondary Education  
22 received an Application for Renewal of Approval to Operate from Stella Adler Academy of  
23 Acting ("Respondent"). On or about May 7, 2013, Stella Adler Academy of Acting certified  
24 under penalty of perjury to the truthfulness of all statements, answers, and representations in the  
25 application. The Bureau denied the application on March 16, 2016. On or about July 8, 2016, the  
26 Bureau issued an amended notice of denial of application.

1           2.    On or about September 26, 2016, Joanne Wenzel, Chief of the Bureau for Private  
2 Postsecondary Education, solely in her official capacity, filed Statement of Issues No. 1001598.  
3 Pursuant to Respondent's request for appeal, a hearing was scheduled for August 29, 2017 at the  
4 Office of Administrative Hearings in Los Angeles.

5           3.    The basis for withdrawing the pending Statement of Issues is Respondent has now  
6 provided the documents and other information needed to correct deficiencies and receive an  
7 Approval to Operate an Institution Non-Accredited.

8           4.    WHEREFORE, IN THE INTERESTS OF JUSTICE, Statement of Issues No.  
9 1001598 is hereby withdrawn without prejudice.
