23 1. On or about February 23, 2017, Joanne Wenzel, Chief of the Bureau for Private
24 Postsecondary Education, Department of Consumer Affairs (hereinafter "Bureau"), solely in her
25 official capacity, filed Statement of Issues No. 1002170.

26 2. On or about November 29, 2012, the Bureau received an Application for Renewal of
27 Approval to Operate and Offer Educational Programs for Non-Accredited Institutions (the
28 "Application") from Respondent Hi-Desert Truck Driving School, Karanjodh S. Johal, Sukhjodh
S. Johal (hereinafter "Respondent"). After sending several notices of deficiencies and reviewing

1 additional documents submitted by Respondent, on or about October 4, 2016, the Bureau issued a
2 Notice of Denial of Approval to Operate an Institution Non-Accredited. On or about October 11,
3 2016, the Bureau received a Request for Administrative Hearing from Respondent.

4 3. The basis for withdrawing the pending Statement of Issues Number 1002170 is that
5 Respondent has produced to the Bureau documents and other information necessary to cure all
6 deficiencies and receive an Approval to Operate an Institution Non-Accredited.

7 4. WHEREFORE, IN THE INTEREST OF JUSTICE, Statement of Issues Number
8 1002170 is hereby withdrawn without prejudice.
