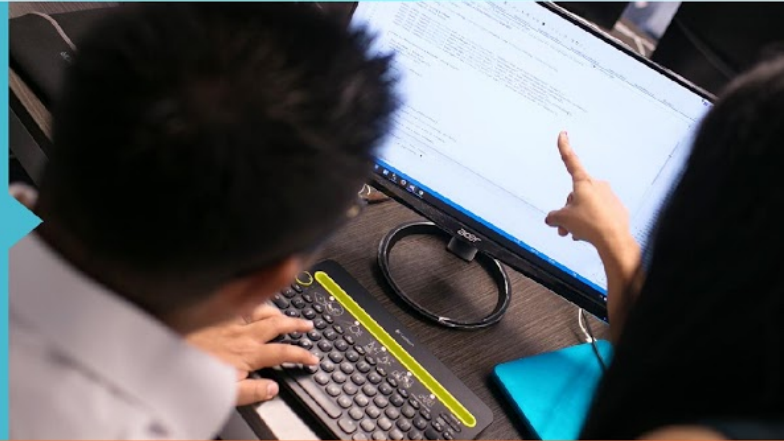

Los Angeles Campus

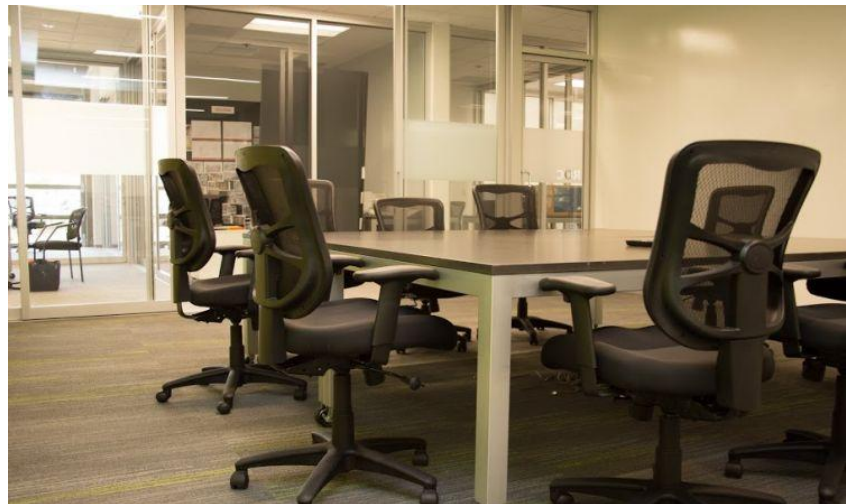

Orange County Campus

Sabio’s Orange county campus is located at the Premier Business Centers in Newport Beach. Also, Sabio’s PreWork sessions take place at the Vine in Irvine. Classroom numbers may vary per cohort, but all students are notified of classroom numbers prior to program start date.

- PreWork is held at 5151 California Ave, CONF 160, Irvine, CA 92617
- Sabio uses a classroom approximately 600 sq. ft. for program instruction and PreWork sessions.

Capacity

The PreWork Program will have a maximum of 25 students per session with one instructor. While the Full Stack Software Developer Training Program will have a maximum of 10 students per senior instructor. Sabio has multiple staff members that provide support to students in addition to their instructors.

Accreditation

Sabio is not an accredited institution and does not offer any degree or diploma programs that are accredited by an accrediting agency recognized by the United States Department of Education.

4. **Students are required to bring their own laptop to every class meet.** A Windows machine running windows 7, 8, or 10 is necessary to complete the course. Please make sure to bring your power cord with you!
5. **If you own a Mac**, the PreWork instructor must determine if it is compatible with installing windows. Instructions on how to download windows will be provided to students. You will be required to download different software throughout the course. A list will be provided upon admission to the program.

Admission Requirements

1. All applicants must have a high school diploma or equivalent & must be able to provide proof if requested by the institution.
2. Sabio does not accept students under the Ability-to-Benefit pathway.
3. There are no General Education prerequisites for enrollment into Sabio's PreWork program.
4. The prerequisite for Sabio's Full Stack Software Developer Training program are (1) successfully completing the PreWork program and/or (2) passing the technical assessment.



- Students must be able to speak, read, and write English proficiently to be successful in any of Sabio’s programs. If necessary, Sabio will request that the student provide proof of passing scores on the TOEFL exam.
- Students must own their own laptop. Refer to number four in Enrollment Process and Required Program Materials.

Programs Offered

The PreWork Program

To train anybody to become a successful developer, Sabio must help the student build a solid foundation. A student’s progress during PreWork is a good indication of a student’s readiness for the Full Stack Web Developer program. Sabio’s PreWork was created to familiarize and/or prepare students with basic concepts before starting the intensive 12-week program. PreWork Orientation is held the first 30 minutes of the first class meet. It is very important that students arrive on time to obtain access to the course materials. Sabio’s PreWork is critical in determining whether the student is eligible and ready for the 12-week intensive program because it prepares the student to successfully pass the technical assessment.

PreWork Class Times and Locations

It is very important that students stay up to date with Slack notifications for all course related communications.

Los Angeles PreWork sessions are held every Tuesday and Thursday from 7 p.m. to 10 p.m. and Saturday from 9 a.m. to 3 p.m. - Physical Address: 400 Corporate Pointe, Culver City, CA 90230. **Orange County PreWork** sessions are held every Tuesday and Thursday from 7 p.m. to 10 p.m. and Saturdays from 9:00 a.m. to 3:00 p.m. - Physical Address: 5151 California Ave, CONF 160, Irvine, CA 92617

Essential Information

If an administrator decides that a student is not prepared for the 12-week intensive program based on their performance or completion of the PreWork course material the student will be notified ahead of time. An administrator determining that a student is not prepared for the 12-week intensive program does not make the student ineligible for the program in the future; it only pushes the student’s start date. All students must pass the technical assessment at the end of the month for official admission into the Full Stack program. The technical assessment is strictly based on material covered during the PreWork program.

Upon being admitted into the program by successfully passing the technical assessment (stated in page 5 of this catalog) tuition for the Full Stack Software Developer Training Program becomes due. All students receive PreWork Orientation at no cost (PreWork Orientation takes place on the first day of PreWork).

Financing

Currently, Sabio is partnered with **SkillsFund** and **Climb** for students attending the Full Stack Software Developer Training program. Students may apply for a loan via any of the lenders mentioned, or may seek out other forms of loans or scholarships to cover the program's tuition and living expenses. Loans through SkillsFund and Pave are paid directly to Sabio. Any money loaned for living expenses will be dispersed to students in a minimum of two payments. **All students must have applied a week before the assessment date.** *Students are not guaranteed approval.* If a student obtains a loan to pay for an education program, the student will have to repay the full amount of the loan plus interest, less the amount of any refund. If the student receives federal student aid funds, the student is entitled to a refund of the monies not paid from the financial aid funds.



Student Tuition Recovery Fund

You must pay the state-imposed assessment for the Student Tuition Recovery Fund (STRF) if all the following applies to you:

- You are a student in an educational program, who is a California resident, or are enrolled in a residency program, and prepay all or part of your tuition either by cash, guaranteed student loans, or personal loans.
- Your total charges are not paid by any third-party payer such as an employer, government program or other payer unless you have a separate agreement to repay the third party. You are not eligible for protection from the STRF and you are not required to pay the STRF assessment, if either of the following applies:
- You are not a California resident, or are not enrolled in a residency program, or
- Your total charges are paid by a third party, such as an employer, government program or other payer, and you have no separate agreement to repay the third party.

The State of California created the Student Tuition Recovery Fund (STRF) to relieve or mitigate economic losses suffered by students in educational programs who are California residents, or are enrolled in a residency program attending certain schools regulated by the Bureau for Private Postsecondary and Vocational Education.

You may be eligible for STRF if you are a California resident or are enrolled in a residency program, prepaid tuition, paid the STRF assessment, and suffered an economic loss as a result of any of the following:

- The school closed before the course of instruction was completed.
- The school's failure to pay refunds or charges on behalf of a student to a third party for license fees or any other purpose, or to provide equipment or materials for which a charge was collected within 180 days before the closure of the school.
- The school's failure to pay or reimburse loan proceeds under a federally guaranteed student loan program as required by law or to pay or reimburse proceeds received by the school prior to closure in excess of tuition and other costs.
- There was a material failure to comply with the Act or this Division within 30 days before the school closed or, if the material failure began earlier than 30 days prior to closure, the period determined by the Bureau.

- An inability after diligent efforts to prosecute, prove, and collect on a judgment against the institution for a violation of the Act. However, no claim can be paid to any student without a social security number or a taxpayer identification number.

Student Right to Cancel / Refund Policy

You have the right to cancel your agreement for a program of instruction, without any penalty or obligations, through attendance at the first-class session or the seventh calendar day after enrollment, whichever is later. After the end of the cancellation period, you also have the right to stop school at any time; and you have the right to receive a pro rata refund if you have completed 60 percent or less of the scheduled hours in the current payment period in your program through the last day of attendance.

Veteran students receiving VA funding via the California State Approving Agency for Veteran Education (CSAAVE) will be eligible for a pro rata refund up to 100% of the program.

- Cancellation may occur when the student provides a written notice of cancellation at the following address: 400 Corporate Pointe, Culver City, CA 90230. This can be done by mail or by hand delivery.
- The written notice of cancellation, if sent by mail, is effective when deposited in the mail properly addressed with proper postage.
- The written notice of cancellation need not take any form and, however expressed, it is effective if it shows that the student no longer wishes to be bound by the Enrollment Agreement.
- If the Enrollment Agreement is cancelled the school will refund the student any money he/she paid, less a registration or administration fee not to exceed \$250.00, and less any deduction for equipment not returned in good condition, within 45 days after the notice of cancellation is received.

Withdrawal from the Program/ Refund Policy

For students enrolling directly into Sabio, you may withdraw from the school at any time after the cancellation period (described above) and receive a pro rata refund if you have completed 60 percent or less of the scheduled days in the current payment period in your program through the last day of attendance. The refund will be less a registration or administration fee not to exceed \$250.00, and less any deduction for equipment not returned in good condition, within 45 days of withdrawal. If the student has completed more than 60% of the period of attendance for which the student was charged, the tuition is considered earned and the student will receive no refund. **Veteran students receiving VA funds via CSAAVE will receive a pro rata refund up 100% of attendance during all programs.** For the purpose determining a refund under this section, a student shall be deemed to have withdrawn from a program of instruction when any of the following occurs:

- The student notifies the institution of the student's withdrawal or as of the date of the student's withdrawal, whichever is later.
- The institution terminates the student's enrollment for failure to maintain satisfactory progress; failure to abide by the rules and regulations of the institution; absences in excess of maximum set forth by the institution; and/or failure to meet financial obligations to the School.
- The student has failed to attend class for three consecutive days.
- The student fails to return from a leave of absence.

For the purpose of determining the amount of the refund, the date of the student's withdrawal shall be deemed the last date of recorded attendance. The amount owed equals the daily charge for the program (total institutional charge, minus non-refundable fees, divided by the number of days in the program), multiplied by the number of days scheduled to attend, prior to withdrawal. For the purpose of determining when the refund must be paid, the student shall be deemed to have withdrawn at the end of three consecutive days. If the student has completed more than 60% of the period of attendance for which the student was charged, the tuition is considered earned and the student will receive no refund.

If any portion of the tuition was paid from the proceeds of a loan or third party, the refund shall be sent to the lender, third party or, if appropriate, to the state or federal agency that guaranteed or reinsured the loan. Any amount of the refund in excess of the unpaid balance of the loan shall be first used to repay any student financial aid programs from

which the student received benefits, in proportion to the amount of the benefits received, and any remaining amount shall be paid to the student.

Consequences of Loan Default

If a student is eligible for a loan guaranteed by the federal or state government and the student defaults on the loan, both of the following may occur:

- The federal or state government or a loan guarantee agency may take action against the student, including applying any income tax refund to which the person is entitled to reduce the balance owed on the loan.
- The student may not be eligible for any other federal student financial aid at another institution or other government assistance until the loan is repaid.

Notice Concerning Transferability of Credits and Credentials Earned at The Institution

The transferability of credits you earn at Sabio is at the complete discretion of an institution to which you may seek to transfer. Acceptance of the certificate of completion that you earn in *FULL STACK WEB DEVELOPER TRAINING PROGRAM* is also at the complete discretion of the institution to which you may seek to transfer. If the certificate that you earn at this institution is not accepted at the institution to which you seek to transfer, you may be required to repeat some or all your coursework at that institution. For this reason, you should make certain that your attendance at this institution will meet your educational goals. This may include contacting an institution to which you may seek to transfer after attending Sabio to determine if your credits, or certificate will transfer.

Policies Regarding Articulation, Prior Learning Assistance and International Student Visas

- Sabio has not entered any articulation or transfer agreement with any other college or university.
- Sabio does not award credit for prior experiential learning.
- Currently, Sabio does not admit students from countries outside the U.S. because the institution cannot provide student visa services nor will the institution verify student immigration status.

Languages

Sabio only provides instruction and documentation in English, therefore all students are required to be fluent in English. If Sabio is concerned about a student's English proficiency, it will request that the student provide proof of passing scores on the TOEFL exam. Sabio does not provide English language services, such as ESL instruction.

Student Records

Sabio will maintain copies of student's financial ledger, an academic transcript, and completion certificates indefinitely. All other student records will be retained for five years.



Certificate of Completion

Students will receive a Certificate of Completion when they have completed all the program requirements. A graduate must have successfully completed all course objectives and have satisfied all financial obligations.

Leaves of Absence

Sabio does not offer a leave of absence due to the short length and importance of attendance in the program. If a student has to withdraw from the program for any reason, he or she may request admission to an upcoming cohort; determined at Sabio's discretion based on seat availability.

Attendance Policy

Sabio's *FULL-STACK SOFTWARE DEVELOPER TRAINING PROGRAM* is very intense and requires consistent attendance and dedication. Students who do not meet the attendance requirements of the program as defined in the Sabio Catalog will be dismissed. Student also understands that the expected out-of-class assignments commitment will be approximately 30 hours per week. In addition, there are four mandatory "meet-ups" during the program. Students will be notified of the dates of mandatory meetups at the time of enrollment. Due to the length of the programs Sabio will dismiss a student from a program after being absent for three (3) days and/or being late 4 days. Sabio makes it clear to all students the importance of being present. Students who are dismissed due to attendance policy violations are allowed to request readmission to an upcoming cohort.

- First absence: The student will be contacted by CEO and reminded of attendance policy.
- Second absence: The student is placed on attendance probation and will be given a warning of possible program dismissal.
- Third absence: The student will be dismissed from the program and required meet with the CEO and CAO to discuss the student's future at the institution or a prorated refund, if applicable, will be provided.
- Students who are late are responsible for making up the time and work they missed before the end of the day. All students can remain in the classroom until 10 p.m.

Program Commitment

Sabio's program requires students to be fully involved and committed to the intensive work required in order to be successful. Upon enrollment, students are made aware of all programs requirements. If a student cannot commit to the program's requirements, he or she will not be eligible for the program. Students are strongly advised to listen and take direction from instructors and advisors in order to achieve success in this program.

Student Conduct Policy

All Sabio students are expected to act professionally and collaboratively with their fellow students and Sabio staff at all times. Abusive or harassing behavior will not be tolerated and students who violate this policy will be disciplined, up to and including withdrawal from the program without the option to return.

Academic Grading Policy

Sabio does not assign traditional grades, but rather determines a student has met the course training objectives through review of his/her work product and series of interviews with the Chief Academic Officer. Students who are not exhibiting the requisite level of aptitude, or who are not attending and participating with their development team, may be given the opportunity to remain in the program until they have achieved the requisite level of expertise, and will be provided additional guidance as needed. However, Sabio retains the discretion to dismiss any student who fails to participate and contribute, and issue a refund subject to the school's refund policy.

Probation and Dismissal Policies

Students who violate the Student Conduct Policy, depending on the severity of the violation, may be placed on conduct probation for the remainder of the program. Students who violate that probation, fail to participate and contribute to their development team, or who fail to comply with Sabio's attendance policy, as outlined above, will be dismissed from the program.

Conditions for Reentrance

Sabio allows students that have withdrawn from the institution to attempt and re-admit by emailing the Chief Academic Officer, Gregorio Rojas (Gregorio@sabio.la) and taking a technical assessment. The student must also have left the institution in good standing, i.e. not have violated any policies and all fees due were paid.

Student Achievement Measures and Completion Requirements

To exhibit the proficiency required to earn a Completion Certificate, a student must exhibit the following to the satisfaction of the Chief Academic Officer:

- Students will be able to apply key principles of systems analysis and design to selected business processes within the organization in order to implement effective information systems. (BSA — Business Systems Analysis)
- Students will be able to design and develop key database structures meeting selected business requirements for effective storage and retrieval of information. (DBM — Database Management)
- Students will be able to explain implementation, integration and maintenance for IT applications to support selected business processes. (INT — Integration)
- Students will be able to explain information systems security that will comply with key requirements of accepted industry standards to support and improve the security of an organization's systems. (ISS — Information Systems Security)
- Students will be able to design and develop computer programs using standards promoted by the Association of Software Professionals (ASP) to promote the quality and effectiveness of programs. (PRG — Programming)
- Students will be able to design and develop a website using selected professional web design principles and standards to facilitate the professional appearance of an organization. (WEB — Web development)
- Students are required to pass a mock interview conducted by the CAO. Students are asked progressively more difficult interview questions in order to exhibit their in-depth knowledge of the subject matter.

Student Services

Job Placement Services Sabio provides students with resume review and consultation (Sabio will not draft initial resume for Fellow), an opportunity to participate in a minimum of two mock interviews conducted by Sabio staff, promotion of the student on Sabio's online channels, at the Fellow's discretion, and access to Sabio's extended mentorship training, placement services and professional network for a period of five years after completion of the Program. **WHILE SABIO WILL PROVIDE PLACEMENT SERVICES TO FELLOWS BOTH DURING AND AFTER COMPLETION OF THE PROGRAM, SABIO CANNOT GUARANTEE THE EMPLOYMENT OF ANY FELLOW.** After completing the program Sabio provides a classroom for alumni to come in and continue to work as they seek work. The room is available Monday through Friday, 8 a.m. to 8 p.m.

Housing

Sabio does not offer on-campus housing or dormitories nor does it provide housing services for students.

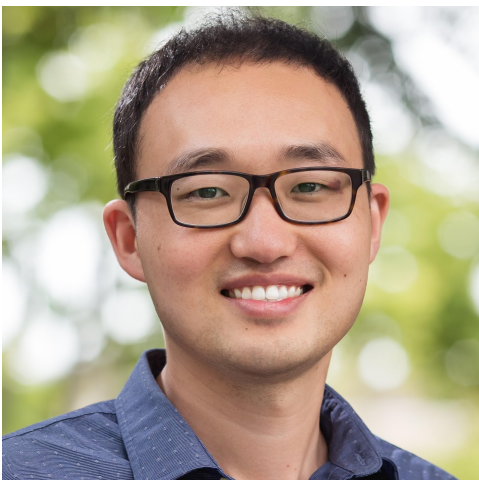


Victor Campos, VP of Engineering

- “If the function were written like...”
- “Wouldn’t the code error if...”
- “Would it be better if...”
- “The code will perform better....”
- “The code will error less ...”

Code can always be improved and as developers just starting out you should be aware that your code will present with ample opportunity to improve. More on code review:
