# "NOTICE CONCERNING TRANSFERABILITY OF CREDITS AND CREDENTIALS EARNED AT OUR INSTITUTION"

The transferability of credits you earn at Aero Tech Academy, Inc. is at the the complete discretion of an institution to which you may seek to transfer. Acceptance of the certificate you earn in Commercial Pilot Course, Flight Instructor Refresher Course, Pilot Ground School Course is also at the complete discretion of the institution to which you may seek to transfer, if the certificate that you earn at this institution are not excepted at the institution to which you seek to transfer, you may be required to repeat some or all of your course work at that institution. For this reason you should make certain that your attendance at this institution will meet your educational goals. This may include contacting an institution to which you may seek to transfer after attending Aero Tech Academy, Inc. to determine if your certificate will transfer."

# ATTENDANCE POLICY

Students are required to complete a minimum of 15 hours of instruction per quarter following the date of enrollment. Exceptions may be granted due to weather, illness or other unavoidable circumstances and must be documented in student file.

### PROGRESS POLICY

Flight training: A student who fails a Stage Check will be placed on probation. If the student fails the next Stage Check the students training will be terminated. The student may be reenrolled only after evidence is shown that the conditions which caused the unsatisfactory progress have been rectified and the facility determines there is a reasonable likelihood that the student will progress satisfactorily.

## CONDUCT POLICY

The student will at all times comply with Federal Aviation Regulations and applicable aircraft course rules. A course rule briefing will be provided to the student by competent authority prior to actual flight training and as needed thereafter. Violation of FAA rules and regulations is cause for dismissal. The student shall at all times when in classroom or on the airfield, conduct themselves in a responsible and or, and shall appear for training in a sober and receptive condition. Violation of these conditions is a cause for dismissal.

### PROBATION

The student will only be put on probation one time for three days for the following: tardiness for class, disruptive in class and uncompleted home work. If conduct continues student will be terminated.

### Dismissal

After one time of probation of three days for the following: tardiness for class, disruptive in class and uncompleted home work, the student will be dismissed.

CANCELLATION, WITHDRAWAL, AND REFUND POLICIES r. The student has the right to cancel and obtain a refund of charges paid through altendance at first class session, or the seventh day after enrollment, whichever is later. If student received federal student financial aid funds, the student is entitled to a refund of monies not paid from federal student financial aid program funds. The student needs to put in writing that he /she wishes to cancel his enrollment with Aero Tech Academy, Inc. sign and date it and give to his/her flight instructor and obtain a refund. Leave of absence: Our students may not take a leave of absence, due to the proficiency they have to maintain to fly the airplane, and skill they have to maintain to do the maneuvers to pass the FAA flight check for the Commercial Pilot Airplane course. 

# STUDENT TUITION RECOVERY FUND

The State of California established the Student Tuition Recovery Fund (STRF) to relieve or mitigate economic loss suffered by a student in an educational program at a qualifying institution, who is or was a California resident while enrolled, or was enrolled in a residency program, if the student enrolled in the institution, prepaid tuition, and suffered an economic loss. Unless relieved of the obligation to do so, you must pay the state-imposed assessment for the STRF, or it must be paid on your behalf, if you are a student in an educational program, who is a California resident, or are enrolled in a residency program, and prepay all or part of your tuition.

You are not eligible for protection from the STRF and you are not required to pay the STRF assessment, if you are not a California resident, or are not enrolled in a residency program."

(b) In addition to the statement required under subdivision (a) of this section, a qualifying institution shall include the following statement in its school catalog: "It is important that you keep copies of your enrollment agreement, financial aid documents, receipts, or any other information that documents the amount paid to the school. Questions regarding the STRF

may be directed to the Bureau for Private Postsecondary Education, 2535 Capitol Oaks Drive, Suite 400, Sacramento, CA 95833, (916) 431-6959 or (888) 370-7589.

To be eligible for STRF, you must be a California resident or are enrolled in a residency program, prepaid tuition, paid or deemed to have paid the STRF assessment, and suffered an economic loss as a result of any of the following:

- 1. The institution, a location of the institution, or an educational program offered by the institution was closed or discontinued, and you did not choose to participate in a teach-out plan approved by the Bureau or did not complete a chosen teach-out plan approved by the Bureau.
- 2. You were enrolled at an institution or a location of the institution within the 120 day period before the closure of the institution or location of the institution, or were enrolled in an educational program within the 120 day period before the program was discontinued.
- 3. You were enrolled at an institution or a location of the institution more than 120 days before the closure of the institution or location of the institution, in an

educational program offered by the institution as to which the Bureau determined there was a significant decline in the quality or value of the program more than 120 days before closure.

- 4. The institution has been ordered to pay a refund by the Bureau but has failed to do so.
- 5. The institution has failed to pay or reimburse loan proceeds under a federal student loan program as required by law, or has failed to pay or reimburse proceeds received by the institution in excess of tuition and other costs.
- 6. You have been awarded restitution, a refund, or other monetary award by an arbitrator or court, based on a violation of this chapter by an institution or representative of an institution, but have been unable to collect the award from the institution.
- 7. You sought legal counsel that resulted in the cancellation of one or more of your student loans and have an invoice for services rendered and evidence of the cancellation of the student loan or loans.

To qualify for STRF reimbursement, the application must be received within four (4) years from the date of the action or event that made the student eligible for recovery from STRF.

A student whose loan is revived by a loan holder or debt collector after a period of noncollection may, at any time, file a written application for recovery from STRF for the debt that would have otherwise been eligible for recovery. If it has been more than four (4) years since the action or event that made the student eligible, the student must have filed a written application for recovery within the original four

(4) year period, unless the period has been extended by another act of law.

However, no claim can be paid to any student without a social security number or a taxpayer identification number."
